

# Mar 30: CORONAVIRUS CASES UP TO 12



The Cayman Islands has recorded an additional four confirmed cases of COV-ID-19 taking the total to 12, with one additional sample still inconclusive.

The update was given by Chief Medical Officer Dr John Lee during Sunday's daily Government press briefing.

He said of 12 confirmed cases, notably they were between the ages of 21 and 83, pointing to the growing pattern that the virus was not limited to the persons in the upper age brackets. Five of the confirmed samples are males and the other seven females. Four of them have had long term health conditions.

All but one of the cases was traced to persons classified as travellers.

To date, 194 cases have been confirmed negative out of 207 tests carried out.

Several persons remain under medical observation after showing or reporting flu-like symptoms consistent with COVID-19, in addition to those who have self-isolated having returned to the territory recently or in keeping with other preventive protocols.

Hon. Premier Alden McLaughlin emphasised that with these results, maintaining social distance had become even more important in suppressing the chances of the virus spreading in the community.

## **PREMIER PREACHES** FRUGALITY

"Alden can live off a couple of cans of corned beef and white rice for weeks!"

With that timely and unscripted response to a question posed by Caymanian Times Publisher and Editor-In-Chief Ralph Lewis, Premier Alden McClaughlin has reset the narrative of the challenge the territory faces as it strives to cope locally with the COVID-19 global crisis.

Frugality is the mantra.

This advice, both timely and necessary, should be taken on board seriously.

It's borne not just an innate survival instinct that has served these islands well as hurricane

experiences can attest, but an inner fortitude that has underpinned a drive to rebuild - sometimes bigger - but always better.

"You know, we don't need to have ribs and steak and chicken every single day. Let's just calm down, think of this as a long hurricane that we are trying to get through," he counselled having lived the hurricane experience himself as others have done.

Mr McClaughlin was at the time addressing the matter of not just the economic pressure on the territory by the COVID-19 crisis, but the financial impact on individuals and families.

It was prompted by a question asking if residents abided by the current restrictions to suppress the spread of the coronavirus in Cayman, would the government consider lifting the restrictions after seven days, given the financial pressure some people are already facing?

The Premier has expressed concern, that after initially complying with the regulations there were indications, much to his displeasure, that some people were abusing them.

He acknowledged being mindful of the financial hardships being faced by some persons, but said that at this stage it would be inadvisable to exit early from the Stay Home Cayman and Shelter-In-Place procedures.

"Not enough time would have expired based on the advice we have in terms of public health for us to be certain that the virus is still not lingering in the community."

On the direct issue of financial hardhip, Mr McLaughlin demonstrated that

"In addition to what has been happening globally, we know we have crashed the economy," he admitted.

The Cayman Islands has been running a healthy surplus due to what the government has credited as its strict financial discipline.

Mr McLaughlin has estimated that this could tide the territory over for at least the next three to four months.

What comes after is the challenge for both government and households.

If the crisis persists, especially due to people not complying with the restrictions in place, the knock-on economic effects could be even more severe, he has warned.

However, the Premier has this solemn advice for his fellow citizens.

"Just let me say this," he intones with a sense of disquieting urgency.

"We can rebuild the economy, but the only person reputed to have been able to be raised (from) the dead was Jesus Christ himself. We cannot bring back lives."

Advising people to be frugal with their spending in this period of crisis facing the country, Premier McLaughlin observed:

"When I see the amount of panic buying that is going on, I ask myself; if people spend up all of their money what about the week after, and the week after?"

"Even when the curfew is lifted, the economy is not going to bounce back miraculously," he cautioned.

"Look at what's happening all around us. People need to hoard what money they have. Eat frugally. Sparingly."

And that brings us back to two of the Premier most memorable and sage quotes on this issue "Alden can live off a couple of cans of corned beef and white rice for weeks!" "You know, we don't need to have ribs and steak and chicken every single day. Let's just calm down, think of this as a long hurricane that we are trying to get through."

# **CAYMAN COVID-19 CASES UP TO 12**

The measures to mitigate the spread of the virus in the community remain in force with the possibility of being intensified again, if the regulations are not followed. His Excellency, the Governor, Martyn Roper announced that more UK-funded testing kits are expected to arrive in Cayman this week as part of supplies for the Overseas Territories from Public Health England.



The Hon. Minister of Health Dwayne Seymour in detailing the COVID-19 Action Plan of the Health Services Authority, disclosed that huge orders of COV-19-related medical supplies to supplement existing stock have arranged by the HSA and shipment is awaited.

#### **SUPERMARKETS**

Given the experience of Saturday where huge crowds descended on the supermarkets, a new system will come into effect from Monday.

This system based on family surname will be assigned in alphabetical order.

It's intended to reduce the element of large numbers of people assembling at the entrance to supermarkets and exposing each other to the risk of COV-ID-19 contamination.

Premier McLaughlin explained that persons whose surnames begin with the letters A to K will be allowed into the supermarkets on Mondays Wednesdays and Fridays. Those with surnames L to Z have been assigned Tuesdays, Thursdays and Saturdays.

Only one person per household will be allowed into the supermarkets on their allocated days.

The Hon. Minister for Health Dwayne Seymour has suggested that this method could also be adopted by the banks.

Mr McLaughlin has advised the public not to treat the new week as a normal work week and to follow the restrictions which have been put in place.

He urges that people follow the Shelter-In-Place and Stay Home Cayman schemes.

Police Commissioner Derek Byrne reported that police monitoring of the overnight 7pm to 5am hard curfew and the daytime 5am to 7pm soft curfew will continue.

He said land, sea and air patrols are in full operation, and warned persons who have been caught out on the roads without any legitimate reason, or at the beaches, to desist from such practices and strictly observe the regulations.

There have been several instances of traffic stops, warnings and arrests of violators.

The Registrar of Lands will accept instruments that are signed and witnessed simultaneously in counterpart, where the transferor's signature is on a different page from that of the officer. This allows a transferor to sign an execution copy of a document in the presence of, but at a safe distance from, the officer who would apply his/her signature and officer details on an identical execution copy.

The Registrar of Lands will also allow officers, who are so prescribed under the law, to verify a client's identification using video conference technology as long as officers can demonstrate that they:

• Are reasonably satisfied that the Government-issued identification is valid and current;

• Can compare the image in the Government-issued identification with the client to be reasonably satisfied that it is the same person;

• Record (with the applicable date) the method used to verify the client's identification; and

• Otherwise, comply with their obligations under applicable laws relating to client identification.

The LSD will allow an additional 45 days within hich to submit documents executed during this period for the payment of stamp duty and registration fees, with no penalties and interest for a total of 90 days for documents executed between the 1 February 2020 and 15 April 2020. The LSD also advises that Lodgments for attorneys in private practice, Category A licensed financial institutions and the Credit Union can be scanned and submitted by email to landreglodgement@gov.ky. Submit all lodgments along with the attached Statutory Declaration, confirming that they have the original documentation. The Declaration form can also be found online at www.caymanlandinfo.ky. All other customers may drop off their documents utilising the drop-in-box, located near LSD public counters. Alternately, customers may submit less urgent documents such as Change of Name or Change of Address, Deletion of Death of Joint Proprietor & Discharge of Charges by mail to: Lands & Survey Department, 133 Elgin Avenue, Government Administration Building, Box 120, Grand Cayman KY1-9000, Cayman Islands

# PREMIER REPRIMANDS LOCKDOWN VIOLATORS

In his toughest reprimand yet, Hon. Premier Alden McLaughlin has severely chastised persons who persist in flaunting the conditions set down in the curfew that Cayman is currently under.

The territory has been placed in alternating hard nighttime curfew and soft daytime restrictions as part of intensified global efforts to halt the spread of the highly infectious and deadly coronavirus COVID-19.

A Shelter-in-Place/Stay Home Cayman drive is now in place.

Speaking at the end of the first three-day 24/7 lockdown, Premier McLaughlin praised those who have been cooperating but did not mince words for the violators.

The government had enforced a full lockdown after a number of violations of the overnight curfew, safe-distancing and a flood of requests by businesses seeking to be classified as essential services - in many cases for all of their employees and not just key staff.

"It is clear to us that we are going to have to have very different kinds of behaviours than we are used to, for quite some time than we are used to until this crisis ends," Premier McLaughlin said.

And he issued this warning: "If we don't get the cooperation of the public, unfortunately, as happens far too often, the innocent will have to suffer with the guilty."

Crowds at the beaches, people driving around aimlessly, out and about without adequate reason, and not keeping the safe distance advice have been some of the challenges faced by police, despite the public in most cases adhering to the protocols. In his overview of the current situation, he noted that in order for soft (daytime 5am to 7pm) curfew to work, the Premier said "all must practice common sense."

Contrasting developments on Saturday with the previous days where he said he was happy with the response of the public, Mr McLaughlin expressed concern about the long queues at supermarkets where social-distancing was not being observed.

He said that system might need to be reviewed.

There are also concerns about some people flocking to the beaches.

"Moving about freely is a significant abuse of the privilege to move around granted by the soft curfew provisions. Hundreds sunbathing is not the plan and is not going to work."

Mr McClaughlin went to state that, "People need to understand that this irresponsible behaviour, this selfish behaviour quite frankly, means that you for the government to become more and more restrictive to get it to a position where we can actually enforce the rules.

"I appeal again for people to be reasonable, exercise common sense, and to follow the rules, otherwise you make life harder for all of the people around you," he advised.

On the likelihood that the curfew could be further tightened of compliance is not improved, he said: "Let's work through the next week and see where we get to."

Of eight confirmed COVID-19 cases - with a possible ninth being reviewed - there's been only been one death; a cruiseship passenger taken to Health City Cayman with a cardiac complaint who was subsequently

found to have had the virus before he was disembarked here.

Another patient who went from Cayman to Honduras where he passed away, died of causes not linked to COVID-19.

"I don't want one single one of my people, and I'm including those who reside here who are not Cayman nationals, to die of this disease in Cayman. That's what we are aiming for," Premier McMcLauglin said in appealing to the public to abide by the new 'Stay Home Cayman' initiative.

"Come on folks, let's do this together," he urged. 🔇

# DES Announces Changes to External Exams Due to COVID-19

The Department of Education Services (DES) has announced a number of changes made to external examinations scheduled for this year for secondary-level students. While the City and Guilds examinations currently remain on schedule, examinations previously scheduled by Cambridge, AQA, WJEC and Pearson are all cancelled as indicated by their respective boards. Examination centres are awaiting the process for awarding grades for the above mentioned exams. Further to a regional press release issued by the Caribbean Examination Council (CXC) on 26 March, a number of changes have also been announced in relation to the May/June 2020 examinations schedule for CXC.

The following key points should be noted with regard to the examinations process: • Online resources geared towards exam preparation are available at learninghub. cxc.org; in addition, DES and the Minstry of Education are working with FLOW and One on One Educational Services Ltd in Jamaica, to provide access to additional content

In addition to the new measures for CXC exams, secondary school graduation dates will be rescheduled to ensure final exam grade reports are taken into consideration and recognized.

"Without question it is extremely unfortunate that several of our locally administered, external exams have been cancelled. From the onset of the drastic upset to all our lives, we have been actively engaged in fact-finding activities and discussions with the various examination bodies. This includes meetings facilitated by CXC which included other Ministries of Education across the region, to deliberate the best scenario for our students as it relates to the administration of examinations. While the changes CXC has implemented are different and may cause inconvenience, the takeaway is that examinations are still going ahead. In moving forward, DES staff, principals and teachers will continue their hard work to collaboratively adapt and make



and especially, Year 11 students. None the less we will find ways to support them and maintain our positivity. The extended date for SBAs means that this must still be a priority and they must not stop working. The Paper 1 multiple choice paper being completed electronically can be managed. We have already trialed this and have completed exam work for CXC over the past two years," assured Jon Clark, Principal of John Gray High.

"Understandably our students may be anxious about external examinations and the changes proposed, we encourage you to remain focused and positive, you have been taught to be resilient and to demonstrate a growth mindset, this is the time to tap into your inner resolve and press on. Your parents and teachers are with you, guiding you

"We are cognizant of the anxieties surrounding the way forward. Students be reassured in knowing that teachers, parents and the entire education fraternity are working to ensure continuity of your education journey. The provisions are in place to assist all our students with preparations for the scheduled external examinations. In this time utilize what works best for you, stay on top by being organized and most importantly, take the very best care of your mental health and well-being in these challenging times," added Devon Bowen, Acting Principal for Layman E. Scott High.

Delores Thompson, Director of Cayman Islands Further Education Centre (CIFEC) also shared some encouraging words, "At the beginning of the school year we shared with you that the biggest determinant of a person's success isn't IQ, family structure, income or participation in extra curricula activities. It is GRIT! Now is the time to demonstrate that GRIT. Team CIFEC, we've got this! Stay engaged with your teachers, keep working and reach out to us if you need anything. We are praying for you, we love you and together, with GRIT, we are going to get through this!"

27th March, the Cayman Islands Premier, the Honorable Alden McLaughlin pointed out that due to the current guidelines regarding gatherings being kept to a minimum of two persons, this would not be possible.

He instead, encouraged churches to pursue fellowship using online mediums:

"Many of churches have been gathering online. It just means that they can't gather together in a physical building or room for the physical purpose of worship," noted the Premier.

Mr. McLaughlin also ruled out a National Day of Prayer in the usuals sense due to the restrictions on gatherings. However, he added that such prayer services could be held over the radio, on television or otherwise.

In response to a question by Caymanian Times' Publisher and Editor. Mr. Ralph Lewis, Health Minister, the Honorable Dwayne Seymour indicated that he would be happy to invite a pastor to the press briefings if the Premier would allow him to do so.

"So far I have been doing the prayers and I haven't run out of prayers but I think we could take someone well trained to come up and give the nation some calm".

Online there has been an outpouring of faith based initiatives and the Caymanian Times managed to catch up with Pastor Felix Manzanares of Journey Ministries Cayman, who has been using

platforms such as zoom (a remote conferencing services company, which combines video conferencing, online meetings, chat, and mobile collaboration), as well as Facebook to reach persons in the community.

Mr. Manzanares explained that the the Church has a unique ability to thrive in challenging times.

"I love what I see happening in the body of Christ because traditionally there has been a focus on the buildings but now we are building the Church instead. We are really understanding what means to love our neighbor and things like spending time with family have become a priority," he noted.

The Minister added that the Church has to be a part of the solution at this time.

"It is important for us to not just show what we are against as people of God but also what we are for and it that spirit it is important to honor and partner with the government in prayer and in practice.

"This crisis has challenged the ministry and leaders everywhere to be innovative and tap into technology. It is a bright time for the Church to be inclusive and build that love and connection with people and really be shepherds."

Journey Ministries has been building an online presence for four years and had already been having online worship during that time. The Church is currently hosting 12 nights of prayer online from 8.30pm to 9.30pm, using Zoom



from their Facebook page "I Am Online Gathering".

"We've always used this forum. In fact, a recent conference that was scheduled and had to be cancelled was held online. We managed to still have the workshop, people paid and the speaker was able to bless the congregation," noted Pastor Manzanares

Another Pastor who is using the wonder of modern technology is Pastor Alston Ebanks of the Church of God, who has been delivering messages via Facebook Live, in addition to producing audio-visual faith based content to uplift the community.

His most recent piece has had a huge impact, reaching many people, who have been sharing it on WhatsApp and Facebook for inspiration.

The Cayman Islands have always had a strong Christian tradition and this time of crisis has been bringing out a renewed ardency among believers.

Residents are encouraged to pay attention to the government's press briefings for information regarding opening times for churches going forward. 😚

### Supermarkets welcomed Shoppers on Saturday

After the "around-the-clock" curfew of the past three days, supermarkets and a limited number of establishments (including pharmacies and gas stations) re-opened today, Saturday 28 March. This in line with the Attorney General's regulations outlined at Friday's press conference (see below for details).

Shoppers were seen getting in line as early as 6.30 am as they waited for their turn to enter the supermarket. According to a security officer on the scene, customers arrived as early as 5.30 am to start their grocery shopping, RCIPS will be working alongside supermarkets and their private security companies to ensure the safe flow of traffic, a smooth flow for customers, as well as the prioritisation and protection of vulnerable individuals. In support of Saturday's efforts, RCIPS Commissioner Derek Byrne issued a statement to news media, accompanied by a video for social media and a message on Radio Cayman.

Commissioner Byrne stated:

"The RCIPS is working in partnership with the supermarkets and retailers to deploy extra uniform patrols at various supermarket locations around the island on Saturday March 28th to create a more positive and safe environment for persons to move around and conduct their business all in compliance with the new Public Health Regulations passed on Friday March 27th.

"Please be assured that the major retailers are well stocked to meet the demands of the community. We remind all members of the community that we are operating in a soft curfew period between 5:01 a.m. and 7:00 p.m. each day for the next 10 days starting Saturday March 28th. Hard curfew from 7:00 p.m. each night continues as previously advised.

"The RCIPS is out to assist and provide public reassurance during this extremely challenging period. We thank





the community for their cooperation and continued support as we work through this difficult period to contain COVID19."

Mr. Byrne references new regulations that were passed on Friday, 27 March the Public Health (Prevention, Control and Suppression of COVID-19) Regulations, 2020 which are available online at http://www.gov.ky/coronavirus. The aim of these measures is to ensure that community spread of COVID-19 within the Cayman Islands is thwarted for the longest possible time. (Community spread means patients have no travel history and no contact with persons that do.)

For information on various retail establishments, including banks and pharmacies, the Cayman Islands Chamber of Commerce has launched a new website - http://chambercovidupdates.ky Going forward, this website will be updated daily in line with the private sector response to government's announcements and changes in policy.

Supermarket hours in the curfew period are as follows:

• Cost-u-Less 8AM-6PM, Monday through Saturday. Dedicated shopping hour for vulnerable: 7AM to 8AM

• Fosters 6AM-6PM, Monday through Saturday. Dedicated shopping hour for vulnerable: 6AM-7AM

• Hurleys 9AM - 6PM for the general public. Dedicated shopping for elderly/ vulnerable, HSA staff and first responders: 7AM- 9AM

• Kirk Market 6AM-6PM, Monday-Saturday, for the duration of the curfew. Dedicated shopping lanes for elderly/ vulnerable individuals

Even though the parking lots were filled and the lines were increasingly long, the customers were well behaved and waited patiently at the time of reporting.

### **UCCI transitions to online teaching and learning**

Monday, March 30 will mark two weeks since the University College of the Cayman Islands (UCCI) transitioned to online teaching and learning as part of the university's contingency plan to minimise the risk of transmitting COVID-19, the novel coronavirus, to its

UCCI's campuses are closed but its faculty and administrative staff are fully operational, remotely, from their homes. Classes and teaching continue online following the current semester calendar. Regular business hours are being maintained remotely for both the Grand Cayman and Cayman Brac campuses during the school closure period, which is scheduled to end on Monday, April 27 with clearance from the Cayman Islands Government.

Faculty members have contacted UCCI's student body to discuss the teaching and learning options for each course, allowing students to successfully complete the semester. Several different online platforms are allowing instructors to engage with students in an interactive digital forum such as Microsoft Teams and Skype for Business complemented with the use of the learning management system, Blackboard. # **Attorney General Shares COVID 19 Regulations**

At a press conference today Friday, 27 March 2020, Attorney General, Hon. Samuel Bulgin outlined the Shelter in Place procedures that will govern new, softer curfew provisions announced by Premier, Hon. Alden McLaughlin.

The new provisions are titled The Public Health (Prevention, Control and Suppression of COVID-19) Regulations, 2020.

The Attorney General noted that:

• Gatherings, parties and events such as conferences and concerts involving more than two persons are not allowed.

• From 5.00 am Saturday, 28 March 2020 for a period of 10 Days, the shelter in place order is in effect and applies to all three Cayman Islands; this might be extended if deemed necessary.

• Although movement will be allowed for essential purposes, shelter at home still requires everyone to remain at home, or in their yard space.

• Breaches, upon conviction, will attract a \$1,000 fine and imprisonment of six months.

• However, Government recognises that individuals need access to essential services, and that essential operations across the Islands must continue to function. Therefore the new regulations allows for necessary exemptions to the Shelter in Place requirement.

The Attorney General explained that the exemptions are broken down into categories A, B and C.

• **Category A** outlines "essential service providers or persons who are designated to carry out certain activities or duties only when acting in the course of their duties." These include police officers and other law enforcement personnel, sanitation workers, utility, banks, supermarkets, health care workers, media personnel, water and cooking gas delivery personnel, taxi drivers, security services personnel and food deliverers who specifically have a time limit of up to 9 pm. Also persons picking up takeaway food may do so until 6 pm.

• **Category B** covers exemptions for individuals exercising or walking their dogs for a maximum of 1.5 hours, provided they can maintain a distance of six feet from another person. Public or private strata pools or gyms cannot be used. • **Category C** provides for restrictions on other activities and operations such as holding strata pool parties or sailing on pleasure boats.

Also exempt are electricians, plumbers or roof repairers who have to perform urgent repairs at clients' places of residence.

Wedding ceremonies should have 10 persons other than the bride, bridegroom, official witnesses and the marriage officer. Funerals should have no more than 10 members of the immediate family, six pallbearers, at least one officiant and essential mortuary staff.

The Attorney General emphasised that even essential staff are allowed to be out and about only to perform their duties; they cannot generally be out and about for their private reasons.

All other services will remain closed during the initial phase, including Outpatient Services and all elective procedures.

Clinical Director Dr. Binoy Chattuparambil said, "As the Cayman Islands' sole tertiary care facility, it is imperative that we open as soon as possible in order to support the emergency health care needs of the local population. However, we would not reopen unless we were fully confident that potential transmission of the COVID-19 virus has been suppressed. We are reassured by the most recent test results announced by Chief Medical Officer Dr. John Lee on Friday, March 27. We stand ready to assist in the treatment of emergency and critical cases as needed. We will announce subsequent phases of our reopening in due course. We stand committed to acting in the best interests of the health of the Cayman Islands community."

To facilitate the reopening of emergency services and critical care, one wing of the hospital has been physically segregated and assigned exclusively only for the isolation of suspected or COVID-19 positive patients.

Another wing of the hospital will be used only for newly admitted emergency patients. The newly admitted emergency patients will not have any contact with the existing patients of the hospital or the staff taking care of them.

The staff taking care of the new emergency admissions are also physically segregated from those staff members taking care of the existing patients.

Commenting on the need for these measures. Dr. Chattuparambil said. "We now, and for the immediate future, live in a COVID-19 world and we must prepare just as we would if we knew a patient was potentially COVIID-19 positive."

# HSA expands flu clinic to new location

With increasing incidences of flu being reported in the Cayman Islands the Health Services Authority has expanded its flu clinic on the main Hospital campus with a dedicated unit to treat patients with flu moderate to severe symptoms and help mitigate the spread of the virus in other clinic settings.

Medical Officer of Health, Dr Williams recommended that persons first make contact via the 24 hour Flu Hotline at 1-800-534-8600 or 947-3077 or email flu@ hsa.ky as initial triage before coming into the Flu Clinic.

Medical Officer of Health, Dr. Samuel Williams says the high number of influenza like cases emerging in recent weeks has resulted in an increase of patients entering the emergency room and general practice clinic. "We saw approximately 300 cases of respiratory tract infections reported within the last two weeks in February so the need is still there."

The dedicated Flu Clinic is located in the space previously occupied by the Outpatient Mental Health Unit, on the side of the hospital facing the Seventh Day Adventist Church, to the far left of A&E. Signage on the hospital campus will direct patients to the Clinic, which will be open Monday to Friday from 8:00 a.m. to 4:00 p.m. All persons at the flu clinic will be required to wear a facemask to prevent the spread of flu.

If you have flu symptoms and have traveled within the last 2 weeks please stay at home and contact your



healthcare provider or the Flu Hotline. Callers will speak with a health professional about their symptoms, be screened for travel history, etc and will be advised on what they should do e.g. come to the Flu Clinic, stay home in isolation.

Dr. Williams says that most people with the flu have mild to moderate symptoms and will recover within about a week without medical treatment. Persons are reminded to rest, take over-the-counter medications and drink plenty of fluids to stay hydrated. Pregnant women and those with underlying health conditions should call the hotline or their primary care doctor at the first sign of flu symptoms.

Flu symptoms may include:

- Fever
- Sore throat
- Cough
- Runny nose
- Muscle or body aches
- Chills

If you experience worsening symptoms such as:

- Sudden dizziness and confusion;
- Severe or persistent vomiting;
- Pain or pressure in the chest or abdomen; or,
- Difficulty breathing
- call the Flu hotline or 911.

To help avoid the spread of germs and reduce the risk of contracting viruses, it is essential to practice the following:

• Wash your hands with soap and water (hand sanitizer if a sink with soap and water is not available).

• Don't touch your face unless you have washed your hands, as that is how the virus gets into your body.

 Cough and sneeze into a tissue and then throw it away, or cough and sneeze into your bent elbow.

• Stay 3 -6 feet away from sick persons with respiratory symptoms.

Patients visiting the flu clinic can use the Seventh Day Adventist Church parking lot, just opposite A&E. 😚

Where the person does not satisfy the

certain activities or duties, only when acting in the course of their duties.

These are as follows:

• police officers, customs and border control officers, officers of the Fire Brigade and prison officers;

• persons involved in essential services delivery, in the form of child protection and residential care, in the Department of Children and Family Services;

waste and sanitation workers;

 staff within a health care facility, or persons delivering emergency medical services:

• essential officers of any water, electricity or other sector encompassing the provision of electronic communications including print and electronic media; persons employed to physically deliver water to premises;

· a person who provides care to a vulnerable person or a person with a disability;

· persons who operate taxis for hire, PROVIDED that there are no more than 2 passengers in the taxi at any one time so that each passenger is able to distance himself or herself as far as possible from the other passenger and the driver;

 persons involved in agriculture and food production;

• persons engaged in the delivery of propane or cooking gas;

• persons engaged in the provision of emergency veterinary services;

• persons engaged in the exercise of Cabinet, parliamentary or judicial duties

• services connected with the loading and unloading of cargo ships, and with the storage and delivery of goods;

· persons employed by a business licensed to provide security guard services:

• persons employed by restaurants to provide food delivery services, until no later than 9:00 pm;

• persons employed by businesses other than restaurants to provide food or grocery delivery services, until no later than 9:00 pm;

• persons who travel to restaurants which provide take-away or curbside take-away food service, for the purpos6:00 pm;

• civil servants as designated by the Portfolio of the Civil Service;

• charities and other persons engaged in the delivery of food or groceries, as designated by the Competent Authority;

· persons who have to undertake essential travel to any of the following 5 types of facilities:

i) health-care facilities for emergency purposes;

ii) supermarkets, convenience stores, mini-marts and pharmacies between the hours of 6 a.m. - 6 p.m. Convenience stores and mini-marts will also be subject to the further restriction of no more than six customers inside at any given time:

iii) retail banks, credit unions and building societies between the hours of 9 a.m. to 1 p.m.;

iv) gas or refilling stations between the hours of 6 a.m. to 6 p.m.; or

v) such other public places as may be specified by the Competent Authority (that is, the Ministry of International Trade). Businesses wishing to apply for an exemption under one of the appropriate categories should email curfewtime@gov.ky.

Also exempt are:

• members of an essential service or an essential services provider designated by the Ministry of International Trade after consultation with the Hazard Management Department of the Cayman Islands, for the purposes of performing their employment duties; and

• other persons involved in other businesses that are designated.

#### **Category B – Exercise or pet** walking

Persons may also leave their places of abode or residence for no more than 1 <sup>1</sup>/<sub>2</sub> hours per day to engage in exercise in a public place or to walk their pet, PRO-VIDED that they maintain a distance of at least 6 feet or 2 meters from another person.

The public is reminded, however, that even though exercise and pet-walking are allowed, persons are still not allowed to go to public gyms or pools, or private strata gyms or pools.

### other activities and operations

Activities such as:

i) having private parties, which include persons from outside the immediate household of the house occupant (and this includes parties held in or around a private strata pool; and

ii) hiring, or travelling on a boat sailing inter-island (otherwise than for transport of freight), are NOT allowed.

However, persons involved in the following activities will be exempt from the Shelter in Place requirement:

1. Persons who have to perform urgent home plumbing, electrical or roof repairs (for example, answering an emergency call for such services);

2. Persons who host or attend a wedding which has NO MORE than 10 persons other than the bride, bridegroom, official witnesses and the marriage officer; and

3. Persons who host or attend a funeral which has NO MORE than 10 members of the immediate family, six pallbearers, at least one officiant and essential mortuary staff.

#### Conclusion

Persons are reminded to practice social distancing by maintaining a distance of at least 6 feet or 2 meters from any other person, no matter where they are. It is only in so doing that they can reduce the further spread of this virus.

Persons are also reminded that with the exception of those that are exempted, all establishments, institutions, businesses, organizations and offices shall be closed but, if the employers so require, their employees shall work remotely from home.

As a reminder to all persons employed within the public service, unless they are specifically designated as an essential worker, they must work remotely from home.

The public is reminded that during this time, for the purposes of ensuring persons abide with the Shelter in Place requirements, a police officer may require a person to answer any questions to enable the police officer to ascertain who the person is and whether he or she is an exempted person.

police officer that the person falls within the exempted categories, the police officer may direct the person to go immediately to the person's place of abode or place of residence.

A police officer may also use reasonable force, if necessary, in the exercise of this power.

However, it will not fall to the Police alone to enforce the Regulations. Indeed, the Government expects that this will be largely an honour system whereby persons appreciate the imperatives involved, act responsibly and exercise good judgment.

Sidebar: A sample of the letter that is provided by the Ministry of International Trade, Investment, Aviation and Maritime Affairs official to employers in relation to their exempted employees is given below.

"I am writing to inform you that your organisation has met the requirement for 1 of our 10 categories for curfew exemption.

Your organisation is therefore exempt from Curfew imposed pursuant to the section 49(1) of the Police Law (2014 Revision) to specifically combat the COVID-19 pandemic threat.

This exemption grants freedom of movement for critical staff to perform essential work duties during the hours of **<u>5am and 7pm</u>** that a curfew has been imposed in the event of an emergency.

If stopped by law enforcement during curfew hours, the Essential Staff Member is required to comply with law enforcement instructions and to present this letter, along with a letter from you naming the staff member as essential and company or government issued identification.

### **Essential Services Continue During** *Coronavirus*

The national response to COV-ID-19 has required everyone to adapt their ways of working, including those of the essential services the public rely on to keep them safe.

The Department of Public Safety Communication (DPSC), Cayman Islands Fire Service (CIFS) and Her Majesty's Cayman Islands Prison Service (HMCIPS) continue to offer their world-class service 24 hours a day, albeit under adjusted conditions.


'The primary focus for all our essential agencies remains to be the safety of everyone across the Cayman Islands. Each agency has well-versed business continuity plans and are working closely as a public safety community to continue operations during these difficult times," commented the Minister for Financial Services and Home Affairs, Hon. Tara Rivers, JP.

In an emergency, DPSC reminds residents to inform the 911 operator if anyone at the incident has coronavirus symptoms and/or is self-isolating. This crucial information will help to minimize disruption to the public safety operations and protect first responding staff.

Since 7 March, DPSC has received 123 calls from the public relating to coronavirus.

The Director of Public Safety Communications, Julian Lewis, said, "DPSC employees are dedicated professionals who contribute to public safety every single day. Our well-practiced business continuity plan ensures an uninterrupted public safety answer point for all three islands. We are in constant contact with our emergency service partners to see this plan is a success to handle and mobilise an efficient and swift professional operational response to all incident types."

CIFS has supplies of personal protective equipment and enhanced op-





erational control measures in place to keep firefighters safe and able to continue to protect the community.

Chief Fire Officer, Paul Walker QFSM, stated, "I would like to offer my assurance to the residents of the Cayman Islands that CIFS will continue to respond to their needs and maintain a 24 hour, 7 days a week fire and rescue service throughout the challenging times ahead. We are working with our emergency service partners to provide a swift and professional operational response to all incident types."

In response to the current COVID-19 concerns, HMCIPS has taken steps to mitigate the likelihood of transmission in prisons. In addition to following the health advice of public health officials, HMCIPS has implemented restrictions to the numbers of visitors, volunteers and service providers that enter. New systems are in place to enable family contact to continue instead of face-toface contact.

The Director of Prisons, Steve Barrett stated, "I would like to take this opportunity to assure residents that public protection and the rehabilitation of offenders remains our core function, in spite of the exceptional community health circumstances we are facing. We are taking all of the steps we can to ensure that those in our custody and our staffing group are protected. This is a time where the prison community needs to exercise a shared responsibility to look after one another and that is what we are working to do."

DPSC, CIFS and HMCIPS are part of the National Emergency Operations Centre and the broader robust response to the coronavirus taken by the Cayman Islands Government. 📀





### Athletes relieved that Olympics is delayed

The postponement of the Tokyo Olympics by a year has been universally applauded by officials, athletes and coaches. Many who would have competed in Japan at the end of July had already missed around a month of quality training because of the disruption caused by the pandemic coronavirus outbreak. Many athletes train in different locations from where they live and are still struggling to get home because of the disruption of cancelled and rearranged flights.

The postponement makes sense as qualifying events had already been cancelled so it made it impossible for the best athletes to be chosen and be in peak form for the Games. Many were finding it difficult or inadequate to simply train indoors.

The postponement came after talks between Japan's prime minister, Shin-



Alistair Brownlee is glad that the Games are postponed zo Abe, and the International Olympic Committee president, Thomas Bach.

Abe said they had established that cancelling the Games was out of the question, and that Bach had agreed "100 percent" that a postponement was the most appropriate response to the global disruption.

Alistair Brownlee, double Olympic triathlon champion said: "Evidently a very tough decision for the IOC and other stakeholders to make but in my opinion the right one. Both, for the message it sends to people around the world battling with the virus and to give clarity to athletes attempting to prepare."

Callum Skinner, retired cycling team sprint Olympic champion, who fronts competitor-led movement Global Athlete, said: "The right decision has been made. Tokyo 2021 presents an amazing opportunity to host a full Games celebrating the world (hopefully) entering the "post-pandemic" phase."

Paralympian Kadeena Cox, cycling and athletics champion, said: "The right choice. Health before everything. Let's all stick together through these tough times and when the time is right, we can enjoy the Games and its legacy."

The delay gives marathon king Eliud Kipchoge extra time to prepare although he will be 36 by next year. When the brilliant Kenyan broke the two-hour barrier for the marathon in October 2019, he did not run alone, but now, as a diary he is recording reveals, he has no choice.

The Rio Olympic champion may be the only man to have broken two hours over 26.2 miles but when he set the time in Vienna, he ran with a cadre of pacemakers.

Now, as the first entries of "Eliud Kipchoge's Isolation Diary" makes clear, he is experiencing the loneliness of the long-distance runner.

The diary, recorded for the BBC, opens with the Kenyan rising from a kitchen chair with his tracksuit and running shoes on. He gives commentary of how he is training solo day by day.

The Olympic Games and Paralympic Games will continue to be called the "Olympic and Paralympic Games Tokyo 2020" even if they are held next year.

Tokyo 2020's fate was in effect sealed this week when Canada and Australia said they would not send athletes to Japan in July, while the British and French governments urged the IOC to make a quick decision.

The US Olympic and Paralympic committee followed suit, citing the "enormous" disruption the pandemic had caused to training and the qualification process. World Athletics, the Olympic committees of Brazil, Slovenia and Germany, USA Swimming and USA Track and Field had joined the growing chorus of calls for a new date for the event.

The postponement is a blow to the host country, which has spent more than \$12bn on the event, while huge sums are also at stake for sponsors and broadcasters. Goldman Sachs estimated that Japan would lose \$4.5bn in inbound and domestic consumption in 2020 if the Olympics did not take place as planned.


The Games have never been postponed in this way, but they were cancelled in 1916, 1940 – also a planned Tokyo Games – and 1944, during the first and second world wars. P

# **NBA restart will be problematic**

The NBA went on hiatus March 11, and if there was any concern the league acted too hastily, the rapid spread of the coronavirus throughout the Los Angeles Lakers, Boston Celtics, Brooklyn Nets, Utah Jazz, Detroit Pistons and many others relieved any doubt.

Very quickly, the NBA went from full attendance to considering games without spectators to fully shut down. It was undoubtedly a difficult decision, but no more games were not difficult to execute.

The real challenge will be starting back up. When will that be a serious consideration, and what will that look like? NBA Commissioner Adam Silver admitted he is not sure. There have been tentative talks of matches without spectators but even that is unfeasible because it would involve a minimum of 50 people in attendance. One transmission, even to a non-player, and the league shuts down again.

Multiply the risk to 29 arenas (with the Clippers and Lakers sharing Staples Center) and the travel involved. Can the league isolate and quarantine that much personnel?

Then there's the logistical nightmare of rescheduling games. The league is staring down at least \$1 billion in losses as things stand.

To alleviate the complications, perhaps a neutral site would make more sense for the league. Bring the entire NBA to Las Vegas, where they have T-Mobile Arena and the nearby facilities at UNLV's Thomas & Mack Center. The city certainly has the hotel capacity with casinos currently closed.

Whatever income is lost by the league, roughly 50 percent will be passed on to the players. That loss will undoubtedly impact next year's salary cap, which was last projected by the NBA to reach \$115 million.

Pushing back the conclusion of the current campaign could delay the start of next season. Perhaps now is the time, given the league and union will need to negotiate their way out of the existing crisis, for more fundamental change to the league.

The priority before the league can return to some version of normal is health. The finances pale in comparison to player, team and public safety.

Meanwhile, LeBron James has reiterated his love for Liverpool Football Club. The LA Lakers star owns a minority stake in the Reds and has close ties to owners FSG.

He's also represented by Liverpool's new kit manufacturer Nike, and it's expected that the Reds will look to tap into James' popularity in the USA to promote the club in America.

James has been to Anfield several times and has reiterated his affection for the club in a live Instagram Q&A.

Asked who are his favourite footballers, he said: "Favourite soccer players ...

I got a few. First of all, every player on Liverpool. Straight up. Every player on Liverpool."

And James would go on to declare his love for French striker Kylian Mbappe, who has been linked with a move from PSG to Anfield.

He added: "Mbappe, Neymar, Cristiano Ronaldo, those guys are legends, I love those guys. Those are just a few of them." James is one of the greatest basketball players of all time having won three NBA championships, four NBA Most Valuable Player Awards, three NBA Finals MVP Awards, and two Olympic gold medals. He was invited in 2011 by Liverpool's owners Fenway Sports Group to buy a minority 2 percent stake in the club worth \$6.5million which by last year ESPN estimated to have risen in value to around \$32million.

### Trinidad and Tobago Records Second COVID-19 Death; Total Number of Caribbean Cases Surpass 900

A second Trinidadian has died from the new Coronavirus (COVID-19) that has been responsible for more than 25,000 deaths worldwide.

The Ministry of Health announced today that, "despite the best efforts of the health care professionals, a second national of Trinidad and Tobago who tested positive for COVID-19 has died". The deceased was an elderly man with pre-existing medical complications. A 77-year-old man with underlying medical issues died on Wednesday.

"The Ministry of Health offers its condolences to the family who is, understandably, grieving this loss at this time. Members of the public are urged to respect patient confidentiality and to allow the family the space to cope with the death of their loved one," it said in a statement.

As of this morning, of the 453 samples submitted to the Caribbean Public Health Agency (CARPHA) for testing for COVID-19, 66 tested positive. Only one COVID-19 patient has so far been discharged, the Ministry said.

Of the 66 cases, 47 came from the group of nationals who recently returned from a cruise.

Yesterday, Prime Minister Dr Keith Rowley urged residents to stay in their homes as the country seeks to stem the spread of COVID-19.

"We have not declared a state of emergency or any lock down.... From Sunday midnight we will deepen our separation by having non-essential activities forbidden," he said, though stressing that people would be able to go out for essential food and medicine.

As of this morning, the number of COVID-19 cases in the Caribbean had surpassed 900, with more than half of them in the Dominican Republic.

The 927 cases were recorded in: Dominican Republic (488 – including 10 deaths), Venezuela (107 – including 1 death), Cuba (67 – including 2 deaths), Trinidad and Tobago (66 – including 2 deaths), Aruba (28), Jamaica (26 – in-



cluding 1 death), Barbados (24), United States Virgin Islands (17), Bermuda (15), Dominica (11), Bahamas (9), Haiti (8), Suriname (8), Antigua and Barbuda (7), Curaçao (7 – including 1 death), Grenada (7), Cayman Islands (6 – including 1 death), Guyana (5 – including 1 death), Montserrat (5), St Lucia (3), Anguilla (2), Belize (2), British Virgin Islands (2), St Kitts and Nevis (2), Sint Maarten (2), Turks and Caicos Islands (2) and St Vincent and the Grenadines (1).

### Night Time Curfew To Take Effect in Barbados as COVID-19 Response Plan Enters Stage 3

With the number of cases of the new Coronavirus (COVID-19) in Barbados reaching 24 yesterday, government will go to Parliament today to amend the Emergency Management Act to allow for the declaration of a public health emergency.

As a result, an 8 p.m. to 6 a.m. curfew will take effect from tomorrow until April 14 for residents, except those who are part of the essential services.

Prime Minister Mia Mottley, who made the announcement in an address to the nation last night, stated: "To be absolutely clear, the first day when 24-hour movement will be allowed for all persons again, unless further extended, will be Wednesday, the 15th of April."

The Prime Minister identified the essential services as including the uniformed organizations of Barbados; security organizations; the Royal Barbados Police Force; the Fire Service; the Barbados Prison Service; Immigration; Customs officers; the medical and paramedical professions; caregivers; hospital providers; utility companies; telecommunications; media and broadcasting services; the provision of essential transport; the collection, storage, purification and distribution of water; the collection, storage, treatment and disposal of sewage and garbage; and the removal of dead bodies.

There will also be a number of services which will be allowed to operate during the course of the day, within the time frame of 6 a.m. to 8 p.m., but the hours would differ, she disclosed.

After the amendment passes in Parliament, details of these will come in an announcement by Attorney General Dale Marshall, who will be joined by the Minister of Health and Wellness, Lt. Col. Jeffrey Bostic, the COVID-19 Czar, Richard Carter, and the Acting Chief Medical Officer, Dr. Anton Best.

The Prime Minister outlined that businesses which will not be impacted by the new restrictions include grocery stores, pharmacies, restaurants for take-away or drive-through only, shops, commercial bakeries, butcher shops, abattoirs, and gas stations, along with fishermen and farmers

tween 9 a.m. and 2 p.m. She, however, cautioned: "While there will therefore be some activity remaining between 6:00 in the morning and 8:00 at night, we are appealing to all Barbadians to please minimize the number of times you need to go outside. Persons have done well, thus far. We can continue to do well if we hold each other's back up at this very critical time."

Prime Minister Mottley made it clear that the country had enough food supplies and the grocery stores will remain open, therefore there was no need for "any mad rush" as the result of the imposition of the restricted hours for movement. (\*)

### St Kitts & Nevis Closes Borders; Country Records First COVID-19 Cases

Commercial flights into St Kitts and Nevis have been banned for two weeks as the government moves to stem the spread of the new Coronavirus (COV-ID-19), after the country became the last Caribbean Community (CARICOM) country to record cases.

Two nationals – a 21-year-old man and a 57-year-old woman who returned to the island from New York – tested positive for the virus.

Both arrived on March 18 and were tested on March 20 and had been in home quarantine ever since they returned to the twin-island federation.

Under the announced flight restrictions, which will remain in effect until April 7 in the first instance, Medevac or medical emergency flights will be allowed should the need arise.

International air cargo and cargo by seafaring vessels will also be allowed in order to maintain connectivity that enables the Federation to import needed commodities such as food, fuel, medical supplies and equipment.


"Let me reiterate that there is no need for panic and to assure all our citizens that everything is being done to mitigate any impact that we might have, and of course to protect you, our people," Prime Minister Dr Timothy Harris said on Wednesday.

He urged residents not to engage in panic shopping.

"I want to assure you that St Kitts and Nevis has an adequate supply of food at this time. Our suppliers have all indicated that their stocks can last for almost two months and that their cargo ships are coming on a weekly basis," the Prime Minister said.

He said that by the end of this week, a total of 123 shipping containers will have arrived in the country via the various shipping agencies. P


