# EDITORIAL

## We can do this (together)

"This is essentially a lockdown...people need to stay at home," Premier Alden McLaughlin declared on Tuesday morning, as he notified the public of heightened measures being implemented in a bid to stem the spread of the deadly coronavirus (COVID-19).

The measures do not appear to have been taken lightly. If you listened to the Premier the day prior to announcing the "lockdown" and the morning that he did, his tone and demeanour changed. He was no longer simply an authoritative source of information. He was like a stern father handing doling out the consequences after the typical "who can't hear will feel" message.

But to think of it, that is exactly what he was doing. After more than a week of his and other authority figures urging the community to take the necessary precautions, groups of people could still be seen flouting the warnings they were given. They could be seen frolicking in large groups at Rum Point and playing sports in large groups.

"You can't expect this virus that we can't even see to be cramping our style.



It can't be as bad as in other places. Not in a small and special place like Cayman!" you can only imagine some of those people saying.

By now, we would have felt what it is like to be under curfew and a lockdown of all but essential services. For those of us who lived in the aftermath of Hurricane Ivan and Paloma, we know that things may seem bleak now, but we pray to God that better times are just around the corner.

We, at Caymanian Times, call on our community to heed the warnings of the health officials and the images that flood our social media and television screens of the pandemic taking root elsewhere. We can get through this but only if we ALL play our part. We can do this, Cayman! We have no other choice if we are to get through this.

## HSA Pharmacies expand refill services with WhatsApp

The Cayman Islands Health Services Authority Pharmacy has launched a WhatsApp service allowing members of the public requiring prescription refills to submit them via WhatsApp for next day pick up across all HSA pharmacies. Persons utilizing this service are to take a photo of their prescription label and send it to 925-6534 (Grand Cayman) and 916-9555 (Sister Islands).

The Cayman Islands Hospital Pharmacy has new hours of operation 7am - 5:30pm Monday - Friday and 8:00am - 5:30pm Saturday & Sunday to accommodate the Government's mandatory island-wide curfew. Over the coming days an alternative collection point for refills will be announced to help reduce the amount of persons needing to come to the main pharmacy.

"We have seen a spike in demand due to new guidance issued calling for social distancing and self-isolation," said Colin Medford, HSA Chief Pharmacist. "Similar to the protocol practiced during hurricane season, we are able to dispense one month of medication at a time and in most cases, persons with available refills, who have not received these medications in the past two weeks, can request an extra month's supply."

We encourage persons who require a refill to avail of our refill resources in order to reduce their need to travel or wait in line in public spaces."

- WhatsApp - send a photo of your prescription label to the pharmacy is now 925-6534 (Grand Cayman) and 916-9555 (Sister Islands)
- Online - fill out the online form on the HSA website [www.hsa.ky](http://www.hsa.ky)
- Dropbox - refill drop box service is located outside of the Cayman Islands Hospital Pharmacy
- In person (same day refill)
- Civil Servants at the Government Administration Building can call request refills which are delivered daily (Monday - Friday) to GAB
- Refills can also be called into the General Practice Clinic 244-7520 or 244-7683.

All refills will be ready within 24 hours.

If you have a new prescription, these can be submitted in the in person for same day pick up or in the drop box for next day pick-up.

## CUC Customer Update

Dear Valued Customer,  
In responding to the COVID-19 pandemic crisis, CUC continues to focus on the health and safety of our employees, their families and the general public while ensuring the continuity of electricity service to the Grand Cayman community.



The Company has plans in place to deal with crises such as this but given the unprecedented nature of the pandemic and how quickly the situation changes there are uncertainties in predicting how deep of an impact and how long this crisis may last. The Company fully supports the actions taken by the Cayman Islands Government and other private sector leaders thus far to limit and reduce the impact and uncertainty to the community and we ask that all be calm and patient as we all adjust our lives to respond to this temporary crisis.

We are maintaining regular teleconferences with Fortis Inc. and other utility groups to share experiences and best practices in responding to this pandemic. Within CUC, We are holding regular virtual meetings to communicate decisions, disseminate official information on the pandemic and to get feedback on our weekly operations.

We continue to work closely with our vendors and service suppliers looking out to the weeks ahead to ensure that our critical supplies and services remain available. We do not at this time anticipate any curtailment of the electricity supply.

As of Monday, March 14, all staff that could do their work from home are

working from home including half of the Customer Service Representatives. Approximately 80% of normal office-based staff are now working from home. Customer call response rates declined earlier in the week but by the end of last week were back up to the 90% level. We thank you for your patience.

Field and Power Plant employees also adjusted their work schedules with approximately 25% working from home and the rest splitting into more staggered shifts so as to increase the social distancing. An intense focus on sanitation of shared surfaces is also being maintained.

With respect to customer bills, we announced a week ago that disconnections would be suspended for March and that credit extensions would be given to customers who found themselves unable to pay because of loss of income due to the crisis. We are extending the suspension period to include April to allow time for all customers who require assistance to contact us. ## Employee Terminations and/or Temporary Lay-offs amidst the Coronavirus (COVID-19) Pandemic

Employers terminating or temporarily laying off workers as a result of the coronavirus pandemic must upon termination pay severance pay of one week's wages, at the employee's latest basic wage, for each completed twelve-month period of employment. The employment period is to reflect any time during which the employee worked for any previous owners of the same business.

Employees are also entitled to any earned vacation leave, sales commission owed, as well as gratuities earned.

In the cases of temporary termination, employers do not need to pay severance to their employees.

Exceptions to this include:

- Where the date of recall is thirty days or more in the future,
- If no date of recall is given at the time of termination. (Severance pay shall be payable thirty days from the termination if the employee has not been recalled. Interest at ten per cent per annum on the amount of severance pay due shall be payable for the interval between the original termination date and the date of actual payment).

For employees in agriculture and construction the exceptions above apply after six months.

The Department of Labour and Pensions will make every effort to work with employers and employees during this time to ensure the proper observance of the Labour Law (2011 Revision) and its Regulations.

### Editor's Note

Section 42 of the Labour Law (2011), which addresses severance pay provides the following guidance:



42. (1) Subject to subsections (2), (3) and (4), simultaneously upon the termination of the employment of any employee entitled to severance pay, the employer shall pay to that employee severance pay calculated in accordance with this Part.

(2) If the termination is stated to be temporary, no severance pay need be paid to the employee at the time of such temporary termination except-

(a) where the date of recall, if one is given at the time of termination, is thirty days or more in the future, severance pay shall be payable on the date of termination; or

(b) if no date of recall is given at the time of termination, severance pay shall be payable thirty days from the termination if the employee shall not then have been recalled; in which case, interest at ten per cent per annum on the amount of severance pay due shall be payable for the interval between the original termination date and the date of actual payment.

(3) Subsection (2) shall apply to employees in agriculture and construction with the words "six months" substituted for the words "thirty days" in both places where they occur in that subsection.

(4) Where payment of severance pay has been made, with interest where due under paragraph (b) of subsection (2), and the employee is subsequently recalled to his former or substantially equivalent employment or is again hired by the same employer, he shall be considered to be newly hired and his term of employment, for subsequent severance pay purposes, shall be considered to have commenced on the date of his recall or rehire.

## The Emergency Travel Hotline number announced

The Emergency Travel hotline number is 244 3333 and will be staffed Monday to Friday 9am – 5pm.

The hotline is for people who have an urgent need to leave the islands. For example for medical or compassionate reasons, for visitors who didn't make the last flights or for third country repatriations due to hardship etc.

Please only call the hotline if it is urgent and please be patient. The helpline is manned by a limited number of staff. If you can't get through, keep trying.

There are no quick answers and no guarantees that we will be able to offer a solution but the situation is fluid and changing daily. The call handlers may



not be able to resolve individual situations or questions. Please be realistic about what support might be offered. They are there to take down the details and that information will inform our discussions with the UK, other partners and airlines regarding an air-bridge.

## All Post Offices to Close and will Reopen 6 April 2020

In response to the Deputy Governor's instructions to the Civil Service today (Tuesday, March 24, 2020) that all non-essential government services are to close 25 March – 5 April 2020, the Postal Service is complying with those instructions.

Accordingly, all Post Offices across the three islands will close 25 March – 5 April and re-open on 6 April 2020, unless instructed otherwise by government at that time.

During this time, the NAU asks families and friends to support those who



wish to access the unit's assistance but who are without the means to email documents.

The NAU continues to offer its full range of services. Given its increased workload however it asks for the public to be patient. All queries will be answered in due course and all efforts will be made to process services in a timely manner.

## WORC Offices Closed due to COVID-19 – Advises persons to shelter in place at home

Due to the COVID-19 "Shelter in place at home" suppression measures, the WORC offices will be closed from March 25th until April 5th 2020.

Individuals with work permit facilities that expire during this period may continue working on the same terms and will be required to report to WORC once the shelter in place at home measure is lifted.

Permanent Residency holders whose right to work fees become due during this period may also continue to work under the same terms and submit the requisite payment and documentation to WORC once the shelter in place at home measure is lifted.

# PREMIER DISAPPOINTED WITH SOME BUSINESSES AS CURFEW EXTENDED

The curfew announced for the Cayman Islands on Monday has been extended.

It will now be in place effective from Tuesday evening 7pm for ten hours until 5am and will be in force for 10 days initially.

The previously announced curfew was from 9pm to 5am.

Hon. Premier Alden McLaughlin in announcing the extended curfew, said allowances will be made for essential services personnel and workers of companies designated as providing essential services.

"From 6am (Wednesday) all non-essential establishments will be closed," he declared.

"Persons will be required to shelter in place, meaning stay at home unless you fall into one of the categories of essential workers or unless your establishment, your business qualifies as an essential establishment."

The Government was meeting on Tuesday to firm up the legal definition of essential services, but much to the consternation of Premier McLaughlin ran into a wave of requests from businesses seeking to be classified under that heading.

## PREMIER DISAPPOINTED WITH SOME BUSINESSES

A clearly disappointed Premier McLaughlin questioned if some businesses were putting economics over the lives of their employees and found many of the requests alarming.

"What I am complaining about bitterly is a lack of acceptance that we are in really, really dangerous times and that we have to take radical action.

"We really have to work through this because, as I keep saying, if we can get to ten days without having to deal with sig-

nificant community spread, we would have achieved a huge, huge victory."

In appealing to the business sector for their cooperation, he said plans to impose the 'shelter in place/stay at home' requirement are being put on hold for the time being with a review pending Wednesday.

Claiming that the message seems not to be getting through some in the private sector, Mr McLaughlin said: "Economic consequences cannot be more important than people's lives."

He repeated that "if we succeed we will not only save lives but we will save the country from going into lockdown for months."

Mr McLaughlin also floated the prospect that if the business sector doesn't comply, Government might not have any alternative but to impose "a 24/7 curfew".

He "begged" the business community to "please support what the Government is doing as it's the right thing to do."

His Excellency, Governor Martyn Roper threw the weight of his office behind the Premier's appeal.

He noted that the civil service is playing its part and he urged the private sector to do likewise.

The Hon. Minister of Health, Dwayne Seymour referred to statistics supported by the World Health Organisation (WHO) and other international agencies which estimate that the scale of the potential disaster for the Cayman Islands if the drastic steps are not taken to suppress the spread of the COVID-19 virus here.

He said the projected rate of infection was 60% of the population if Government failed in to take the necessary measures.

"This could mean that 800 people in Cayman could die," Minister Seymour

warned, underlining the gravity of the crisis confronting the territory and the rest of the world.

## A SIXTH POSITIVE TEST

Earlier Tuesday, Chief Medical Officer Dr John Lee had announced that a sixth person had tested positive for the COVID-19 virus.

The person is a patient of the Health Services Authority.

Several family members and one close contact of the individual have been placed in isolation while further investigations are carried out.

Medical Officer of Health, Director Dr Samuel Williams-Rodriguez said they were looking into the likely mode of infection to determine if it was a community transmission.

If so, it would be Cayman's first case of community transmission of COVID-19 and would mark a new phase of the pandemic here.

Premier McLaughlin, in repeating his call for the public and the business community to abide by the restrictions Government is putting place said it was almost certain that the virus is within the community.

"We believe this is the best chance this country has of suppressing the community transmission of the virus, and we are taking the step now rather than waiting until there are multiple cases around by which time from what we've seen in other countries, it is usually much too late."

## ENFORCEMENT

In urging the public to cooperate with the police and other law enforcement authorities, Governor Roper said that in addition to police patrols, customs and border agents will be stepping up their vigilance.

The helicopter service will be deployed to support enforcing the curfew.

He acknowledged that "the curfew might not be perfect from Day One and will be adjusted as needed."

"We need people to have common sense and be pragmatic. We will improve it and we will enhance it as we go along. But the key thing is that it will remove many thousands of people from our roads and our streets and limit those human contacts."

And emergency travel line is also being established for persons who might have urgent travel needs.

Police Commissioner Derek Byrne said with the curfew in place until April 3rd, policing will be fair but thorough.

"There will be fair application of the law," he said, "but it will not be liberal."

He said that there will be high visibility but fair enforcement and persons deliberately breaking the law will face the consequences.

The penalties are \$3,000 or 1 year in prison, or both. 🌐

# STAY HOME CAYMAN

Following what has been described by Government as the excellent public response to the three-day total lockdown last week, the territory is now into the "Stay Home Cayman" phase.

A three-day 24 hour curfew, part of efforts to combat the spread of the COVID-19 pandemic locally, was lifted at 5am on Saturday.

It's been replaced by a combination of a hard nighttime curfew from 7pm to 5am, and a soft daytime 'Shelter-In-Place/Stay-At-Home' regime between 5am and 7pm.

During that period only government-designated essential services are allowed to open. The public is advised to observe the social-distancing advice or otherwise stay indoors.

"We are trying to save the country from a massive threat. We are in the

emergency stage. We are just trying to get through the next couple of weeks," Hon. Premier Alden McLaughlin stated.

He said he was very pleased with the public response to the measures so far.

Requesting that everyone including businesses continue to comply with the measures, the Premier said: "Government does not want to be forced to enforce another hard shutdown."

Mr McLaughlin again implored: "Stay home Cayman, unless you have very good reason to go out in keeping with the regulations."

Chief Medical Officer Dr John Lee reported that up to Friday the number of confirmed cases remained at eight - plus a ninth sample tested as positive but for which confirmation was still being awaited. 🌐

# Cayman Islands Government Office in the UK (CIGOUK) assists Caymanians to get home and shifts gear to focus on Caymanians in the UK

The UK Prime Minister, Boris Johnson, announced updated measures to be taken to prevent the further spread of the COVID-19 virus in the UK.

These measures are to reduce further spread of the virus in the UK to protect the people and the National Health Service.

The announcements include strict lockdown rules across the UK for three weeks. You will only be able to leave your accommodation for the following reasons:

- Shopping for necessities
- Once a day for exercise
- Medical need or providing care,
- Travelling to or from work only if absolutely necessary essential work (if you are unable to perform the work at home).

All non-essential shops are closing, excluded are food shops, pharmacies, corner shops, hardware stores, petrol stations, pet shops, post offices, banks, newsagents and shops inside hospitals.

Parks will stay open, but gyms including outdoor gyms, play-parks, kiosks, all places of worship except for funerals will close. All gatherings of more than two people are to be banned except for members of your own family. These measures are in place for three weeks.

Over the last two weeks, the CIGO-UK has been attending to the questions and concerns of overseas Caymanians including providing general advice, guidance and updates for those contemplat-

ing whether to remain in the UK and assisting with travel arrangements for those who determined to leave the UK prior to the Cayman Islands airport closing Sunday, 22 March.

Officers from CIGO-UK also went to Heathrow airport, or were standing by remotely, to monitor the check-in process for the last flight to Cayman in case any consular services issues arose.

The Office now turns its attention fully to those Caymanians remaining in the UK and is working closely with Cayman Connection UK in order to not only disseminate messages and to ensure Caymanians know where they can go for information and support, but also to develop a virtual community of support and togetherness

during this time of restricted physical gathering.

“The enhanced UK measures mean that now more than ever, Caymanians who stayed in the UK may feel isolated and even further from home and family and this is following a very difficult decision not to return. We want to ensure that remaining Caymanians do not feel like they have nowhere to turn. We are encouraging Caymanians remaining in the UK to register with a new online portal developed specifically for those who did not return home. We are working with networks and individuals and will join community zoom calls and initiatives to help Caymanians to feel more engaged with the virtual Cayman community overseas.”

# Reefs Go Live – Free modules, open-access for everyone

Beginning on 27th March at 9:30am, CCMI will be releasing a weekly live education session each Friday as part of our Reefs Go Live programme.

Starting with ‘How Do Scientists Grow Coral’, the module will include a 5-10-minute video and a 30-minute live question and answer session from CCMI’s Education Coordinator, Maisy Fuller, and Marine Operations Coordinator, Giacomo Santoro. Supporting educational resources and activities for students can also be found online at reefresearch.org for extra projects!

The first of three modules, ‘How do Scientists Grow Coral?’ will include footage of researchers diving on the reefs in Bloody Bay Marine Park, where students will ‘virtually’ visit Little Cayman’s coral nurseries. Students will be introduced to CCMI’s coral reef research programme and learn what it is like to be a scientist.



In the first module, students will get a brief history about why growing coral is much like gardening, what corals are, why corals are endangered, why it’s necessary to grow corals in nurseries, and

learn some basic scientific restoration methods.

Over the next three weeks, students will also learn how they can get involved in science. Topics such as endangered

species, predators, coral bleaching, and climate change will be included.

# Gas Prices in Cayman Decreasing

The cost of gas in the Cayman Islands has been declining considerably. However with Wednesday’s announcement that the Islands will be in a 24-hour lockdown, beginning at 7pm on March 25th, motorists won’t be able to take full advantage of the new prices for at least a day or two.

As of 24th March, the lowest price for a gallon of regular gas in the Grand Cayman was CI\$3.89 at Refuel and the highest price for regular was CI\$4.65 at the Walkers Road Rubis.

Prices for premium gas in Grand Cayman bottomed out at CI\$4.14 (also at Refuel) and customers paid CI\$4.96 at the Walkers Road Rubis as of 24th March. diesel prices were as low as CI\$3.59 at Refuel; representing the lowest quote published for that particular fuel; and as high as CI\$4.50 at On the Run (Brown’s Red Bay), which had the highest quote for diesel.

The lower prices come as the demand for oil worldwide is at an all time low and a barrel of the ‘black gold’ is trading almost in the single digits; a trend which can be attributed to a trade and price-war being waged between Russia and Saudi Arabia, as well as the down-turn in the global economy.

The energy sector is also reeling due to the onset of Corona Virus across the planet.

“Usually, prices in the Cayman Islands would lag behind global trends and only come down many months after prices drop - if at all - but during the recent Corona Virus concerns being experienced it seems as their is an effort by proprietors to pass on the savings at the pump more rapidly,” noted an industry insider who spoke exclusively with the Caymanian Times.

The highest Gas price for a gallon of premium gas in Cayman Brac, (premium is the only type of gas for which numbers were published in the Brac) was CI\$5.04; roughly 2 percent higher than the highest price of a gallon of premium in Grand Cayman.

The lowest price quoted for premium gas in Cayman Brac was CI\$4.89; representing a difference of 15 percent to the highest price being paid for premium in Grand Cayman.

Cayman Brac residents can find the highest prices for gas at West End and the lowest at Tibmart; respectively.

In Little Cayman the highest price for premium gas is CI\$5.82; coming in at 15 percent higher than the highest price in Grand Cayman and 16 percent higher than the highest price in Cayman Brac.

The price for a gallon of diesel in Cayman Brac was quoted at CI\$4.87, while the price in Little Cayman for the same was CI\$6.05; a difference of 20 percent.

The latter is 40 percent higher than the highest price for a gallon of diesel in Grand Cayman, while the former is 26 percent more than the highest price in Grand Cayman.

The prices of fuel are usually far greater in the Brac due to extra shipping costs.








It remains to be seen whether lower prices at the pump and a decrease in the

cost of oil worldwide, coupled with the current economic downturn will translate to cheaper Cayman Utilities Company electric bills in Grand Cayman.

However, the energy provider has said it will work with the Island’s residents to keep lights on for the month of March.

# BRITISH PRIME MINISTER AND HEALTH SECRETARY SELF-ISOLATE WITH COVID-19

coronavirus. I am now self-isolating, but I will continue to lead the government's response via video-conference as we fight this virus. Together we will beat this."

Mr Johnson was tested at Number 10 Downing St, address of his official residence and office by a team from the National Health Service (NHS) on the advice of the Chief Medical Officer of England, Professor Chris Whitty.

Professor Whitty has been appearing alongside the Prime Minister in his daily COVID-19 press briefings along with other senior UK government and NHS representatives.

Mr Johnson was absent from Thursday's session.

The Prime Minister has self-isolated and will work from home for an initial 7 seven following standard precautionary procedures.

His pregnant partner will stay in separate quarters in the official residence.

In a video posted on his Twitter account, Mr Johnson said:

"I'm working from home and self-isolating and that's entirely the right thing to do.

"But, be in no doubt that I can continue thanks to the wizardry of modern technology to communicate with all my

top team to lead the national fightback against coronavirus."

He thanked the public for their well-wishes which have started to stream in and was especially praiseworthy of the NHS staff.

Mr Johnson will continue his duties as Prime Minister working remotely.

The British Prime Minister carries ultimate constitutional responsibility for the Cayman Islands and the other British Overseas Territories.

## SECOND CABINET MEMBER TESTS POSITIVE

Meanwhile, less than an hour after, the British Secretary of State for Health, Matt Hancock confirmed that he too had contracted COVID-19.

In a Tweeted video message he said: "Following medical advice, I was advised to test for coronavirus. I've tested positive. Thankfully my symptoms are mild and I'm working from home and self isolating until next Thursday."

The Health Secretary who has portfolio responsibility for the NHS, said it is "vital that we follow the advice to protect our NHS and save lives."

By Thursday, the UK had recorded 578 deaths from COVID-19, the most of them in London now considered the epicentre of the outbreak in the UK.

Of around 12,000 confirmed cases in the UK, most of them - around 4,000 - are in London considered as the epicentre of the crisis in the country.

The huge ExCel conference centre in the capital is being rapidly converted into a mega 2,000-bed hospital to treat exclusively COVID-19 patients.

It will be called the Nightingale Hospital in honour of the British World War 1 nurse heroine, Florence Nightingale. 🌐

# Prince Charles tests positive for COVID-19

Britain's Prince Charles has tested positive for COVID-19.

A statement on Wednesday morning from his official residence Clarence House said the 71-year old prince had begun displaying "mild symptoms" on Sunday.

The heir to the British throne is said to be self-isolating and working from home.

He was tested for the virus on Monday with the results released on Tuesday evening.

Prince Charles is said to be "otherwise in good health and has been working from home throughout the last few days as usual."

His wife Camilla, The Duchess of Cornwall, was also tested for COVID-19.

Her results were negative.

She is said to be also self-isolating at their home separately from Prince Charles.

Both will follow the standard 14-day isolation period.

Prince Charles has had a number of public and private engagements recently.

He is said to have last seen Her Majesty the Queen, his mother, on March 12th.

A statement from Buckingham Palace, the Queen's official residence said: "Her Majesty the Queen remains in good health. The Queen last saw the Prince of Wales briefly on the morning of 12 March and is following all the appropriate advice with regard to her welfare."

It is not known if the Queen has also been tested for coronavirus as a result of Prince Charles's positive test. 🌐

# Cuban medics needed all over the region

Cuban doctors are world renowned for their expertise and knowledge as well as their availability to work abroad which is why they are being deployed worldwide to tackle the novel coronavirus outbreak. Such is their capability; they are being invited all over the Caribbean and elsewhere. Many of the hired Cuban medics have experience in fighting the Ebola epidemic in Africa. Other Cuban groups have left for Nicaragua, Suriname, Granada and Jamaica.

Jamaica welcomed 140 Cuban medical professionals on the island Saturday, to help the country fight COVID-19. The St Lucia government has hired 100 Cuban doctors and nurses to help their effort too. Barbados is considering hiring Cuban doctors and nurses to assist their battle.

The Jamaican team comprises of 90 nurses specialising in critical care, emergency, medical-surgical and primary care; a team of 46 doctors who are internists and haematologists, and four therapists. In keeping with the government's current regulations for travel, the entire team are quarantined for 14 days before being deployed across hospitals island wide.

The Cuban medics arrived at the Norman Manley International Airport and were greeted by Jamaica's Minister of Health and Wellness, Dr Christopher Tufton and Cuban Ambassador to Jamaica, Inés Fors Fernández.

Tufton said: "Thank you, Cuba for your quick response to our request for support against COVID-19. Thanks to the local health team who coordinated

to get this mission here in just over a month."

A spokesperson for the medical team said Cuba was happy to assist Jamaica and stressed the importance of solidarity amid the spiralling spread of the virus. "We will assist our sister nation. We are proud of following the principles of the Cuban medical collaboration," said Eduardo Roperio, head of the corps.

"We, along with Cuban doctors already working in Jamaica as part of a bilateral agreement between the two governments, are committed to helping address COVID-19," he added.

The medical collaboration between Jamaica and Cuba dates back to 1976 when at the request of the Jamaican government, Cuba sent a brigade of 14 doctors to the island. Over the years, Cuba has sent hundreds of medical professionals to Jamaica to assist whenever possible. Jamaica has also returned the favour, sending nurses and doctors to its neighbour to assist in times of crisis.

Jamaica had reported 23 cases of the COVID-19, including one death by Wednesday. The entire country has been declared a disaster area, with schools, bars, entertainment venues, and universities closed. Communities in Bull Bay in St Andrew and Corn Piece in Clarendon have also been quarantined. The country's air and seaports are closed to incoming traffic for two weeks.

St. Lucia Prime Minister Allen Chastanet announced that the Cuban health professionals would provide much needed assistance to their local counterparts. Chastanet told legislators that

accommodation has already been arranged for the Cuban doctors and nurses who are expected by Friday.

Chastanet also thanked the government of Cayman, who he said volunteered one of their planes to transport the Cuban medical team directly to St Lucia. They will be helping to set up Victoria Hospital as a dedicated respiratory hospital. They will work at both Victoria and the Owen King European Union (OKEU) Hospital.

Chastanet also said that the most dangerous threat surrounding the virus is what has been seen in other countries like Italy, where hospitals become overwhelmed to the extent that healthcare becomes increasingly difficult to deliver.

He noted that the decision to close St Lucia's airports to incoming passengers, including St Lucian nationals wanting to return home, was a tough but necessary call. The plan is to have OKEU serve the basic health needs of St Lucians while Victoria will be a dedicated respiratory hospital to deal with a potential crisis.

Brazil has revised its position against the presence of Cuban doctors in its health care program and now its health ministry has announced that it intends to re-hire up to 1,800 Cubans to tackle the problem.

Almost 9,000 Cuban doctors, many working in poor, remote communities across Brazil, headed home in November 2018, after Havana pulled them. Brazil President, Jair Bolsonaro said they were

working in "slave labour" because the Cuban government took 75 percent of their salaries. But 1,800 did not go back to Cuba and will be eligible for re-hiring, a ministry official told Reuters.

So in demand are the Cubans that a medical team arrived in Italy this week to help their crisis. When boarding a flight in Havana towards Rome, they were applauded by the other passengers. The delegation included 37 doctors and 17 nurses and will work at the Crema field hospital, in the Lombardy region, the epicentre of the crisis with over 28,000 cases and more than 3,500 deaths.

Lombardy authorities made an international appeal asking for help in dealing with the countless cases which prompted the Cubans' response. Cuban doctors have much experience with major epidemics. Cheers Cubans serve 61 countries in Africa, Central America and Asia. They operate mainly in poor countries, and in locations without medical coverage.

In recent times, doctors have become Cuba's biggest export. When former Cuban leader Fidel Castro established a communist regime on the island in the 1950s, universal health care was one of his biggest investments. This led to a booming healthcare system, a higher life expectancy than in the United States, and more doctors per capita. And while Cuba has recorded 21 cases of COVID-19, many countries around the world are looking to the island for answers. 🌐

## Canadians told to respect lockdown

Canadians in their millions can expect more restrictions after the number of coronavirus cases in the country jumped significantly.

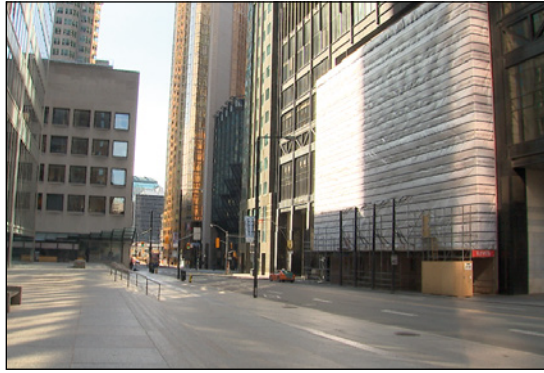
New diagnosed cases spiked by a third on Monday alone, and notable jumps were reported in the country's largest provinces of Ontario, Quebec and British Columbia.

More than 2,000 people have tested positive in Canada and at least 25 people have died, according to John Hopkins University.

"We must slow community spread through unrelenting social distancing. A key reason we want to delay and flatten the epidemic curve is to buy time for research and innovation to occur," said Dr Theresa Tam, Canada's Chief Public Health Officer.

Ontario and Quebec have tightened business and travel restrictions and all non-essential businesses were ordered to close on Tuesday. A state of emergency was also declared in the city of Toronto, mayor John Tory announced.

Canadian officials say they have now tested more than 100,000 people and will be able to test as many as 10,000 people per day.

Over the weekend Prime Minister Justin Trudeau said it was not yet necessary for Canada to declare a national state of emergency, but he pleaded with all Canadians to stay home and avoid all non-essential visits anywhere, including to family and friends.

He said then that his decision about when or if to declare a country-wide state of emergency or a more complete lockdown would be based on science, and that emergency powers were not yet needed.

Trudeau himself has been in quarantine along with his wife and three children after his wife tested positive for coronavirus two weeks ago. He says he is still symptom-free. 🌐

## Pacquiao puts "life on the line" to help

Manny Pacquiao is so dedicated to helping Filipinos during the coronavirus pandemic that he has said that he is not afraid to die.

The superstar boxer entered politics in 2010, when he was elected to the Philippines House of Representatives to represent the province of Sarangani. In 2016, he was elected to serve a six-year term as a senator.

The Philippines had reported over 600 cases and at least 33 deaths.

Pacquiao is a legendary philanthropist in the Philippines. He has founded the building of thousands of houses for poor people. He is worried that people could resort to looting if living conditions deteriorate because of the spread of the virus.

"If you are a leader, you have to be a frontliner," Pacquiao said. "I'm prepared to put my life on the line. You have to lead and let people see that

you are with them. I grew up poor. I know what they feel."

Pacquiao donated 600,000 face masks to frontline workers tackling the coronavirus outbreak in the Philippines and teamed up with Alibaba's billionaire CEO, Jack Ma, to donate 50,000 COVID-19 testing kits.

He has also made numerous public appearances to try to reassure residents fearful of COVID-19 spreading even more. 🌐

## Private sector makes peace with president

The Honduran government and the private sector are working together to work as a team to confront Covid-19.

President Juan Orlando Hernández met with Juan Carlos Sikaffy, President of the Honduran Council of the Private Enterprise (COHEP), and other representatives of its membership such as banking, production, maquila, power generation and commerce, to plan the country's economy.

The plan will consider key milestones related with biosafety, economy aid, employment, production, food and health. The parties also agreed in aiding 800,000 families living in the most vulnerable areas of the capital Tegucigalpa and Choluteca, La Ceiba, San Pedro Sula and wherever new outbreaks are emerging.

"We join the Government's efforts to contain the spread of COVID-19. As the private sector we are aware of our commitment to guarantee employment, food and health guidance for the people in this crisis, for which reason we have decided to actively participate in all issues of social nature so that the negative impact on production is as little as possible," said Sikaffy.

He praised the government's work to flatten the curve and stressed that it

is important to comply with biosecurity measures, so the productive sectors gradually incorporate themselves into their labour activities.

Pedro Barquero, President of the Chamber of Commerce and Industries of Cortés (CCIC) and one of the main critics of Hernández, highlighted that for the first time they are united, the unions and chambers of COHEP to face this crisis. He said: "Our resentment and differences are in the past. I think the differences I have had should be erased from our memory and we must work together to face this crisis in the best possible way." 🌐

## Cuba announces anti-virus measures

Cuba President Miguel Díaz-Canel has announced on TV new measures to confront Covid-19 in the country.

He said that those who are concerned about the pandemic, and have suggested social isolation or total quarantine, should consider that while most Cubans can isolate themselves, another portion of the population cannot halt activities that are vital to the country.

The first measure announced by Díaz-Canel is the regulation of the country's ports of entry, with authorisation only for residents of Cuba, although there will be flexibility to provide for cooperation with other countries.

"In this way, we ensure the entry of Cubans who are currently abroad, the return of foreign visitors to their home countries, and commercial activity," he stated. "This will allow us to avoid new cases, and focus on detecting more cases within the country, and avoid further transmission."

This 30-day measure started on Tuesday. It also stipulates that Cuban residents returning to the country will be quarantined for 14 days, to protect families on the island.

Díaz-Canel also called for more serious application of social distancing practices, in everyday life. He recommended that highly susceptible persons stay at home, avoiding close contact with others, as much as possible, and reducing the number of contacts and the duration of visits, which have the greatest impact on the possibility of transmission.

He reiterated the importance of working at home, tele-commuting, providing online classes and activities for students, and going out only to purchase food or medicine, or take care of an urgent matter.

Also announced were economic measures to protect the population's income, including restructuring the workweek, extending unemployment benefits and temporarily waiving the payment of taxes, among others. 🌐

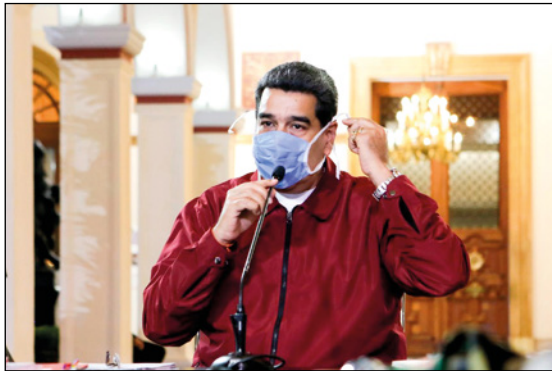
## Venezuela worried of mass spread

Venezuela has at least 70 cases of the coronavirus, increasing anxiety in a crisis-stricken country where the healthcare system lacks infrastructure and resources to treat basic diseases.

"We are facing an unknown disease, without knowing what the behaviour will be in our country," said Dr Oscar Noguera, an internist and director of Ancora Humanistas, a nongovernmental organisation in Venezuela.

"Health personnel are already complaining about the lack of adequate clothing for their protection, while the increased emigration of doctors and nurses has left our hospitals in a vulnerable condition. The number of intensive care beds available in the country is barely close to 80."

In an attempt to contain the outbreak, President Nicolas Maduro imposed a nationwide quarantine and restricted travel between states. "We are preparing for the most dire situation we've ever faced before," Maduro said on state television. "All of the country will enter a quarantine. It is indispensable and necessary, and it is the answer."

But such measures have done little to quell the anxiety that comes with the coronavirus.

The president also encouraged people to wear face masks, even if it meant improvising them, and he banned people from boarding the metro or taking trains without one.

Analysts warned that the quarantine is not a feasible option for a lot of people, as many operate in the informal economy.

"The quarantine poses a dilemma between producing and surviving or guarding and protecting yourself," Carlos Pina, a Venezuelan political analyst, said. 🌐

## UK wants public to self-isolate

Strict new curbs on life in the UK to tackle the spread of coronavirus have been announced by Prime Minister, Boris Johnson. The new measures comes at the same time as the UK government converted the ExCel Conference Centre in East London as a makeshift hospital that can accommodate 4,000 patients.

People may only leave home to exercise once a day, to travel to and from work where "absolutely necessary", to shop for essential items, and to fulfil any medical or care needs, said Johnson.

Shops selling non-essential goods have been told to shut and gatherings in public of more than two people who do not live together will be prohibited.

The UK death toll has reached 335. If people do not follow the rules police will have the powers to enforce them, including through fines and dispersing gatherings, Johnson said.

He said the country faced a "moment of national emergency" and stay-

ing at home was necessary to protect the NHS and save lives.

He said the restrictions would be in place for at least three weeks and would be kept under constant review.

The government guidance says people should only leave home to shop for food or medicine, go to work, exercise or attend a medical appointment.

Even when following this guidance, people should minimise the amount of time spent out of their homes and should keep two metres away from people they do not live with.

The government has also stopped all social events, including weddings, baptisms and other ceremonies - but funerals will be allowed. 🌐

### Do
