AIR BRIDGE FEARS ALLAYED



Hon. Premier Alden McClaughlin has moved swiftly to allay concerns emerging from some parts of the community over next week's much anticipated charted British Airways flight.

There has been a feeling of disquiet expressed by some people about the screening of persons due to return to Cayman on that flight.

A number of students, other Cavmanian nationals, and Cayman residents living in the UK will be on the inbound charter part of an emergency air bridge set up by the UK for the Overseas Territories.

The flight will come via Bermuda as a number of nationals of that sister territory will also be on board.

Concern has been expressed over the persons on the flight coming from a highrisk country. There have been around 1800 deaths and more than 22,000 cases of COVID-19 to date in the UK.

CAYMAN CORONAVIRUS CASES INCREASE

A further eight cases of COVID-19 have been confirmed in the Cayman Islands bringing the total as at Wednesday April 1st to 22.


In giving the daily update on Wednesday, Chief Medical Officer Dr John Lee said all of the persons tested positive have either fully recovered or are only showing mild symp-

He said 251 tests have been conducted so far of which 228 have been negative.

The persons tested positive are from a combination of households and persons who have returned to the territory.

Dr Lee's prognosis is that the numbers are likely to increase as testing and contact tracing continues.

Government Continues to Provide for Those in Need



In addition to nearly CI\$3 million already approved by Cabinet to assist the most vulnerable, elderly and disabled Caymanians, Government continues to provide for residents negatively affected by COVID-19.

Emergency supplementary funding, recently approved by Cabinet, will provide temporary food assistance to non-Caymanians who qualify and are unable to leave the Cayman Islands or who find themselves out of work due to the impact of COVID-19.

Work permit holders who urgently require food supplies and who have insufficient income or savings to sustain themselves may now be eligible for a \$150 food voucher effective Wednesday, 1 April, 2020.

Seeking to bring some clarity and reassurance to the issue, Premier McLaughlin reminded that the persons coming in on that BA flight are Cayman nationals or persons who have the right of abode in the territory.

"It is very difficult to tell people who have a right to live in the country or people who are citizens of your country that they are not allowed in."

The Premier said that stringent measures have been put in place to manage their return at this time of global and national public health emergency.

He stressed that anyone arriving in Cayman "will be subject to strict mandatory monitoring by the government in a place other than their home for 14 days."

"The point I'm making, he said, "is that those persons who are currently isolated (the students) and those who will come, will pose a far less risk to this community that individuals who move about freely, not practicing social distancing and handing together in groups."



Mr McLauglin also said that residents who disregard the current restrictions "are far more likely to be vectors of COV-ID-19 than persons who have been isolating or will be isolated for 14 days."

His Excellency the Governor Martyn Roper, in giving an update on the flight plans on Tuesday, also gave an assurance to residents that adequate measures have been put in place to safeguard the community.

"I think the messaging has helped reassure many people in the community who

were concerned about this. I want to repeat again that we'll do absolutely nothing to put in jeopardy the welfare, well-being and health of people on these islands."

In additional to those coming in, the flight will also bring a shipment off vital medical supplies from Public Health England to support the ongoing efforts here in the fight against COVID-19.

"That flight is increasingly important for bringing in equipment. It will have UK-funded personal protection equipment on it, it will also have some HSA-ordered equipment on it ...and the supermarkets are also looking at bringhhin in some supplies on it."

Mr Roper said there have also been numerous requests locally from persons who wish to catch the flight out.

The chartered BA flight paid for by the British government will fly to Cayman via Bermuda and will return to the UK via the Bahamas.

The UK government is spending £75 million in chartering flights to airlift British citizens trapped overseas to return to their homes in the UK.

Premier McLaughlin said he expected the local tourism industry to be particularly hard hit as a result of the COVID-19 pandemic.

He said Government was looking into ways of assisting those persons with work permits to return to their home countries as far as practicable.

For some destined for the UK, this could mean getting a seat on the outgoing charted BA flight, while for others it could be in-transit via the UK to their home destinations.

He advised that this is why it's important for residents to adhere to the various protocols and advisories to maintain social distance, stay at home unless necessary to be out, and to be extremely careful when handling items including goods being delivered.

Hon. Premier Alden McLaughlin said although he was not surprised by the increased figures they nevertheless put Cayman a very dangerous position.

He again urged that people stay at home to reduce the risk of themselves becoming infected and subsequently spreading the virus in their homes and in the community.

Noting that cases were reported "from east to west" across the territory, Premier said it was an indication of more

cases emerging in areas and households throughout the territory.

However, he noted that while the numbers of positive test results were small comparatively, it indicated the strong likelihood of more positive tests coming through.

Mr McLaughlin said it was therefore paramount that people "stay at home to reduce the risk of putting themselves and the community at risk."

Regarding the 'Stay Home Cayman' drive, Police Commissioner Derek Byrne indicated that he would be recommend-

ing that the overnight 7pm to 5am hard curfew be extended beyond this Friday when it's due to expire.

The Hon. Minister of Health Dwayne Seymour said with the number of confirmed cases on the rise, it was even more vital for people to stick to the protocols and stay at home unless they had acceptable reasons to be out.



In drawing a comparison with other countries to suggest that while the numbers in Cayman while concerning, might not be alarming, he noted:

"In some places there are more deaths than negatives, and in some others, they are reporting more positives than negatives."

With 22 positive results reported in Cayman to date, there has only been one death and 228 negative results from 251 tests - but still cause for concern as emphasised by Mr Seymour and the other officials.

A homemade mask making initiative has been launched in Cayman in response to the COVID-19 pandemic, CayMask.com.

Launched by Massive Media, and following similar programmes that first started in Europe, CayMask provides instructions for how to create, use and sanitise your homemade mask, and includes a Facebook community for people to share or request homemade masks as needed.

In the 30th March daily government press conference, Dr Lee expressed support for all residents to wear homemade masks when leaving their residence as a way of reducing the risk of transmission of the disease:

"There is no doubt, if everybody was to wear masks then it would protect the community more than it currently is. For the reason that, although when you wear a mask you're not protecting vourself, if you're stopping the droplets spreading from you to another person, if everybody is wearing a mask then you are generally stopping the virus travelling around."

As well as creating your own mask, CayMask is encouraging people to create extra masks for others in the community, especially those who are most vulnerable:

"We really hope people will help each other with this initiative, there are elderly isolated and other vulnerable groups who will need masks to be made for them, and people can use the CayMask Facebook Group to help connect the makers with those people," stated Rich Dyer of Massive Media. "Our Czech team have seen directly the impact this has had in reducing infection rates in Europe, and we are eager to get this initiative going in Cayman ASAP."

People are encouraged to mark any posts with the #caymask hashtag, so people can connect easily to share/ request masks, as well as showing people how you have made your own locally.

The website sums up with an important message to remind people that "My mask protects you, your mask protects me".



Cayman Islands **Soft Curfew Guide**



How the Soft Curfew Works


The soft curfew during the daytime, introduced on Saturday, 28th March 2020, allows the population limited movement to conduct essential tasks and builds on previous meeting bans enacted by Government under the Public Health Law (2002 Revision). A still ongoing, hard curfew at nighttime that requires closure of all but essential businesses is enacted under the Police Law (2017 Revision).

01 | What is Soft Curfew or "Shelter in Place"

During this daytime curfew persons are still expected to remain in their place of residence, inclusive of their yard space.

Exceptions





Essential Outings

Any person may leave their homes but only to engage in essential travel to the following public places:

- » health care facilities;
- » supermarkets;
- » convenience stores and minimarts;
- » pharmacies;
- » retail banks, building societies and credit unions;
- » gas or refilling stations, to refuel a motor vehicle.

The above businesses are exempt from soft curfew but will open only between the hours of 6am and 6pm. Retail banks, building societies and credit unions will open only between the hours of **9am** and **1pm**.

The numbers of customers allowed inside a place of business at any one time, should be managed to allow each customer to distance themselves at least **six feet** or **two metres** from any other person.

In fact each person in a public place must maintain a distance of at least six feet or two metres from another person.

Convenience stores and minimarts are also subject to a further restriction of having no more than six customers inside at any time.

Exercise

People may also engage in outdoor exercise, which includes walking their pet. This may be done alone or together with a family member living at the same residence, for no more than an hour-and-a-half each day, between the hours of 6am and 6pm.

At such times persons must also maintain a distance of at least ${f six}$ **feet** or **two metres** from any another person. Exercise **must not** be carried out in a public pool, a public gym, around or in a strata pool

Dangerous Situations

Persons who are required to leave their place of residence because they are at risk of injury or risk of death, are exempt from the shelter in place provisions.

02 | Who is essential?

Persons considered to be **essential staff** are exempt from the shelter in place requirements **but only** when carrying out official or employment related duties. They may also move during hard curfew when carrying out official or employment related duties.

This includes but is not limited to:

- Police officers
- CBC officers
- Fire officers
- Prison officers
- DCFS child protection and residential care workers
- Sanitation and waste workers
- Staff within a health care facility
- Persons delivering emergency medical services;
- Essential officers of any water, electricity or other utilities sector. This includes the provision of electronic communications, including print and electronic media.
- Persons employed to physically deliver water or cooking gas to premises;
- Persons who provide care to other persons with a disability, or who are otherwise vulnerable persons;
- Non-profit organisations and persons that engage in the preparation and delivery of food and supplies to persons with disabilities, or to persons who are vulnerable persons, subject to approval by the **Ministry of International Trade** via **curfewtime@gov.ky**,
- Taxi-drivers, on condition that there are **no more than two passengers** in the taxi at any one time;
- Persons involved in agriculture and food production;
- Persons engaged in the provision of emergency veterinary services;
- Persons engaged in the exercise of Cabinet, parliamentary or judicial duties;
- Persons providing services connected with the loading and unloading of cargo ships and with the storage and delivery of goods;
- Persons employed by a business licensed to provide security guard services;
- Persons employed by restaurants to provide food delivery services, until no later than 9pm; persons employed by businesses other than restaurants to provide food or grocery delivery services, until no later than 9pm;
- Persons who travel to restaurants, which provide **drive-through** or **curb side collection** of food, until no later than **6pm** and;
- Civil servants, as designated by the Chief Officer of the Portfolio of the Civil Service, for the purposes of performing their employment duties;

Persons with questions about which businesses and personnel are deemed essential, and may be exempted from the shelter in place provisions, should contact **curfewtime@gov.ky**.

03 | Closure of Non-essential Workplaces

To facilitate **hard and soft curfew conditions**, all non-essential establishments, institutions, businesses, organisations and offices have been closed.

Businesses may require employees to \boldsymbol{work} $\boldsymbol{remotely}$ from home.

All persons employed within the public service, unless specifically designated as essential workers, shall work remotely from home.

04 | Other Bans and Closures

The following activities are **banned at all times** whether during hard or soft curfew:

- Private parties that include any person outside the immediate household;
- The business of a restaurant, except only drive-through services, delivery of food or curb side collection of food;
- Visiting or permiting entry to any person to
 - » A private strata pool, strata gym or playground;
- Works of construction of any sort, apart from urgent home plumbing, electrical or roof repairs;
- Offer for hire or seek to travel on
 - » a boat, sailing inter-island, except for transport of freight;
 - » inter-island private commercial sea transport that is non-essential;
- Hosting or attending a wedding, which hosts ten or more persons other than the bride, bridegroom, official witnesses and the marriage officer;
- Hosting or attending a funeral, except ten members of the immediate family, six pallbearers, at least one officiant and essential mortuary staff.

The following categories of **public meetings** and **gatherings** are also **banned at all times**:


- Leisure, recreational or spiritual activities including those organised by:
- » service clubs,
- » faith-based organisations,
- » community organisations,
- » civic organisations and
- » business organisations;
- Parades, and social activities related to such parades, including stage shows and parties;
- Sporting events;
- Concerts;
- Conventions;Conferences;
- Graduations; and
- Fundraisers

05 | **Penalties**

A person who, without lawful authority, remains in a place other than the confines of their own residence or yard space, inclusive of the person's yard space, commits an offence and is liable on conviction to a fine of one thousand dollars and to imprisonment for six months.

Any other breach of the terms of the soft curfew is liable to a similar fine. $% \label{eq:linear_problem}$

Violations of the hard curfew fall under the Police Law and persons are liable on conviction to a fine of three thousand dollars and to imprisonment for twelve months.

Those who qualify can apply by downloading the Non-Caymanian COV-ID-19 Support application form. Alternatively, forms can be collected from various supermarkets and gas stations in Grand Cayman and Cayman Brac.

Completed forms should be emailed to CIGCOVIDSupport@gov.ky or left in the drop box outside the Customs and Border Control Offices (formerly the CI Immigration Headquarters) on Elgin Avenue.

Issued by the Ministry of Community Affairs, the voucher will provide in-

terim support over a two-week period to those who qualify until the airport reopens and/or they can resume their jobs

In addition, the Ministry is strongly encouraging everyone in the community to continue to support one another, Caymanian and non-Caymanian alike.

Employers should continue assisting employees and similarly, residential landlords are asked to be flexible with their tenants, including using security deposits in lieu of rent if necessary.

Exemption letters to be issued to facilitate cargo clearance and collection

The Port Authority wishes to advise the public that due to space limitations it will issue an exemption letter to allow persons that have imported cargo to clear and collect their goods.

The exemption letter will be for a specified date and time and is valid only for the collection of cargo.

To request an exemption letter persons that have imported goods are asked

to call the Port Authority Billing Office on 949 2055 or 914 3789 or 914 3786 or email exemptions@caymanport.ky

The Port Authority further advises that social distancing must be practiced at all times when collecting cargo, which means keeping at least 6ft or 2 metres away from other people.

Ministry Engages Virtually With Financial Services Industry

As part of its business continuity plans during the coronavirus (COVID-19) pandemic, the Ministry of Financial Services held a virtual meeting with heads and delegates of financial services industry associations in the Cayman Islands on Tuesday, 31 March.

The Ministry facilitated a panel discussion with representatives from the Department for Financial Services Policy and Legislation, the Registrar of Companies, the Department for International Tax Cooperation, and Cayman's financial services regulator, the Cayman Islands Monetary Authority (CIMA), all providing departmental updates and other updates on their specific areas of expertise.

'The Government appreciates how important the financial services sector is to the Cayman Islands. We felt it was a good time to engage directly with industry associations to remind them of the work that the Ministry and related departments are doing presently, and to hear any feedback or concerns industry may have at this time. This regular dialogue, which is in keeping with the Ministry's programme of quarterly industry updates, will help to assist the Government with our short, medium, and long-

term planning in the face of this pandemic', Financial Services Minister Tara Rivers said.

'Ultimately, we have the same goal in mind: which is to work together to support the local financial services industry that employs thousands of Caymanians and residents; to maintain clients' confidence; to attract new business; and to ensure that the Cayman Islands continues to be a leading global financial centre, which benefits our people locally by providing jobs and incomes, during these unprecedented times and well into the future', she said.

Presentations were made on the various Ministry-related business continuity plans, as well as those in place by other areas of the Cayman Islands Government that directly affect the financial services industry; along with updates on the local and international engagement efforts.

Over 15 associations made representations on the economic impact of COVID-19 on their members' businesses. Association representatives expressed their appreciation, and were encouraged to inform their membership of Government's efforts to date. The Ministry will continue to work with

industry to formulate further opportunities for dialog between the public and private sector.

The Government has already undertaken a number of measures to help the financial services industry address administrative challenges such as extending the deadline for industry feedback on ongoing consultations, deferring annual fees and filing deadlines, and ex-

tending the Economic Substance Notification filings.

New shopping rules to keep us safe

The task of keeping the country fed during this COVID-19 crisis falls largely on the shoulders of Cayman's three main supermarkets: Hurley's, Foster's and Kirk Market. Each one is doing their part to ensure that shoppers can buy necessities in a safe and orderly fashion while maintaining the required 6-foot distance from other shoppers and staff to stop the spread of the COVID-19 corona virus.

New store hours

As from Tuesday last week, Foster's store hours changed to 6am to 6pm Monday to Saturday and, for the first time since Hurricane Ivan, they will be opening on Sunday, from 9am to 5pm (with the exception of Foster's Morritt's Express at East End, which will remain closed Sunday). The change in stores hours was to abide by the Government's 7pm to 5am curfew restrictions. In addition, Foster's Pharmacy will be open from 6am to 6pm, Monday to Saturday and 9am to 5pm on Sunday; their delis will be open from 6am to 5pm Monday to Saturday and 9am to 4pm on Sunday, and their Western Union branches will

be open from 7am to 4pm, Monday to Saturday, but closed on Sunday.

Foster's also implemented a dedicated shopping hour from 6am to 7am at their stores for the elderly, infirm and pregnant.

To comply with the new mandatory curfew hours set by the Government, Kirk Market has also changed operational store hours to 7am to 6pm, while their pharmacy is open 9am to 5pm.

Hurley's store hours are also now Monday to Saturday 7am to 6pm. They have also implemented special shopping hours for the elderly, disabled and vulnerable customers, as well as HSA employees, social workers, and first responders. Dedicated hours solely for these people are Tuesday, Thursday and Saturday, 7am to 9am. At Hurley's, the elderly and vulnerable will be given a face mask when they enter the store and they ask that HSA employees, social workers and first responders provide ID upon entry.

Home delivery

Online delivery is the best way to shop to ensure social distancing. Hurley's was the first supermarket to introduce on-

line delivery and there is no lower limit on the amount of groceries you can purchase. Delivery charges are either CI\$20, CI\$40 or CI\$80, depending on customers' location on Grand Cayman. They also provide a 'Click and Collect' service, whereby customers order online and then drive to the store to collect the shopping that has already been bagged and ready to be collected.

Kirk Market has just launched its delivery service. Minimum order is CI\$75 and delivery charges depend on your location on Grand Cayman, ranging from CI\$14.95 to CI\$24.95. They deliver Monday to Saturday, from 8am to 5pm, offering customers the chance to choose a delivery window of two hours.

CICSA Co-op Credit Union to Organize Branch Visits by Surname

On Wednesday, 1 April, the Credit Union will implement a new procedure to manage queues during current limited branch hours. This is to comply with the government's latest announcement regarding crowding at banks and other essential businesses.

Members will be able to visit both the Grand Cayman and Cayman Brac branches on certain days based on surname. For the week of 31 March - 3 April, the procedure will be as follows:

- Tuesday, 31 March: Members with all surnames
 - • Wednesday, 1 April: Surnames starting with A – K
 - Thursday, 2 April: Surnames starting with L Z
 - Friday, 3 April: Members with all surnames
 Credit Union branch visitation based on surname vill continue afterwards Monday Friday the week af-

will continue afterwards Monday - Friday the week after, starting 6 April, for the duration of the "shelter-in-place" order.

- \bullet Mondays & Wednesdays: Those Members with surnames starting with A K
- \bullet Tuesdays & Thursdays: Those Members with surnames starting with L Z
- Fridays: Members with all surnames

When Members arrive at the branches, they will be asked to show a valid ID.

This new branch visitation scheme based on surname is in addition to the Credit Union's new, limited daily hours of operation that were implemented on Saturday, 28 March. They are projected to continue until further notice based on the government updates on the COVID-19 crisis. These hours are listed below:

Hours of Operation

Monday-Friday:

- 9AM 10AM: Elderly and immune-compromised ONLY
- 10AM 1PM: General membership

The limited hours of operation and limited staff requires that the Credit Union focus on essential services



only, so Members are asked to carefully consider transactions and only visit the Credit Union for necessary ones like cash withdrawals, deposits (using the ATM when possible) and urgent transactions. For all other inquiries, the Credit Union Member Services and Loans teams are available via email or telephone.

The Credit Union will continue to review the situation and keep Members informed about the effect of COVID-19/Coronavirus on its operations. However, anyone may access the latest updates, including other

important Credit Union news by accessing their website. (cicsa-creditunion.org/news)

In the Cayman Islands, the CICSA Co-operative Credit Union has assisted members for 44 years. It was founded in 1975 by seven Cayman Islands Government Civil Servants and incorporated in 1976 and since, has focused on providing services to members at low fees, encouraging saving and offering competitive loans. It currently has over 14,000 members. CICSA Co-operative Credit Union is also a member of the Cayman Islands Banker's Association.

The Bay Market Cafe at Foster's Camana Bay has now closed its indoor and outdoor dining areas indefinitely but they continue to offer takeout from all food stations and hot food bars, now service-only, with a reduced menu offering. Bay Market Cafe also recently launched online ordering, with pickup and delivery options within Camana Bay available.

New shopping rules

If you have to shop in the store, each supermarket is suggesting that each household should designate one shopper per household to come into the store. They strongly suggest leaving children at home and social distancing of being 6 feet apart from other shoppers and staff is enforced.

At Foster's, each customer will be given a shopping cart to shop with at the door, regardless of the size of their shop to help with social distancing. Reusable bags cannot be used, and will not be allowed in store. The fee for plastic bags will be waived.

Staff are also monitoring and restricting the number of customers within their stores throughout the day.

"We ask that the community remain calm, think rationally and use proper hygiene practices throughout the day. We recommend designating one shopper per household to reduce the number of people in store and avoid doubling up on items. When in store, maintain safe social distancing (3 to 6 feet), use a debit or credit card to pay when possible, and sanitise your hands and the shopping cart or basket handles when entering the store," the Foster's team asked.

Hurley's have implemented set procedures so that aisles are now one way. They urge customers to take note of the directional arrows on the floor as this will assist in ensuring all shoppers and staff remain 6 feet apart at all times. They ask shoppers to come prepared, know what you need to buy as you won't be able to turn back around for items you may have missed. They also say to be aware of floor markers indicating where shoppers can stand when waiting to be served.

Product limits

Foster's Supermarket, Priced Right, Kirk Market, and Hurley's Marketplace all joined forces to address the effects COVID-19 has had on the production and supply of products, implementing strict rules on what people can buy across all their stores. These include a two-product limit per customer on the entire grocery, frozen, and health and beauty care department items. The meat, seafood, produce, dairy, deli and bakery departments will remain limit free.

As an example, a customer can purchase two Quaker Instant Oatmeal Original Flavor, two Quaker Instant Oatmeal Variety Packs, and two Tombstone Frozen Pizzas at the same time. All Foster's Supermarket, Hurley's Marketplace, Kirk Market, and Priced Right locations will implement the above limits.

The supermarkets say that while this limit may seem like it could be cause for panic, it's not. Shipments are still coming in multiple times a week and the supermarkets are still sourcing product from any quality source they can.

"We've come together to help ensure product is available for as many people as possible during this uncertain time. Putting the product limits in place stops panic buying and should keep products on the shelf longer. In speaking with our suppliers, we will continue to get product and shipping lines continue to say that the ships will sail," they confirmed.


Shopper Daniel Terry went to Kirk Market on the Tuesday that the new measures had been implemented at the store, following the Government's 7pm to 5am curfew.

"I would say that people were cautiously tense," he said. "I went mid-afternoon and the staff had customers queuing up around the outside of the building to ensure that everyone observed the social distancing rules. Once inside, there were announcements to remind shoppers to stay six feet apart."

Mr Terry also shopped at Cost U Less and Priced Right on the following Wednesday and observed that Priced Right had implemented one-way shopping aisles.

"I got to Priced Right just before the opening at 6am and there were already people queuing in an orderly fashion to enter, 6 feet apart. They allowed the elderly, infirm and pregnant to enter first, but we only had to wait about 20 to 30 minutes before we were allowed to enter and shop," he advised. "We were sprayed with hand sanitiser upon entry and encouraged to wipe down the cart handle."

"I think people just need to realise that this is the new way of life: sanitise and sterilise everything you touch," he said. "People should not fear the changes, just take the necessary precautions and keep your distance from others."

Canada's spy agency is moving quietly ahead with plans to collect and use databases containing personal information about its citizens.

The Canadian Security Intelligence Service says the initiative - made possible by sweeping security legislation passed last year - will enable the agency to crunch large volumes of information and detect previously unseen patterns. However, the new power to

gather, sift and keep Canadian datasets worries civil liberties advocates.

The government should give Canadians a better sense of the kind of information CSIS is now allowed to exploit, given the existing dangers of falsely identifying people as security threats, said Tim McSorley, national co-ordinator of the Ottawa-based International Civil Liberties Monitoring Group.

"It would help to ensure that Canadians' rights are being protected," McSorley said. He also questioned whether

"we want to be moving in this direction of intelligence agencies collecting and retaining vast amounts of information?"

Memos disclosed to The Canadian Press under the Access to Information Act show CSIS set the process in motion last July with a request to Ralph Goodale, public safety minister at the time. The spy service asked Goodale to approve proposed classes of Canadian datasets, a step intended to ensure accountability for the data program.

Philippines exports avocados to China

The Philippines is getting an unexpected new agricultural contract from China, avocados.

The first batch of avocados imported from the Philippines weighing 7,656kg arrived at the Waigaoqiao Port in Pudong New Area of Shanghai on Monday.

According to the Shanghai Customs, the Philippines is the first Asian country to export avocados to China, which marks the successful practice of bilat-

eral agricultural cooperation under the Belt and Road Initiative.

The customs had established green channels for faster inspection of the imported avocados, which will also undergo lab detection for heavy metals and pesticide residues.

All plantations and packinghouses in the Philippines planning to export avocados to China must get approval from both the Philippines' Department

of Agriculture and the Chinese General Administration of Customs.

The plantations should also carry out standard agricultural practices ensuring the quality and traceability of the fruit, according to relevant inspection requirements in China.

Measures will be taken to streamline the quarantine procedures, helping the avocados to meet Chinese customers as soon as possible.

Hondurans get food home food deliveries

Armed Honduran soldiers began delivering food to some 3.2 million people on lockdown in their homes last Wednesday, part of the government's efforts to stop the spread of coronavirus in a nation with few resources and a limited public health system.

So far, Honduras has reported 36 cases of the virus

and no deaths. To prevent the virus from spreading, President Juan Orlando Hernandez has suspended public transportation, closed government offices and businesses, and ordered people nationwide to stay indoors at all hours. "We are doing everything in our power to save lives. This includes making sure the most vulnerable have food at home on their tables," Hernandez said on national television.

The distribution of beans, rice, sugar, butter, cornmeal and spaghetti along with soap, detergent and hand-sanitizer for 6,000 families began in the impoverished Los Pinos neighbourhood in the capital of Tegucigalpa. The army will gradually bring supplies to 800,000 families in San Pedro Sula, La Ceiba and Choluteca, some of Honduras' biggest cities, each of which have reported cases of coronavirus.

Last Tuesday, residents in various parts of Tegucigalpa protested on the streets to demand food, saying they were unable to work or shop for groceries because of the lockdown.

In Los Pinos, which is controlled by the violent Barrio 18 gang, uniformed soldiers in bulletproof vests and carrying M-16 rifles arrived in army trucks with supplies meant to last 15 days per family and went on foot through steep narrow streets to deliver packages.

"We are going to go door to door. We want whoever needs it, who doesn't have money, to have this food package, while this difficult situation lasts," Hernandez said.

Many other families were left without aid, however, spurring further protests in various parts of the country, with residents blocking a road for several hours outside Tegucigalpa and demanding supplies.

Venezuelan leaders asked to step down

Venezuela's president and political opponent have been asked to stand down by the United States administration.

The US has proposed a political transition plan for Venezuela, offering to lift sanctions if the president, Nicolás Maduro, and his opponent, Juan Guaidó, step aside and pass power to an interim government made up of their supporters.

Under the 'democratic transition framework', all political prisoners would be released, and all foreign – principally Cuban – forces would leave. A five-member council of state would be selected, with two members chosen by the opposition, two by Maduro's Socialist party, and the fifth member picked by the other four. The military high command would remain in place.

"The hope is that this set-up promotes the selection of people who are very broadly respected and known as people who can work with the other side," the US special representative for Venezuela, Elliott Abrams, said.

The US and European Union would then lift sanctions on the current leadership. Broader sanctions on the country's oil business would be lifted after all foreign forces had left the country. All sanctions would be lifted after free elections, to be held within six to 12 months.

The proposal comes a week after the US indicted Maduro and top members of his government and army for drug trafficking and money laundering, and as Venezuela faces blanket sanctions, a collapse in the price of oil, its main export, and the coronavirus pandemic, with a crippled health system.

"The United States has long been committed to finding a solution to the manmade crisis in Venezuela," the US secretary of state, Mike Pompeo, said. "The urgency for this has become all the more serious in light of the Maduro regime's failure to adequately prepare for and address the global Covid-19 pandemic. This framework demonstrates our commitment to helping Venezuela fully recover and ensures that the voice of the Venezuelan people is respected and included."

At press time both leaders had not yet responded.

Cuban Americans want US sanctions lifted

Cubans living in America are campaigning for the Trump administration to lift sanctions on Cuba because of the coronavirus epidemic.

The Cuba Solidarity Network in the United States is demanding an end to the economic blockade against the Caribbean island in a statement published on local media.

The communiqué acknowledges Cuba's medical work to fight COV-

ID-19 by sending thousands of health professionals to countries in Europe, Asia, Latin America and the Caribbean.

However, the US response has been more than shameful and irresponsible, says the declaration, regarding the US Department of State's warning on those who request assistance from Cuba.

According to the Department of State, Cuba offers those medical missions 'to recover the money it lost when the countries stopped participating in that

abusive program'.

However, the Solidarity Network is outraged by this characterisation of Cu-

ba's medical solidarity. "Cubans were in Haiti after the earthquake, in Africa fighting Ebola, they even offered their help to the US victims of Hurricane Katrina," the document stresses.

Cuba's medical solidarity is a pillar of its society and is based on the concept of health care as a human right, in contrast to the US, where 27 million people have no medical insurance and they cannot have a sick leave.

"These are times of solidarity, not blockades," stresses the document, signed by 40 US organisations that make up the Cuba Solidarity Network.

London mayor appeals to soccer clubs

The mayor of London has written to each of the capital's Premier League clubs to ask for doctors and medical staff to join the National Health Service's fight against coronavirus.

Sadiq Khan sent a letter last week requesting support. In a historic move, the mayor asked for three different are-

as of help. He wants doctors, physios and other clinically trained staff to assist the NHS as they continue to deal with the pandemic, which has hit London harder than any area of the country.

He also asked for key equipment from training grounds which will then be used at many field hospitals which are being set up across the capital. The equipment requested features mobile catering facilities such as food heaters and refrigerators, which could prove invaluable.

Khan closed his plea by asking clubs to assist in providing accommodation

for NHS workers while the struggle continues.

Sources have said that there is a keen desire among the clubs to assist. Each of those in the top tier has a trained doctor for each of its teams. They may well send academy doctors, while retaining a first team doctor should the Premier League restart over the coming weeks. Khan has also written a similar request to London's Championship sides.

The mayor did not write to Tottenham as they are already heavily involved in the process and sources said they will instead receive a 'thank you' letter.

Tokyo Olympics sets new date

The Tokyo Olympic Games has got a new date; 23 July 2021 to run to 8 August after being postponed for a year because of the coronavirus pandemic.

The International Olympic Committee's executive board announced the decision on Monday. The Olympics will still be called Tokyo 2020 despite taking place in 2021. The Paralympic Games will now run between 24 Aug. and 5 Sept. 2021.

IOC president Thomas Bach said: "I am confident that, working together with the Tokyo 2020 Organising Committee, the Tokyo Metropolitan Government, the Japanese Government and all our stakeholders, we can master this unprecedented challenge.

"Humankind currently finds itself in a dark tunnel. These Olympic Games Tokyo 2020 can be a light at the end of this tunnel."

The decision to postpone both events was taken to protect the health of the athletes and everyone involved, and to support the containment of the Covid-19 virus.

The response from Olympians of the new date was a positive one.

Olympic champion swimmer Katinka Hosszu posted a photo of herself smiling, saying as an athlete she felt "lucky ... in this unlucky situation" to now know the dates of the Games and have a full year to prepare.

American BMX racer and Olympic silver medallist Alise Post-Willoughby was among the first to react, posting a smiling emoji on social media while sending "smiles and gratitude" to her sponsors and family.

The new dates also took into consideration the rest of the global sports calendar after the men's football European Championship was postponed to summer 2021. The World Athletics Championships,

originally set to take place in Oregon, USA, this August is postponed until

If that is moved back exactly a year it would clash with the Commonwealth Games in Birmingham.

A summer 2021 Games also had the backing of the US broadcaster NBC, whose rights fees make up more of the IOC's income than any other body. The move also frees up the top NBA, football and golf players to compete.



But a July date means that the Olympics will take place during the hottest time of the Japanese summer - a longstanding worry that has already led to the Olympic marathon being moved to Sapporo in the north of the country. It was these concerns that led to some sports, including swimming, equestrianism and triathlon to moot a "Cherry Blossom" Games in the spring of 2021 instead.

It is the first time in the Olympic Games' 124-year modern history that they have been delayed, though they were cancelled altogether in 1916 because of World War One and again in 1940 and 1944 for World War Two. Cold War boycotts affected the summer Games in Moscow and Los Angeles in 1980 and 1984 respectively.

NBA draft may be delayed

The 2020 NBA Draft, initially scheduled for June 25 at the Barclays Center in Brooklyn, could be pushed back to August or September. The draft always comes after a completed season, but scheduling is impossible under the circumstances of the coronavirus pandemic.

Nevertheless, the league is hopeful that it will be able to finish out the season. Logistically, the draft must occur after the postseason has completed so that teams can participate in potential draft-day deals.

The NBA season has been indefinitely suspended since March 11 when Utah Jazz center Rudy Gobert tested positive for COVID-19, followed by a plethora of other players and NBA figures from across the league's landscape, including New York Knicks owner James Dolan. Despite the current high level of uncertainty surrounding the season, however, NBA commissioner Adam Silver is optimistic that it can still be salvaged, to an extent.

"I'm optimistic by nature, and I want to believe we're gonna be able to salvage at least some portion of the season," Silver said two weeks ago. "Again, I'd say we've done new and creative things in the past, we experimented with this year's All-Star Game with a unique ending, we've talked about play-in tournaments for going into the playoffs, there may be other things we can do with the format. I know I've heard from a lot of our players. They're going stir crazy, they want to play, they want to compete. We're gonna try by every means we can to play basketball again, but the safety and health of our players and fans is first."

In April, the WNBA is holding a virtual draft without players, guests and media members in attendance.







Coronavirus – Self-Isolating

Do

- Stay at home
- Try not to be in the same room as other people at the same time
- Only allow people who live with you to stay
- Stay in a well-ventilated room
- Ideally, keep two weeks of food, drink, medication and cleaning supplies at home
- Ask friends, family members or delivery services to carry out errandsfor your such as getting groceries, medicines or other shopping
- Make sure you tell delivery drivers to leave items outside for collection
- Clean toilets and bathrooms regularly
- Think about a bathroom rota if a separate bathroom is not available, with the isolated person using the facilities last, before thoroughly cleaning the bathroom themselves
- Use separate sheets and towels from anyone else in the household and launder at the hottest temperature possible for the material
- Wash crockery and utensils thoroughly with soap and water. Dishwashers may be used to clean crokery and cutlery
- Stay away from your pets if unavoidable, wash your hands before and after contact

Do Not

- Invite visitors to your home or allow visitors to enter
- Go to work, school or public areas
- Use public transport or taxis
- Do not share dishes, drinking glasses, cups, eatingutensils, towels, bedding or other items with other people in your home
