165,000 Test Kits arrive



The highly anticipated shipment of 135,000 COVID – 19 testing kits ordered by Government from South Korea arrived on Wednesday. It's the first consignment of an order for 200,000 units.

The remaining 35,000 are on their way to Cayman from the South Korean

suppliers via London due to capacity constraints on the charted aircraft.

Those are expected here at a later date via commercial transportation.

A government statement on Wednesday disclosed the cost of the order to be US\$4.4 million averaging around US\$22 per kit.

The hard-to-obtain kits were sourced through the joint efforts of the Office of His Excellency the Governor Martyn Roper, the British Embassy in the South Korean capital Seoul, and the Cayman Islands Government.

FIRST PHASE OF BUSINESS RELIEF MEASURES ANNOUNCED

Small and medium-sized businesses in Cayman are to get a respite from the pressures brought on by the COV-ID-19 crisis.

Minister for Commerce, Hon. Joey Hew has outlined the initial measures on Monday in what he said was the first tranche of the Government's offer.

The package consists of a low-interest loan programme, grants for small and micro-enterprises along with technical assistance and training.

The Government has set aside a total of \$KY 14.5 million for this first phase of its COVID-19 small and micro-business support programme.

In making the announcement, Min. Hew said Government has been mindful of the challenges facing the busines

challenges facing the business sector particularly the smaller enterprises resulting from the COVID-10 outbreak.

"Right here across our Islands, we see economic activities in major sectors have come to a halt. And, there is no doubt that business and commerce

RCIPS Warns of Potential Cybercrime Scheme Using Malicious USB Devices, 6 April

The RCIPS is informing the public, particularly IT managers and business users, of a notice being circulated by INTERPOL regarding a new cybercrime scheme targeting businesses in the Executive Management, Information Technology, and Human Resourc-

The scheme involves mailing USB devices to the targeted businesses, contained in packages which usually include gift cards or toys. When one of these USB devices is connected to a company computer, the device gathers system information, gains administrator privileges, and then forwards the information to a remote server. A fake message box is often displayed during this process, warning of errors on the thumb drive.

Although there is currently no evidence of such devices being received



in Cayman, all persons are advised to be aware of the potential dangers of connecting USB devices from unknown sources to your system.

Anyone who believes they may have fallen victim to this or a similar scheme, is advised to contact and report the matter to RCIPS.



HSA and Cancer Registry observe National Cancer Registrars Week

The Health Services Authority and the Cayman Islands Cancer Registry join communities and medical professionals across the world to observe Cancer Registrars Week, April 6-10, 2020 and recognise the country's progression in voluntary cancer registra-

This year's theme '2020 Vision for the Future' reflects the critical role cancer registrars play in capturing data that informs cancer prevention and screening programs, treatment, and re-

"Understanding cancer data is the key to the nations fight against cancer. By collecting and analyzing cancer data we can better plan healthcare infrastructure, clinical services and other support systems" Amanda Nicholson, the Cayman Islands Cancer Registrar.

"Within our community, National Cancer Registrars Week isn't just about cancer registrars. It's also about recognising everyone involved with cancer surveillance and prevention. We rely strongly on our partner organisations, the nurses and doctors at our local hospitals, and most importantly, cancer survivors themselves. Cancer prevention efforts in Cayman come from a large network of people and organizations within our community."

The Cayman Islands Cancer Registry is a population-based health registry that relies on persons to volunteer the information as it is not mandatory in the Cayman Islands. The registry is unique in its cancer surveillance which captures data on a diverse and multicultural population in the Cayman Islands. The registry was developed to better understand what cancer trends look like within the Cayman Islands, thereby making it possible to do more in terms of prevention.



"From the data collected we can start to see some emerging trends taking shape. In 2019 the most reported cancers for males included prostate cancer, cancers of the blood and lung cancer respectively. For women the most reported cancers were breast cancer, colon cancer and ovarian cancer. Breast cancer remains the most reported cancer to the registry over-

Approximately 68% of registrants for 2019 were female and 32% male. Most cases in the registry for last year were reported by registrants within the first 6 months of receiving a diagnosis.

The Cayman Islands Cancer Registry is calling for cancer patients & survivors to register and complete the online data collection form. All information included in the registry is confidential and anonymous as the registry uses a digital numbering method, database designed by the World Health Organisation (WHO) and customised to fit the needs of Cayman's unique community.

HUGE SHIPMENT OF COVID-19 TEST KITS ARRIVE

Governor Roper said: "Moving consignments around the world is proving extremely difficult at the moment, so I'm pleased we've been able to get these test kits here in such a short space of time."

He added that "This consignment will enable our health professionals and front line workers, and large numbers of the public to be tested.

"This is a huge step in keeping on track with the containment part of our strategy. I would like to pay particular tribute the private sector collaborators we worked with."

Premier Alden McLaughlin, in adding his thanks to those all involved in this operation, remarked: "I know how challenging it was to source, procure and transport a consignment like this from the other side of the world in such challenging times.

"The work and generous donations from the private sector were instrumental."

Mr McLaughlin said, "Cayman is now in a much better place in our ability to ramp up testing and keep everyone safe."

The Government statement noted that "the complex and challenging arrangements for the procurement and consignment were led by the Governor's Office in collaboration with the Cayman Regiment, the Ministry of International Trade, Investment, Aviation and Maritime Affairs, the private sector and the British Embassy in Seoul who undertook due diligence to assure the quality of the testing kits and helped with local logistics."

In giving credit to those who were instrumental in sourcing and shipping the consignment, it also listed local businessmen Mr Vernie Coe and Mr Craig Merren who provided the initial contacts for the suppliers.

The logistics were supported by the Dart Corporation who arranged and funded the aircraft charter to fly the consignment from Seoul via Anchorage to the Cayman Islands.

A government stated said; "In an incredibly generous gesture, local philanthropist Mrs Susan Anne Olde OBE donated half of the amount for the purchase."

Noting that, Governor Roper said, "The generous donation from Mrs Olde and the financing of the aircraft by Dart demonstrate the real strength that we can bring to this fight when we combine government and private sector resources and expertise."

It was the Government's Chief Officer of the Ministry of International Trade, Investment, Aviation and Maritime Affairs, Eric Bush who broke the news on Wednesday morning of the arrival of the shipment of test kits earlier on Wednesday.

He had sent out a Tweet declaring: "Cayman has received enough COVID-19 testing kits to test the population more than twice!"

He called it "Another part of the collective and collaborative response to protect our people. Public and private sectors working hand in hand."

The shipment is expected to significantly upscale the volume of testing in Cayman for the coronavirus.

Chief Medical Officer Dr John Lee said testing was expected to go from around 150 tests per day to around 500 per day possibly over the next ten days.

Testing is also expected to be enhanced and coordinated across the three hospitals in the territory.

Government is also in the process of sourcing a further shipment of medical supplies, this time from China, especially linked to managing the COVID-19 crisis.

Meanwhile, it has been confirmed that a shipment of ventilators and masks sourced from the United States were intercepted by US customs officials on the basis that they the shipment violated US trade restrictions under the current COVID-19 protocols. ③

Other notable languages used by the Health Minister include Spanish, Russian, Arabic, French and Tagalog (Philippines).

Musicians in Cayman also have the opportunity to win CI\$1200 in separate categories, for creating an extraordinary jingle about the Covid-19 scenario; an initiative spearheaded by the Health and Culture Ministry to give performing artist - who are out of work - an opportunity to bring in some much needed income.

British Airways Flight Arrives in Grand Cayman

The British Airways flight arrived in Grand Cayman this afternoon. The flight carried vital supplies for the Islands including urgent pharmaceuticals, personal protective equipment and test kits.

The flight returned 58 Caymanian students and other residents to the Island. On arrival the passengers were checked by Public Health and were immediately transferred by bus to a government quarantine facility. They will remain in highly supervised isolation for 14 days, after which they will be tested for Covid-19 before being able to return to their family homes.

Before landing on Grand Cayman the BA flight made a sched-

uled stop in Bermuda allowing 129 Bermudans to return home and for supplies to be delivered to the Overseas Territory.

The plane will also allow for a UK advisory team to travel to the Turks and Caicos Islands, to provide medical, operational and security expertise to local authorities.

The return leg of the flight departs on Tuesday afternoon where 131 people of varying nationalities will leave Cayman for London Heathrow. The flight will make a stop in Nassau where it will collect 44 British Nationals and other European passengers who wish to be repatriated to or via the UK.

Governor Martyn Roper said: "This flight has taken considerable effort to arrange at a time when moving people and consignments around the world is a global challenge. Its arrival has enabled vital supplies to be delivered to Cayman and increases our capacity for testing. It has also allowed many people to return home to both Cayman and Bermuda. The upmost care will be taken to isolate those returning travellers to limit the risk to the population to the absolute minimum. Tomorrow's outbound flight will enable 131 people to return home from Cayman via London Heathrow. I am grateful for the support of the Premier in



allowing this flight to land and to everyone who has been involved in its planning. I would like to thanks Andre Ebanks and his team at the Cayman Islands Government Office in

effects of the pandemic and give these Islands the best chance of recovery," he said.

He said there is ongoing contact with the various stakeholders on how best to alleviate the challenges they are facing in the current economic downturn.

"As part of our efforts to arrest the economic disruption of COVID-19, my ministry will be implementing a number of relief measures to support our micro and small businesses.

"The Government has always been proactive by making it a strategic priority to implement initiatives to support micro and small enterprises across the Islands," Min. Hew added.

The initial approach will be built around a programme of loans and grants with a number of business-support components bolted on.

The loan scheme to be managed by the Cayman Islands Development Bank, will come from a fund of \$KY 5 million and will benefit businesses that are 100% Caymanian-owned.

It will provide each borrower with a fully-backed government guarantee with up to \$KY 50,000 for small businesses and \$KY 20,000 micro-enterpris-

They will also benefit from a sixmonth moratorium during which the bank will not collect principal or interest payments. The loan is repayable over five (5) years at 1% interest in the first year, subject to increase thereafter.

For the grants scheme, \$KY 9 million has been set aside by Cabinet.

The Micro and Small Business Grant Programme targets three thousand vulnerable micro and small businesses and is intended to provide initial assistance of \$1000.00 monthly to selected business for three months.

Mr Hew said, the objectives of this programme will be to provide working capital assistance to micro and small businesses affected by COVID-19 which have enough of a domestic market to render the businesses recoverable.

Government will also assist those businesses which have been heavily

focused on the tourist market and have demonstrated the ability to transition to a larger domestic market.

However, they must demonstrate a willingness and capability to re-purpose and transition into a new post-COVID economic environment.

Eligible businesses must have been operational for at least twelve (12) months prior to March this year.

Training and technical support are also built into the two schemes.

The relief package is seen as the precursor to an anticipated more extensive stimulus programme being developed.

Commerce Minister Hew stated: "In the coming days and weeks, we will continue to engage in discussions with members of the business community and other stakeholders to find interventions to lessen the impact of COVID-19 on your economy and our people."

The Government's has always maintained that its priority is to preserve life

and curtail the spread of the COVID-19 pandemic which is causing huge economic disruption globally.

Min. Hew reminded: "As the Honourable Premier has mentioned on a number of occasions, there are discussions taking place concerning our support for the business sector and economy.

"But as a Government, we will continue to place priority on flattening the curve of new cases so that our Islands can get back on its feet (at least) with domestic activities in the near future."

CIFS Adapt to Support Emergency Services

The closure of borders to international passengers has presented the Cayman Islands Fire Service (CIFS) with the opportunity to further support emergency service colleagues.

CIFS firefighters have been redeployed following a reduced demand for dedicated on-duty aviation cover at the Owen Roberts International Airport. As Chief Fire Officer, Paul Walker QFSM explains, "Working with colleagues from the Cayman Islands Airport Authority and the Civil Aviation Authority, we have been able to adapt our aviation crewing arrangements while maintaining appropriate fire and rescue cover

for the reduced number of flights and aircraft types. Creating this capacity has enabled us to put in place arrangements to provide support to other services should the community spread of coronavirus escalate."

Greater crewing flexibility have allowed CIFS to redeploy certain officers to areas in greater demand, or to reinforce other emergency services agencies should staffing levels be impacted.

Staff from the aviation control room are undertaking 911 call centre familiarisation to ensure this essential service is adequately maintained.

Four CIFS staff are working with the Health Services Authority to join Emergency Medical Service Ambulance shifts if required to bolster support.

A firefighter with prior maritime search and rescue experience has also been redeployed to the Cayman Islands Coastguard to support increased workloads monitoring maritime related hard and soft curfew restrictions.

Chief Walker said, "Colleagues from CIFS have been flexible and supportive, understanding the concept and need for cross service business continuity. Here in the Cayman Islands, we have strong and trusted relationships with our partners from across the emergency services. It is a genuine team approach with a shared focus to maintain our 911 critical services to protect and help residents across the Cayman Islands."

He went on to say, "I would like to encourage all residents to maintain social distancing, adopt good personal hygiene and abide by the soft and hard curfew restrictions. This is the only sure way to protect our elderly and vulnerable, our families, friends and colleagues as well as ourselves from the community spread of this deadly virus. We are working for you. Stay home for us."

Stepping up to the plate

With tourism industry workers feeling the extreme hardship of necessary business closures during the COVID-19 pandemic, The Wharf and Grand Old House restaurants (which are under the same ownership) are currently providing some easing for industry workers in the form of daily meals.

The initiative, started by the restaurants' Operations Manager Luciano di Risi, is called Supporting Each Other and gives tourism workers who have lost their jobs and income a daily meal.

Luciano came up with the slogan which speaks to the heart of this initiative: 'We cannot help everyone but everyone can help someone'.

The restaurants' Guest Relationship manager Dunja Yeap explained how

people can get food: "Tourism industry people severely impacted by closures can email info@wharf.ky for this service, which will operate while funds last. Interested people will receive a questionnaire back which they need to complete so that we can ascertain their eligibility."

Responding to customers and other partners who had contacted the restaurants, asking how they could donate to the cause, the restaurants say people can also use that email and also info@grandoldhouse.com to donate funds.

"We can only operate this service while we have the funding to do so, so we really need everyone who is able to, to donate funds to us directly or donate to the local distributors, such as Progressive, Uncle Clem's and Cayman Distributors on behalf of the programme,"

Dunja advised. "While we would greatly appreciate direct donations of food, we cannot accept fresh produce for hygiene reasons, though if people have canned goods or bags of rice, we should be able to accept those. But it would be far better to donate financially or through the distributors, so we know that food items have been properly stored."

The restaurants' executive chefs Thushara and Christian are both working with a team of volunteers to prepare meals for people every day. The staff wear protective masks and gloves, people keep their distance and queues are well-managed, Dunja said.

"We are currently working on a week by week basis but we are getting increasing numbers of messages from people who are desperate

for food. We cannot feed everyone and have to prioritise those most in need, so we would greatly appreciate donations, however big or small to help us feed people in these desperate times," Dunja stated.



Hosanna-Save us Now from Coronavirus (A brief reflection on Holy Week)


Zachariah 9 St Mathew 21:1-11

The Holy Week begins with the glorious welcome to Jesus in Jerusalem:

"Hosanna" is the resounding expression in the scripture readings and the hymns we sing on Palm Sunday. "The multitude that went before, and that followed, cried, saying, Hosanna to the son of David: Blessed is he that cometh in the name of the Lord; Hosanna in the highest" (Mathew 21:9)

Hosanna means, Save us now, deliver us now, help us now. This happened in fulfillment of the scripture "Rejoice greatly, O daughter of Zion; shout, O daughter of Jerusalem: behold your king comes to you, righteous and victorious, lowly and riding on a donkey, on a colt, the foal of a donkey" (Zachariah

"Jesus the King" was born king, came proclaiming the kingdom of God, preached in sermons and parables about the kingdom of God and demonstrated in acts of healing, restoration and transformation. 


On your plate fill between 4 o'clock and 10 o'clock with these fibrous veggies and greens. This is roughly half of your plate.

Canada fuming as US get its face masks

The tense relationship between Canada and the United States has worsened after a Canadian politician claimed that President Donald Trump has blocked the delivery of three million face masks designed to help fight the coronavirus outbreak.

The premier of Ontario, Canada's largest province made the accusation. Doug Ford told Global News the incident had happened over the weekend and described it as "absolutely un-

acceptable". He also said the province's stock of personal protective equipment would run out in a week.

Allies of the US are complaining about what they call its "Wild West" tactics in outbidding or blocking shipments to buyers who have already signed deals for medical equipment.

Trump has asked manufacturing firm 3M Co to pause the exports of domestically produced respirator masks to Canada and some Latin American countries.

Canada's Prime Minister Justin Trudeau sidestepped reporters' questions about the incident on Monday, saving his government was in productive talks with the US and adding: "We expect those shipments to be delivered."

Canada's Deputy Prime Minister Chrystia Freeland told reporters that Ottawa was aware of "some difficulties" shipping the masks across the border and would do all it could to help.

"We are working intensely with the United States to ensure that all the masks that have been bought can be exported to Canada," she said when asked about Ford's complaint.

"We have had positive conversations and we are continuing to work to settle this matter," she added.

The US embassy in Ottawa was not immediately available for comment. Canada's death toll had risen to over 300 with the number of positive cases over 16,000. 😚

Filipino shot dead over virus curfew

The Philippines is allowing police to shoot dead anyone not adhering to the coronavirus curfew and one man has already lost his life. He was shot dead after he was scolded by a health official for not wearing a face mask.

The 63-year-old flew into a rage after receiving the warning from the health care worker in the town of Nasipit in south Philippines.

He is thought to have been drunk at the time, a police report claimed. The man grabbed a scythe and began threatening officials with it at the coronavirus checkpoint.

'The suspect was cautioned by a village health worker ... for not wearing a face mask," the report said. "But the suspect got angry, uttering provoking words and eventually attacked the personnel using a scythe."

A police officer shot him dead after reportedly trying to calm him.

The death is the first coronavirus related killing to take place in the country after President Rodrigo Duterte warned anyone not following lockdown measures would be shot. In a televised address last week the

controversial leader said it was vital everyone cooperates and follows home quarantine measures.

He also said the abuse of medical workers was a serious crime that would not be tolerated.

Amnesty International condemned the remarks as "deeply alarming" and said they follow reports of inhumane punishments for lawbreakers of the coronavirus lockdown, such as being detained in dog cages and sitting for hours in the sun.

There have been 3,660 confirmed cases of the coronavirus in the Philippines and 414 deaths. 🏵

Cuba using homeopathy for virus recovery

Cuba will shortly begin mass distributing a new medication which it has developed in a homeopathic way to help recovery from coronavirus.

PREVENGOVIR, a homeopathic immunological booster, is being distributed to citizens to help prevent viral infections like Covid-19 and other common flus. Dr Francisco Duran, Director of Epidemiology, announced.

Duran explained PREVENGOVIR was first applied to risk

groups in isolation centres, elderly and mother-infant homes, and hospitals caring for positive and suspected Covid-19 patients.

Homeopathy is a system of alternative medicine created in 1796 by Samuel Hahnemann based on his doctrine of 'the similar cures the similar'. It has

Initial stats show that the booster is helping Covid-19 sufferers to recover quicker, Duran said. 😚

Ex-Honduras president in FIFA bribes dies

A former president of Honduras who was convicted in the FIFA soccer bribery scandal died in the United States on Saturday.

Rafael Callejas governed Honduras from 1990 to 1994, but he was better known for soliciting hundreds of thousands of dollars in bribes in the wide-ranging FIFA soccer scandal over lucrative broadcast rights.

Callejas, 76, pleaded guilty in 2016 and was being held at a prison in Atlanta when he died.

Current Honduran President Juan Orlando Hernandez confirmed Callejas' death, adding on his Twitter account that "we enormously regret" the loss of the former leader. Hernandez said Callejas is survived by his wife, children and grandchildren.

No cause of death was given, but Callejas had reportedly suffered from leukaemia.

After leaving office, Callejas was once a member of FIFA's television and marketing committee.

He pleaded guilty to racketeering conspiracy and wire fraud conspiracy in a New York federal court. He said he distributed a significant portion of his bribes to delegates of the Honduran soccer federation so he could remain its president, a position he held from 2002 to last August.

Callejas said he abused his powerful position in the soccer world to award contracts to Media World, a Miami-based sports marketing company that paid bribes through US bank accounts to the foreign bank accounts of Callejas and a co-conspirator. (?)

Venezuela boat sinks after ramming cruiser

A Venezuelan navy coastal patrol boat sank in the Caribbean after allegedly ramming a cruise ship that it had ordered to change direction.

The owners of the Portuguese-flagged RCGS Resolute said the naval vessel Naiguata also fired shots in an "act of aggression in international waters".

The collision left

the cruise ship, which has a reinforced hull for sailing in icy waters, with only minor damage. Venezuela accused the Resolute of an act of "aggression and piracy".

It also said it "did not rule out" that the cruise ship "was transporting mercenaries to attack military bases in Ven-

President Nicolás Maduro has previously accused the United States and other countries of plotting to overthrow

The incident took place near La Tortuga Island, a Venezuelan federal dependency, on 30 March.

Columbia Cruise Services, which operates the Resolute, said the cruise ship had been carrying out routine engine maintenance in international waters

more than 13 nautical miles (24km) from La Tortuga.

A statement from the Hamburg-based company said that shortly after midnight, the Naiguata radioed the Resolute, questioning its intentions, and ordered the captain to follow it to a port on Isla Margarita, to the east.

Although the Resolute - a purpose-built polar expedition vessel - suffered minor damage, the patrol boat began taking on water after hitting its bulbous bow.

The Resolute remained in the area for more than an hour and contacted rescue co-ordinators on the Dutch Caribbean island of Curaçao. All attempts to contact the Naiguata went unanswered and the Resolute eventually sailed to Willemstad on Curação. 😚

Johnson grateful for NHS care

As the UK Prime Minister Boris Johnson recovers from suffering from symptoms, coronavirus his appreciation of the National Health Service has increased exponentially. Johnson, 55, was in intensive care in St Thomas' Hospital from Monday and is making slow progress. He is grateful not just for the NHS

staff but also for the swathes of volunteers who are helping health workers. Johnson's pregnant fiancée, Carrie Symonds, has also tested positive for coronavirus.

People who volunteered to support the NHS in England during the coronavirus crisis are being sent details of what tasks they can do to help. More than 750,000 people signed up for the "volunteer army" - three times the government's original target - to help relieve pressure on the NHS. They will support 2.5 million people who are considered at risk.

The volunteers may have to deliver food and medicines, drive patients to appointments and phone the isolated.

The process is being managed through a mobile app called GoodSam, where health professionals, pharmacists, and local authorities can upload requests for help.

Thousands of approved volunteers can pick which tasks they want to complete in their local area. Volunteers switch their app to "on duty" to show when they are available.

The Royal Voluntary Service, the charity helping co-ordinate the scheme, have completed checks on the applications.

One of the many to sign up was teacher Stacey Walsh, from Banbury, Oxfordshire, who is still teaching but wants to volunteer in her spare time.

She said: "I've said I'll do whatever's needed. I'm a very social person so being able to provide people who are isolated with support over the telephone - that's something that I really am looking forward to.

"It's really important as public sector workers we stand alongside the NHS. There is a unity between us so I'm really happy that I can help."

COVID-19: Jamaica Government Extends Quarantine for Community Where First Victim Stayed

Prime Minister Andrew Holness has announced that a community that had been quarantined following the first reported death from the novel Coronavirus (COVID-19), will remain under quarantine for another two weeks.

He said residents of Corn Piece Settlement in the southern parish of Clarendon will remain under quarantine for another 14 days, as government tries to contain the spread of COVID-19 in the island.

Jamaica has 58 confirmed cases of COVID-19. The cases include three deaths

The first was that of a 79-year-old man who travelled to Jamaica from New York on March 12. The quarantine of Corn Piece was implemented after members of the elderly man's family, who reside there, refused to comply with the requests of the public health team on the ground to remain at home.

It is believed that the victim stayed in the community during the period of his illness and had contact with several people living there. At least six confirmed COVID-19 cases were connected to him. Prime Minister Holness said the quarantine has been extended on the advice of the Ministry of Health and Wellness.

"It is clear why this is necessary. We definitely have to ensure that there is containment in that area," he said.

Meantime, the Prime Minister has also announced that a special Cabinet unit has been established to further bolster the Government's strategies to contain the spread of COVID-19.

He said the unit will undertake detailed reviews and deliberations of engagements and decisions by Ministries and the Government's response, in general, to COVID-19. Holness said members have already held their first meeting.

"[With this group,] we are better able to manage [and] spend quality time thrashing out all the details of decisions that have to be made. [The unit, which will] focus on areas that are not adequately covered by one particular Ministry, is charged with working in ensuring that those functions that are not in the remit of a particular Ministry, have no slips in implementation," he said.

Holness said the group will, additionally, offer support in relation to policy implementation.

"We need to be spending time at the policy level to get [that aspect] correct.

We have to ensure that we are reviewing, monitoring and evaluating the implementing arms, making sure that [where there are] bureaucratic obstacles, those are removed," the Prime Minister added.

COVID-19: Barbados Records First Death; Six Patients Released From Isolation Centres

An elderly man, whose wife has also tested positive for the novel Coronavirus (COVID-19), is the first person to die in Barbados from the viral illness.

At a press conference where it was also disclosed that six others who had tested positive have recovered and were released from government isolation centres, Minister of Health and Wellness Lt. Col. Jeffrey Bostic said the deceased was an 81-year-old Barbadian who travelled to the United Kingdom and returned to Barbados on March 22.

He died hours after he and his 83-yearold wife were tested for COVID-19 after reporting symptoms on Saturday.

Bostic said the elderly man, who had underlying medical conditions, deteriorated rapidly after being admitted into care. Prior to being admitted, he was neither in home quarantine nor at any of government's quarantine/isolation facilities.

"I was informed of his death late [Saturday] night from COVID-19-related pneumonia and complications of diabetes," the Health Minister said.

The man was one of the 56 cases confirmed in the island since March 16. He and his wife were among four people who got back positive tests on Saturday. The other two were: the seven-year-old daughter of another person who had tested positive for the virus, and a 21-year-old woman who returned from the United Kingdom on March 16.

Isolation Facilities Manager, Dr Corey Forde, who is also Head of the Infectious Disease Programme at the Queen Elizabeth Hospital, said the majority of the 49 patients still at government isolation centres are in stable condition.


Meantime, COVID-19 Czar Richard Carter has urged Barbadians to let the first COVID-19 death be a sobering reminder about the potential danger of the virus and the risk of age and underlying health conditions.

But he also suggested that the first release of patients, who have emerged as cured of COVID-19, shows that the virus is not a death sentence and with care and appropriate treatment, people can survive.

The six patients to recover from COVID-19 left isolation facilities yesterday after two consecutive negative tests over the last two days, which is in keeping with international testing and standards. Patients require two negative screens, which are done 24-hours apart, to be considered recovered from the illness.

Minister Bostic said the recovery of the patients was a testament to the quality of care and treatment provided by the country's medical teams, adding: "We celebrate this important milestone with these patients and their families with whom they can now be reunited."

He expressed gratitude to the medical professionals, who, he noted, at great



personal risk to themselves, continue to care for and treat those infected with COVID-19.

"These brave Barbadians, the other public health staff directly involved in the Covid-19 response and the entire cohort of staff working in the public and private sectors to maintain the high-quality health care that Barbados has become known for, deserve our support, our prayers and our deepest respect," the Health Minister said.

Barbadians are currently under a 24-hour curfew which will remain in effect until midnight on April 14. They are required to stay at home unless they need to get food at village shops or bread at bakeries which are open for a specified

period each day; to go to the pharmacy; or to seek medical care.

However, Carter expressed concern that too many people were still not heeding the instruction to stay inside.

"We still continue to see a level of irresponsible behavior, albeit from a minority of Barbadians Persons who failed to follow the advice, even though there may be a small minority, that minority is putting the rest of us at risk," he said.

"It is important that we do everything possible not to put additional strain on our healthcare system by staying off the road and staying at home, and following the public health advice, which has been given at every opportunity that we have spoken."

COVID-19: Barbados Reports Second Death and Increase in Cases to 60

Less than 24 hours after Minister of Health and Wellness Lt. Col. Jeffrey Bostic reported the first fatality from the novel Coronavirus (COVID-19), a second person has died. It was also reported that the total number of cases recorded in the island has now reached 60.

The Ministry of Health and Wellness this evening disclosed that a 74-year-old man with underlying medical conditions, died this morning.

He tested positive for COVID-19 on March 20 and had been in isolation since his diagnosis.

A statement from the Ministry said the man was infected after coming into contact with another COVID-19 positive individual.

The first person to have died from COVID-19 in Barbados was an 81-year-old man who travelled to the United Kingdom and returned to Barbados on March 22. He died Saturday night, after he and his 83-year-old wife tested positive for the virus when they reported symptoms earlier in the day.


Health Minister Lt. Col. Jeffrey Bostic said the elderly man died of COV-ID-19-related pneumonia and complications of diabetes.

Acting Chief Medical Officer Dr Anton Best expressed sympathy, on behalf of the Government and people of Barbados, to the family and friends of the latest victim.

He said he was saddened that another Barbadian had succumbed to the viral illness, and it was particularly difficult to hear of a second death so soon after the first.

"This is a sombre time for our country as we lose another person to this deadly disease. I ask our citizens to remain strong and to continue to be vigilant every day, taking every precaution to protect themselves against this illness," he said.

Dr Best further appealed to residents to observe the curfew currently in place, by staying off the streets, to help health officials contain the spread of COVID-19.



Four additional people tested positive for COVID-19 yesterday, bringing the total number of persons who have tested positive for the viral illness since March 16 to 60 – 31 females and 29 males – ranging in age from seven to 95.

Of those, 52 remain in isolation, six have been released and two have died.

The new cases include a 95-year-old male who is critically ill. The others are a 47-year-old female, who was infected by a known contact, a 57-year-old female and an 84-year-old woman who travelled abroad.

A total of 557 tests have been carried out since testing started on February 11.




