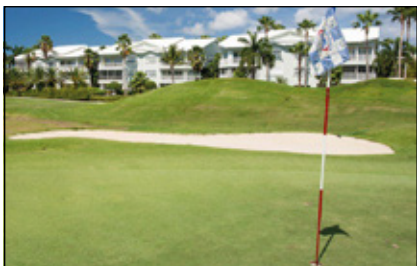

# Weather radar service temporarily unavailable

The Kearney Gomez Doppler Radar is temporarily unavailable following a hardware failure.

The Cayman Islands National Weather Service (CINWS) confirms its technical team is working closely with the radar manufacturer to isolate the fault and determine a timeline for repairs.

CINWS Director General John Tibbetts says every effort is being made to address the issue.

“Our team is working diligently in collaboration with the radar manufacturer to identify the equipment responsible for the issue. Once we have determined the cause of the issue, we will make every effort to get the radar back up and running. Although we don’t have a timeline for restoring radar service as yet, we are not expecting a long delay.”

Last year, a representative of the radar manufacturer travelled to Grand Cayman to complete a number of essential repairs to the radar equipment and the dome.

While the weather radar is an important asset in the CINWS meteorological toolkit, Mr. Tibbetts says it is complimented by other services and tools.

“The radar helps us monitor meteorological conditions as far as Jamaica, and is helpful for providing small-scale predictions. For tracking storms further afield, we use the Cayman Islands Government’s GOES-R satellite system,” he said.

Ministry of Sustainability & Climate Resiliency Acting Chief Officer Troy Jacob confirmed the radar was in good working order

following the manufacturer’s visit last year.

“Following the repairs completed by the manufacturer last year, the radar was performing as it should for quite some time. Unfortunately, it is not always possible to proactively identify hardware issues,” he said. “We understand the affinity and reliance that the public has for the radar, and that there would be frustration in the community when the radar is unavailable. I would like to assure the public that the team at our National Weather Service is doing all they can to restore the radar to full service while continuing to deliver accurate, timely forecasts, advisories and warnings for the country by using the other weather forecasting assets available to us. We intend to keep the country

informed of our progress with the radar repairs, and hope to have another update shortly.”

## Cayman Airways adds Easter and Summer flights for Montego Bay route

Residents in Cayman and Jamaica who are looking for options for an Easter weekend getaway or Summer travel this year, now have the Cayman/Montego Bay route as a choice with nonstop flights.

Over Easter, flight KX2612 will depart Grand Cayman on Friday April 7, 2023 at 7:35am to arrive in Montego Bay at 8:35am. Flight KX2613 then departs Montego Bay at 9:35am to arrive in Grand Cayman at 10:30am.

On Monday April 10, 2023, flight KX2616 departs Grand Cayman at 5:10pm and arrives in Montego Bay at 6:10pm.

Then flight KX2617 departs Montego Bay at 7:10pm and arrive back in Grand Cayman at 8:05pm.

The popular Jamaica destination will also see the addition of twice-weekly nonstop flights to/from Grand Cayman this Summer from June 23, 2023 through September 8, 2023, on Mondays and Fridays. The Summer flight schedule has flight KX2612 departing Grand Cayman at 7:35am and arriving in Montego Bay at 8:35am. Then flight KX2613 departs Montego Bay at 9:35am and arrives back in Grand Cayman at 10:30am.

Cayman Airways has confirmed that, due to changes in Jamaican security policies affecting all airports in Jamaica, in-

cluding Sangster International Airport (MBJ), passengers on flights are required to deplane during mandatory security checks. This policy rendered impractical the previous arrangement of a combined Montego Bay/Kingston flight whereby passengers continuing on to another stop in Jamaica could remain onboard. In response, the airline has instead offered seasonal and ad-hoc service, while actively exploring various solutions to address the issue.

The Cayman Airways Reservations Call Center is also ready to assist customers with bookings seven days a week from 7am to 8pm. Call 345-949-2311 (in the Cayman Islands) or 866-759-1372 (toll free in Jamaica).

The Cayman Airways Ticket Office on 91 Owen Roberts Drive on Grand Cayman is also open to assist customers from 8:30am to 5:30pm Monday through Friday, from 8:30am to 4:30pm on Saturdays, and is closed on Sundays and public holidays. The Ticket Office on Cayman Brac near the Charles Kirkconnell International Airport is open from 9am-5pm Monday through Friday, and is closed on Saturdays, Sundays, and public holidays.

ons Centre on Tuesday 7 March. Julliette Gooding Honorary Consul to Barbados, MC'd the meeting where there was lots of fun, food and fellowship. Dr Joy St John came coming to Cayman Islands to participate in training of Law Enforcement Agencies. Those attending the conference as well as Barbadians living in Cayman have been invited to meet with her.

Dr. Joy was the Chief Medical Officer of Barbados for 12 years before joining the World Health Organisation, as Assistant Director General. In 2019 she became Executive Director of CARPHA which is a CARICOM institution that has 26 member nations including the Cayman Islands. Established in 2013 it fulfills the roles of previously separate institutions, bringing them under one roof, and covers areas including the management of both non-communicable and communicable diseases, emergency responses to disasters (hurricanes, earthquakes, flooding), and the prevention of injuries, violence and job-related illnesses.

"We came here to present to local security stakeholders," Dr. Joy said. "It is important because Cayman needs to know what the rest of the Caribbean is doing, but it's also important because security is something that's easily threatening the Caribbean. It was wonderful because we



had a great reception. They listened, and then they asked really good questions," Dr. Joy said.

Julliette Gooding started the fun and games with an ice-breaker quiz, all about questions on Barbados. The first one, "who is Rhianna?" was answered by, "She's a singer," which was good enough to win a lovely gift of fancy Barbadian goods, all wrapped up with a ribbon. Other questions kept coming.

Ms. Gooding invited people to take the mike and introduce themselves. Anton Gash was one of the first. He said he had first been to Barbados when he was

16, and remarked on how much Nelson Street had changed when he went back at the age of 45. After 38 years in the Royal Navy and another 10 working for a company, Mr. Gash is helping with aspects of Border control and had contributed at the conference with Dr. Joy.

Ms Gooding also spoke about the work of the Barbados Overseas Association. The Association looks out for Barbadians living here, getting together with community projects and activities which support the community and bring it together, while also giving back to the Cayman community they call home.

# OfReg Consumer Council Chairperson resigns

OfReg has accepted the resignation of Consumer Council Member and Chair, Mr. George R. Ebanks. His resignation comes as the result of irreconcilable differences arising between Mr Ebanks, OfReg and other Council Members. These differences centre on his behaviour as Chair and on the role and remit of the Council as an advisory body to OfReg to identify and recommend solutions to issues facing consumers in the utilities sectors.

Council Members independently reported to OfReg that Mr. Ebanks was acting unilaterally in speaking on behalf of the entire Council on matters on which they had not discussed or agreed upon. This extended to a fundamental disagreement on the role and function of the Consumer Council. They also took serious issue with Mr. Ebanks' aggressive and demeaning tone and behaviour in both written communications, and in Council meetings.

OfReg Interim CEO, Mr. Peter Gough said, "OfReg has accepted Mr. Ebanks resignation as Chair and Member of the Consumer Council. It is disappointing to find the Chair was not aligned with the role and remit of the Council and was in conflict with other Council members to the extent that the Council could no longer function under his leadership. However, we look forward to appointing a new Chair in due course so that the Council can get back to the work of helping



OfReg represent and protect the rights of consumers in the utilities sectors."

## *Appeal Court rules Britannia owners' rights unprotected*

The Cayman Islands Court of Appeal recently reversed an earlier judgment given by the Grand Court with regards to owners in the Britannia complex and their rights to use the former Hyatt hotel's golf course and beach, which had been registered in the Land Register. Dart, who took over ownership of the old Hyatt hotel in 2016 - following the resort's demise after Hurricane Ivan in 2004 - and the property's surrounding land (which includes the golf course and beach), said this Appeal Court decision was "an important decision for certainty of title in respect of land in Cayman that is governed by the Registered Land Act".

The original developer/owner of the Hyatt Regency hotel, golf and beach resort, granted certain benefits to property owners in the Britannia development in the early 1990s, including the right to play golf on the golf course, to use the facilities at the beach resort and to use the tennis courts located on parts of the former Hyatt Regency properties. These rights were recorded in written legal agreements and registered by the Registrar of Lands on the Land Register. The creation and reg-

istration of the legal agreements occurred more than 15 years prior to Dart purchasing the Hyatt Regency properties.

After Dart bought the property, it found there to be "considerable uncertainty regarding the nature and validity of the rights".

"After years of without prejudice discussions with representatives of the Britannia owners seeking to reach agreement regarding the rights, and being unable to do so, the only remaining option available was for the landowner to seek the Grand Court's guidance, clarifying the legal position surrounding the agreements, bringing certainty to all," Dart said in a press release.

The Grand Court held that Dart should be bound by the agreements, but this decision has now been overturned by the Court of Appeal.

Specifically, the Court of Appeal was concerned about the type of registrations of the rights, whether they were valid and, if not, whether the register could be rectified and bind the landowner. The Court of Appeal confirmed that the nature of the rights did not amount to restrictive

agreements capable of being registered as encumbrances. They had not been validly registered because incorrect and amended forms were used at the time of registration and wording used invalidated the Britannia owners' rights. The land register could not be rectified by the Registrar of Lands to change that, the Court found. Consequently, the Court of Appeal decided that the Land Registrar must now rectify the errors in the Land Register by cancelling and deleting the rights in their entirety.

The Court specifically stated:

"As things currently stand, the register contains entries registering agreements that do not qualify for registration by reason of failing to satisfy the definition of restrictive agreements provided for in section 93(1) LRA. Those entries are accordingly grossly inaccurate and give a very misleading impression. In our view the case for their deletion is overwhelming."

During both the Grand Court and the Court of Appeal hearings, the landowner's Leading Counsel, Mr. Jonathan Seitler KC, highlighted the importance of certainty of title in respect of Cayman land, with the

Registered Land Act acting as a formalised comprehensive code, protecting the integrity of the Cayman Islands' land registration system. On this point, the Court of Appeal stated:

"In our judgment, there is a powerful argument, founded on the long-accepted benefits that flow from commercial certainty .... As a result of the parties' freely taken decision to register restrictive agreements, the register recorded entries only for restrictive agreements and parties inspecting the same would have been well entitled to conclude that it was restrictive agreements and only restrictive agreements that had been registered. The whole point of the system created by the [Registered Land Act] was that entitlement to land and related interests therein are to be determined by entries in the register and that people should be able to rely on the entries to determine and vindicate their real property interests."

Understanding the impact of the decision on the Britannia owners, the Court of Appeal further stated:

"The Court has well in mind that the outcome of this appeal will have a profoundly negative impact on some 193 proprietors who, when purchasing their properties, are likely to have paid a premium for the Rights that they would have assumed had been securely protected by restrictive agreements registered in the Land Register. However, as we were driven to conclude, the apparent restrictive agreements that the parties to the original Instruments and Agreements deliberately decided, on legal advice, should be the sole mechanism for protecting the Rights, lacked the essential ingredient plainly and obviously required by section 93 (1) RLA, namely that of restricting building on or the user or other enjoyment of the land owned by the Resort. The die was therefore cast at the very moment that the requested entries were recorded in the register, and it is most unfortunate that the proprietors must bear the consequences of the mistaken selection of this defective mechanism for the protection of the Rights."

The Judgment is public and should be available from the Cayman Islands' Judicial and Legal website shortly.

The Cayman Islands Netball Association is this year marking a significant milestone. Seeing that it is women's Month, CINA will highlight and thank the women who have kept this sport alive and also thank the men that supported netball.

The organisation which was established in 1956 was honoured as an early Pioneer at National Heroes Day 2023.

From its inception, CINA has been a pride of Cayman for both excelling in the sport and its community outreach.

The place of netball in Cayman came via the foresight of Teacher Timothy Mc Field and later Mrs Edna Moyle who joined in playing the sport after returning from Knox College.

But where there might have certain societal gender limitations for women wishing to get involved in sporting activity, the growth of netball in Cayman has been one of inclusivity.

Over the last 20 years, the sport has been embraced by boys and men throughout the society...and not just as spectators. Boys and men in every district now put their skills to the test on the netball court.

The popularity and success of the sport in Cayman is now on such a scale that the net-

ball team was the most successful national team in sports in the Cayman Islands in 2019, as determined by the world ranking across all internationally recognised sports.

### Netball 2025 will continue this legacy

Netball 2025 is built on four strategic pillars: effective governance and leadership; the game; empowering through netball; and nurturing.

"This is the vision and plan that will drive netball forward over the next five years in the Cayman Islands. It is our blueprint for the work we at the Cayman Islands Netball Association (CINA) will be doing to lead netball over the next decade. The four pillars build on the firm foundation of the three years strategic plan (2016 - 2019), which shows that at the end of the last three years netball has never looked better. Indeed, coming out of the 2018/19 season," says President of CINA, Lucille Seymour, BEM, MBE, JP.

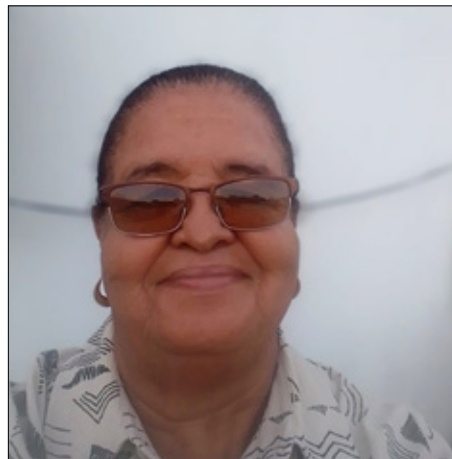
Through hard work, dedication and success on the playing field, Cayman Netball is now ranked 28 globally.

ed much employment for many people either as managers, coaches or as a career sport."

The great steps taken and goals achieved would not have been possible without the involvement of our stalwarts. They are many and don't wish to omit any.

"The milestones are worth mentioning here as the persons who have been involved in these areas have propelled netball to be a successful organisation, benefitting the sociological and cultural life of Caymanian women. Netball gave women the opportunity to travel far and wide to empower themselves and to develop great characteristics so that they could get scholarships or possess great employment."

CINA was set up in 1968 when its first constitution was approved as the sport's governing body in the jurisdiction. Cayman participated in the Caribbean Games in 1977 in The Bahamas, and participated in its first global netball tournament in Australia in 1991. Recruiting the first technical director, especially

a male, gave CINA a great opportunity to recruit male umpires and coaches.

The efforts of Mr Dilbert and Ms Veronica to fight hard and convince the Government that hard courts are essential in this game should be highlighted. The idea of playing on grass courts had faded into history.

Cayman participated in its first Under-16 International Championship in the Caribbean in 1996.

The success of this sport cannot be touted without involving teachers and other volunteers. This has to certainly involve the persons who over the last 20-40 years committed their lives and made sacrifices for netball to remain beneficial and integral in the sporting arena.

## Rule #4: Go to Bed

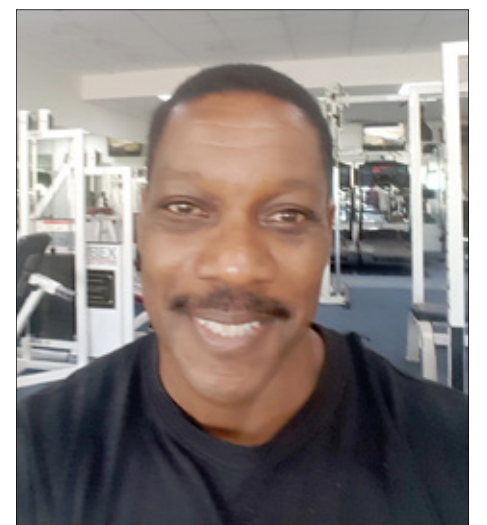
It seems no matter how many studies come out showing the direct connection between sleep and fat loss, people still ignore their body's signals to get more sleep. Don't
