Government cracking down on marriages of convenience

Cabinet has approved the drafting of new immigration regulations which will stop sham marriages in Cayman that are not true unions and are simply a ruse to get round immigration laws.

In what it calls "a decisive move" to strengthen the integrity of marital/civil

partnerships unions and uphold the sanctity of the institution of marriage/civil partnerships, Cabinet has approved the drafting of new immigration regulations, specifically the Immigration (Arrangements of Convenience) Regulations 2024. These regulations are aimed at addressing key issues related to marriages/civil partnerships of convenience. This landmark decision underscores the government's commitment to ensuring that marriages/

The week, which was celebrated under the theme 'Honouring Our Past, Forging Our Future' was observed from 19th-25th May, and recognises the commitment of EMS providers in increasing the probabilities of positive outcomes for patients needing urgent and immediate healthcare.

Cubans will need in-transit visas

In a bid to curb "irregular migration" of Cubans through the Cayman Islands, Cabinet has approved amendments to the Customs & Border Control (Visas, Entry and Landing) Regulations, 2019 which seek to introduce the requirement for in-transit visas for Cuban nationals.

Cuban nationals are travelling through the Cayman Islands and then onto other South American or Central American countries on a return ticket, but in some cases, are not returning. The amendments to the Regulations are to ensure that the visa application poses the appropriate questions to help CBC Visa Officers make decisions to approve or deny visas.

People are leaving their homes in search of safety and a better life, which has resulted in global unauthorised migration occurring more frequently. Considering the "push" and "pull" factors, migrants are risking everything to escape conflict, disaster, poverty, or hunger. Caribbean nations are not exempt from this trend as Haitian and Cuban citizens have traversed the Caribbean Sea with the intention of ar-

riving in the United States and thereafter seeking asylum, a release said.

From November 2021 to November 2023, WORC statistics showed that 12,381 people travelled on a round trip ticket on Cayman Airways from Havana, Cuba, however only 3,116 persons returned on the ticket.

As a result, government worried about the various risks to the Cayman Islands attributed to the irregular migration of Cuban nationals, namely: reputational risk, risks of sanctions, risk of cancellation of routes for CAL, risk of visa restrictions



for Caymanians and risk of increased applications for asylum by Cuban nationals in-transit.

Therefore, the Ministry of Border Control, Labour & Culture is taking measures to introduce an in-transit visa for Cuban nationals, to reduce the risk of irregular migration and to disincentivise passengers from Cuba from exploiting the Cayman Islands or CAL during irregular migration.

Minister for Border Control, Labour & Culture, Dwayne Seymour, stated:

"Securing our borders isn't just about lines on a map; it's about safeguarding our nation's integrity and ensuring the safety of our citizens. By taking proactive measures to manage irregular migration, we not only mitigate risks but also uphold the values of order and security, that define us as a nation."

civil partnerships are entered into sincerely and not exploited for ulterior motives, a release said.

Marriages/civil partnerships arrangements of convenience, often referred to as "sham marriages", are marriages/civil partnerships entered into for the primary purpose of circumventing immigration laws or obtaining other benefits. Currently, the Marriage Act (2010 Revision) and Civil Partnership Act (2020) lack explicit provisions addressing arrangements of convenience.

New laws intend to require the need for enhanced scrutiny of intended unions which will empower officials to scrutinise intended marriages/civil partnerships more rigorously. This will be achieved by mandating the collection of additional information from persons intending to marry, ensuring that all unions are entered into with genuine intent.

The legislation will establish a clear legal framework for officials to report any suspicions that may arise during their interactions with intended couples. This aims to ensure that any potential concerns are documented and addressed in a timely manner.

To ensure consistency and reliability, the legislation proposes the implementation of a standardised reporting system for all suspicions related to marriages/civil partnerships of convenience. This will facilitate uniformity across all reports and enhance the effectiveness of the response, government said. The proposed changes aim to address potential gaps in the current legislation regarding the prescribed form and manner for reporting suspicions. By defining clear guidelines, the new Regulations will provide officials with the necessary tools to act appropriately.


Enhancing the ability of WORC to swiftly respond to reports of suspicion is a key focus of the proposed legislation. The streamlined process will enable more efficient handling of cases, ensuring that genuine marriages are protected while preventing abuse.

Dwayne Seymour, Minister of Border Control, Labour & Culture said by introducing these measures, they aimed to ensure that marriages/civil partnerships were based on genuine relationships and not exploited for convenience.

"We are committed to maintaining the integrity of our marital system and protecting the rights and responsibilities that come with it," he said.

The Cabinet's approval marks the beginning of the legislative drafting process, which will involve thorough consultation with relevant stakeholders and the public. These new Regulations will ultimately serve to enhance WORC's prosecution capabilities against officials who fail to report suspicions, which is presently challenging due to the absence of prescribed reporting procedures.

Plan Cayman- George Town Residents have their say

Constitution Hall was filled on Thursday 6 June, as residents came to voice their feedback on the Draft Plan - the most significant new development since Plan Cayman began back in the 1990s. It was part of a series of district consultations held throughout June and into July, at locations including West Bay, Savannah, Bodden Town, North Side, Cayman Brac, Little

Cayman and East End.

The panel at the front of the hall began by giving an overview to Plan Cayan, before the Floor was opened to questions. People lining up for their turn at the mic were limited to 2 minutes each, to make things fairer and give everyone a chance to speak. Panelists included Haroon Pandohie, Director of Planning, and Richard Mileham, Planning Officer Policy and Development, along with Central Planning Members Danette

McLaughlin and Ian Pairaudeau.

"There's a lot of technical expertise here, but as you know - especially if you're doing something like the National Development Plan - it is driven by the involvement of the people and their interests," said Pandohie. "We can come up with these technical pans and sit with people, and translate your hopes, your dreams and your visions into a technical planning document, but it requires the people sitting in this room to drive the process forward."

One of the questioners from the Floor wondered why she had not been able to contact Richard for over a "year and a half," with her query.

"As with any process, we need to be able to track the information...it has to be done in a manner in which everyone is able to engage at the same time because it is a national debate. You have to provide your engagement in writing at the time, so it can be archived and put into this process," Pandohie responded. Another panelist added that, once the present consultation period had finished, there would also be an appeals process, and that time periods for both processes had been prescribed by law.

Another question from the Floor concerned, "No stormwater plan for the South Sound catchment area." which is crucial to the area's drainage, hydrology and marine life." As a South Sound resident, she said, she was concerned for the apparent lack of "Joined up thinking." between departments. Mr. Mileham answered by saying that he believed joined up thinking was an integral part of the document and the processes, and while stormwater drainage was referenced in the document, he also agreed that a stormwater management plan was needed for South Sound.

Another question concerned the differential of 'commercial' and 'backyard' farming for residential areas. "I say this because I live in a purely residential area, not zoned for agriculture, and a commercial farm was allowed to come up in the neighborhood. that affected my family's daily quality of life, based on the daily spraying activities of that farm."

"This highlights why we must update the Development Plan," Pandhohie answered, " A residential zone says: 'the primary uses are residential and horticulture.' the questioner replied that didn't address her query about differentiation. "That's why we've introduced the Area Plan Concept," Pandohie said. "With Area Plans we are able to appreciate the uniqueness of an area such as George Town - to get in there and sit with residents and create an area plan...that reflects what they would wish for in their community."

Communities in Prospect and Spotts-Newlands of George Town, and Belford Estates of Bodden Town were also reviewed. All areas were advised to be clear with minimal pools of water.

CAL Barbados Route Discontinuation Focus of PAC Session

The Cayman Airways Ltd. (CAL) flight route to Barbados, which was introduced just 9 months ago on 18th October, 2032 and cancelled recently was the subject of the Public Accounts Committee hearing on 6th January.

During the session MPs heard from the CAL President and CEO Fabian Whorms, who noted that despite the route's cancellation and any negative perception that has accompanied the development, the arrangement between the flagship carrier and the Barbados Government via its marketing subsidiary Barbados Tourism Marketing Inc (BTMI) was "Fantastic".

Mr. Whorms said the Barbados route fit into CAL's operation strategy by not compromising the rest of the service and noted that one of the caveats for the introduction of the route was that, "....operating these flights should not in any way hinder any of our current service or our future plans." He added that the Barbados flights were schedule on days of the week when there was nothing else to do with the aircraft or its crews and putting the aircraft and staff to work on such days covered both variable costs and allocated costs.

"There's nothing else we would have done with the aircraft or our crews," he remarked, adding that, "Many of our rotes do not cover fully allocated costs."

Mr. Whorms noted that the Barbados flights did not hinder any current services, nor future plans and explained that the decision to add the flights was basically a risk-free proposition for the airline and the contractual arrangements were structured to guarantee revenue and profit.

The CAL President and CEO said it was not a challenge for them to put the contract together in a way that was optimal/ favourable.

"we have entered into much more so-

phisticated contractual arrangements than this one.

"So it was not a challenge for us to put in place the terms that we wanted," he said, explaining that the flight essentially operated like a charter and that the revenue comes from both tickets sales, as well as a top-up from BTMI should the numbers of the former fall short, because of the guaranteed profit margin built into the contract.

"We have made a level of profit from this venture which assures us that if we find ourselves in a situation where we need to go to the Cayman Islands government and say we have a shortfall that we need to bridge, for whatever reason for this fiscal year, we know that that number is now going to be so much smaller because we can apply the profits that was earned from this," said Mr. Whorms.

At the time of the launch of the route, Tourism Minister, the Honourable Kenneth Bryan, had noted that the introduction of the Barbados route would offer cost-effective flights that significantly enhance the convenience of travel overall to, and within, the Caribbean, adding that financial commitment from Barbados Tourism Marketing Inc. (BTMI) to back the Cayman Airways service was crucial in making a Barbados route a reality.

The Honourable Minster spoke exclusively with the Caymanian Times about the route and its benefits, as well as the reasons for its termination.

"This is as a result of the Opposition playing politics and creating bad press. There were many benefits included in this package. We have now tossed loss of possible medical tourism revenue, regional leisure opportunities and marketing opportunities," noted the Minister.

He added that the flight, which essentially operated as a charter for Barbados - giving them access to the Western United States - was something that was initiated at the very top of the Barbados Government and the country's Primer Minister Mia Mottley was instrumental in making the route a reality.

"The cost of the flight was covered by Barbados to whatever extent there was a shortfall in revenue from tickets and the room tax, as well as other benefits to the local economy in Cayman meant that this was an economic accelerator for us," said Minister Bryan, who explained that the initial agreement was for one year, with a 2 month notice, 'opt-out clause'.

He said the arrangement was a 'sweet deal for Cayman' and, ".....we have to put our planes and personnel to use in the most strategic way," noting that his Ministry would continue to seek the best opportunities for Cayman, despite the setback.

In addition to providing nonstop service to and from Barbados, the service had been timed to provide convenient connections to the Eastern Caribbean and Europe via the many carriers that fly to the Grantley Adams International Airport in Barbados.

Convenient connections via Grand Cayman to Los Angeles, effectively linking the West Coast of the United States with the Eastern Caribbean was another goal of the service, in addition to synchronizing the flight schedule to align with other Cayman Airways destinations.

The expanded connectivity was expected to usher in fresh opportunities for business travel, tourism, and cultural exchange, further enhancing regional ties.

The early-bird flight marked the third new route of the Cayman Islands' national Carrier in one year, with Panama and Los Angeles routes also launched in 2023.

When asked whether he agreed that the discontinuation of the Barbados Rout to Grand Cayman was not due to financial concerns and lack of business Opposition Leader and former Chairman of the Board for Cayman Airways, the Honourable Roy McTaggart said, "Without seeing any numbers it is difficult to really form a view.

"The CEO did ofter the share the numbers with the PAC privately. However the PAC is all about transparency and openness."

The RCIPS is aware of false information circulating on social media, suggesting that the RCIPS and another law enforcement agency have deliberately failed Caymanians in the recent local police recruitment drive to favour hiring nationals from other jurisdictions.

They have categorically state that this information is inaccurate and misleading.

On the 24 of April 2024, the RCIPS launched an extensive local recruitment campaign specifically aimed at Caymanians and individuals with Permanent Residency with the right to work.

As part of the criteria applicants are required to be Caymanian (as defined under the Cayman Islands Immigration Act) or Permanent Resident (with the right to work without restrictions); be physically fit, computer literate, and must hold a minimum of a High School Diploma or a General Education Degree (GED) from an accredited institution with a minimum of five (5) CXC passes or equivalent, two (2) of which should be in English and Mathematics.

A total of 803 persons applied. Of this number, 354 persons met the eligibility requirements (Caymanian, or PR and RERC holders).

Following an initial vetting process, a total of 137 applicants were invited to sit the entrance examinations which consisted of questions to demonstrate knowledge of numeracy, literacy and comprehension skills.

Several candidates indicated that they were unable to sit the examinations held on both islands (Grand Cayman and Cayman Brac) on the 01 June 2024, due to various reasons. Every effort has

been made to accommodate these candidates by scheduling further opportunities to sit the examination.

A total of 51 candidates were invited to undergo the fitness test, accommodations were also made for rescheduling where the set dates and times were inconvenient for the candidates. After an initial vetting process (background checks) eight (8) applicants thus far failed due to adverse information, including discrepancies found in other eligibility requirements.

So far, a total of 16 candidates passed the full eligibility criteria, for recruit police constables and 13 for recruit auxiliary constables. It is crucial to note that our vetting process is ongoing, including thorough checks of individuals' immigration status. This further demonstrates our commitment to ensuring that only Caymanians and persons with Permanent Residency with the right to work are invited to join the RCIPS.

Commissioner Kurt Walton

states, "As Commissioner of Police I want to emphasize that we will not compromise the standards of the RCIPS by employing individuals who do not meet the requirements to become police officers. Our commitment is to uphold the highest standards of integrity, fairness, and transparency throughout the recruitment process."






