## Unlawful Barriers Removed

Assessing Stormwater Management across Grand Cayman.

On Wednesday, June 26, Minister Hon. Jay Ebanks, accompanied by Managing Director Edward Howard of the National Roads Authority (NRA) and the NRA crew,

took decisive action to address two critical issues:

1. The removal of unlawful barriers obstructing public access on West Bay Road
2. The assessment of stormwater management needs across various areas.

Minister Ebanks personally oversaw the removal of cones, barriers, and other obstacles unlawfully placed in front of hotels, condominiums and businesses on West

# DOES UNITED STATES CRICKET GROWTH IMPACT THE FUTURE OF WEST INDIES CRICKET?

“For it is God who works in you to will and to act according to his good purpose.” – Philippians 2:13

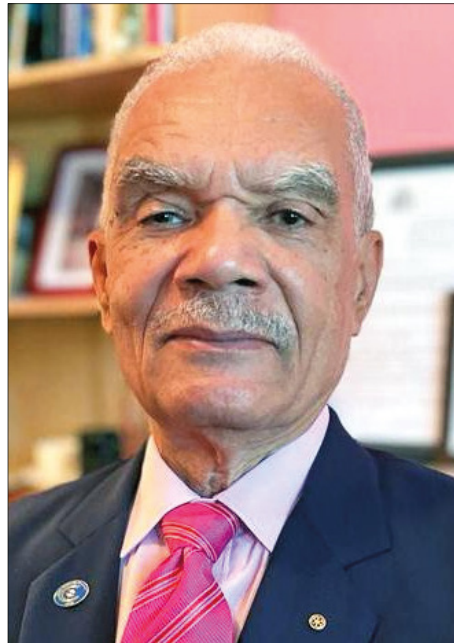
From the mid-late 1970s to the early 1990s, the West Indies team was the strongest team in the world in both red-ball and white-ball cricket. However, this dominance has not been sustained, and at times, our performances have trended towards the depths of despair for cricket fans.

This fluctuating performance can be attributed to several factors: financial investment, marketing approaches, infrastructure, pitch curators, operating logistics and coaching systems, all of which need improvements.

The growth of cricket in the United States presents opportunities and challenges for the sustainability and resilience of West Indies cricket. I have been closely monitoring this development, which has the potential to significantly reshape the cricketing and socioeconomic landscape in our region.

The United States, with its vast population and diverse immigrant communities, represents an untapped market for cricket. The sport’s increasing popularity there, driven by the success of Major League Cricket (MLC), can substantially boost its global profile. This burgeoning interest can positively impact West Indies cricket in several ways.

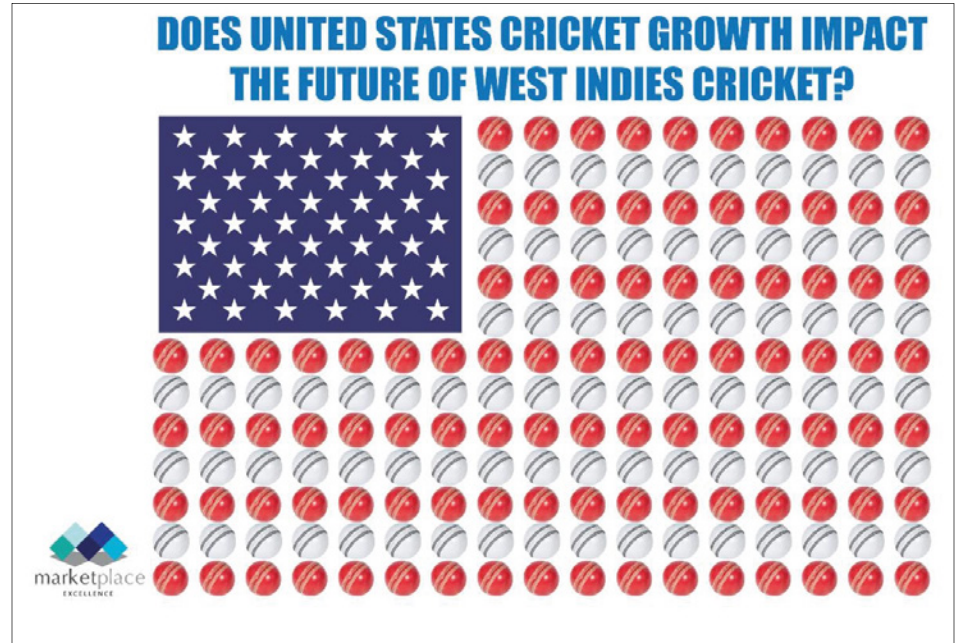
First, the expansion of cricket in the U.S.

can increase financial investment in the sport. The commercial potential of the U.S. market is enormous. As cricket gains traction, we can expect more sponsorship deals, broadcast rights agreements, and merchandise sales. This influx of capital can benefit West Indies cricket through collaborations and shared investments, enhanced facilities, coaching contracts and player development programs.

Second, the growth of cricket in the U.S. can provide West Indies players more op-



portunities to compete at a higher level. Establishing a professional league like MLC can serve as an additional platform for our players to showcase their talents and gain valuable experience. This exposure can help bridge the gap between domestic and international cricket, fostering a new generation of West Indies cricketers better equipped to compete on the world stage.

However, there are also challenges to consider. The rise of cricket in the U.S. could lead to a talent drain, with young Caribbean cricketers potentially being

lured by the financial incentives and lifestyle offered in the United States. This could weaken the talent pool available for West Indies cricket if not managed carefully.

Moreover, the West Indies Cricket Board (WICB) must proactively engage with U.S. cricket authorities to ensure mutual benefits. Strategic partnerships, exchange programs, and joint ventures should be developed and nurtured to help both regions flourish without one overshadowing the other.

## Pensioners Receive 3.8% Inflation Increase to Payments

The Public Service Pensions Board (PSPB) is pleased to announce that in accordance with the Public Service Pensions Act (2023 Revision), the pension augmentation for 2024 has been calculated at 3.8% based on the Consumer Price Index (CPI) as determined by the Economics and Statistics Office.

This will mean that all Defined Benefit and Defined Contributions pensions in payment as of 31st December 2023 will be adjusted for inflation as of the first day of 2024. For eligible pensioners in receipt of a monthly pension, their June payment will reflect the 3.8% increase and the retroactive portion for January through May will also be reflected on their June pay slips as an adjustment.

Bay Road, ensuring that public access is restored and maintained.

In addition to addressing the barriers on West Bay Road, Minister Ebanks conducted a comprehensive assessment of stormwater management needs in multiple areas, underlining the government's commitment to improving infrastructure and addressing community concerns.

Minister Ebanks emphasized the critical importance of public safety and accessible roads, stating, “

Accessible, safe, and efficient roads are vital for the well-being of our community. My Ministry leads the National Road Safety Strategy, and addressing these two critical issues—removing unlawful barriers and assessing stormwater management—

is essential for public safety. Road Safety, is a community effort—everyone has to do their part. The Ministry and the NRA are dedicated to ensuring our roads remain open and safe for everyone to use.”

Under the leadership of Minister Jay Ebanks, the Ministry of Planning, Agriculture, Housing, Infrastructure, Transport, and Development (PAHITD) and the NRA continue to be dedicated to maintaining public infrastructure and enhancing roadway safety.

# Gun Amnesty for July

For the entire month of July, the RCIPS is holding a National Gun Amnesty, working with key partners and stakeholders who are taking a stand against illegal guns in Cayman, aiming to appeal to those who have access to, or are aware of, illegal guns, in order to get them off the streets.

This was because of the recent uptick in crimes being committing using illegal firearms which had escalated into violent incidents with obvious disregard for the safety of the community, the RCIPS said.

The National Gun Amnesty will run from 1 to 31 July, 2024 and is the first gun amnesty being held in Cayman since June 2018, when 18 firearms were surrendered along with just under 900 rounds of ammunition. Other weapons, including a crossbow and flare guns, were also surrendered at that time.

This year's campaign is being led by Chief Superintendent Brad Ebanks who said the amnesty would let those who possessed illegal guns, ammunition and any other types of illegal weapons, to hand them over to the police, without having to fear being prosecuted for possession of the firearm.

"We are giving these people an opportunity to reject a lifestyle that can end in only one of two ways: death or prison," he warned. "The results from the last amnesty should give us an idea that this is an effective method of serving our community and protecting our families."

Commissioner of Police Kurt Walton said there were around 90 firearms outstanding in the community that had been used to commit crimes, which had not yet been recovered by the police.

"If you have access to these guns, I am appealing to you to hand them over and make our islands a safer place for

our children, our youth, our elderly and other vulnerable members of our community," he said, "In addition to maintaining a safe space for our visitors to enjoy, even more important is ensuring that the people who live and work here are safe in going about the business of living their lives."

The police said the amnesty gave people who could be innocent custodians of a weapon and possibly even unsure of its legal status, a safe and straightforward way to dispose of the item by handing it over to the police.

The amnesty will be active between the hours of 7:00am to 7:00am, and anybody handing in guns will need to package them in a specific manner: any ammunition should be removed from the gun and packaged separately, also in paper or plastic. The gun itself should

be wrapped in paper or a plastic bag and taped securely. If being transported by vehicle, the gun should be placed in the trunk of the vehicle, and where it is out of reach of the occupants. The gun should also be taken to the nearest designated location. For example, persons transporting a gun from Bodden Town should not be carrying it to the West Bay Police Station.

Chief Superintendent Ebanks confirmed 12 firearms had been seized by the RCIPS this year so far and eight people had been arrested and charged for possession of an unlicensed firearm.

"Persons caught with a gun outside of the conditions of the Amnesty conditions will remain subject to prosecution for possession of an unlicensed firearm, and can face a minimum sentence of ten years if convicted," he advised. "I know there are persons out there that are in possession of unlicensed firearms who have realised, this is not a good idea. This is now your opportunity to do right thing and walk away."

The various options for handing in a firearm are:

**\* Option 1 - Drop Off:**

Guns can be handed in to any police station. There are drop boxes in place at the West Bay, Bodden Town, and Little Cayman Police Stations, in which guns (properly packaged) may be placed. There are no drop boxes at the George Town or Cayman Brac, or East End Police Stations, and so persons should call 936-8026 to make drop off arrangements at these stations.

**\* Option 2 - via a Trusted Third Party:**

Guns can be handed in to a trusted third party, consisting of pastors, elected members, and community leaders, all of whom are listed on the RCIPS website at [www.rcips.ky/gunamnesty](http://www.rcips.ky/gunamnesty)<<http://www.rcips.ky/gunamnesty>>. The list is also provided as an attachment to this press release. These third parties will then arrange for the gun to be immediately handed over to the police.

**\* Option 3 - via Cayman Crime Stoppers:**

**\* Option 4 - Arrange Collection:**

Persons can arrange collection of a gun by calling 936-8026, any police station, or by contacting a police officer that they know and trust.

The Amnesty is also being supported by an advertising campaign featuring online and digital billboard ads, as well as local media, to familiarise the public with the parameters of the amnesty and various options for handing in guns.

"We are pleased to process this increase in monthly payments for our

long serving pensioners who deserve to have comfortable income in retirement," said Mrs. Jewel Evans Lindsey, Chief Executive Officer for the PSPB.

The only pensioners not eligible to receive an increase in payment are those receiving the government's Ex-Gratia Uplift as this group will con-

tinue to receive their monthly payment of \$1250.

This is a result of applying the 3.8% inflation adjustment increase to the monthly pension and then decreasing the amount of the Ex-Gratia Uplift to maintain the \$1250 monthly payment.

# Cayman National donates new catboat to Cayman Catboat Club

The Cayman Catboat Club has a new addition to its fleet thanks to a donation by Cayman National. The “Truman B” was christened at an official handover ceremony held at the Catboat Club on 20 June as part of Cayman National’s 50th anniversary celebrations.

Cayman National commissioned the building of a new catboat to commemorate the retirement of a founding shareholder and a former chairman, The Hon. Truman M. Bodden. The boat was built from scratch by Buxton Boats in Stonington, Maine, United States, using traditional methods and building materials based on detailed examination of local boats. Cayman National will also fund the boat’s maintenance in the early years.

Cayman National Corporation Ltd. (“CNC”) board director Clarence Flowers, himself the owner of two catboats said, “Catboats are emblematic of our identity as a seafaring nation, yet we have less

than a dozen still in operation. Cayman National has a long history of celebrating our maritime heritage and we are proud to contribute to the Catboat Club’s outstanding work in keeping our past alive. The construction of this boat was made possible by dedicated efforts of Heber Arch, boat builder Peter Buxton, and former CNC CEO Stuart Dack.”

The “Truman B” will join the Catboat Club’s current fleet of 5 catboats and will be used for racing and catboat rides, giving today’s generation the opportunity to experience a mode of transport that was once a way of life in days gone by. Beyond fishing and turtling, the catboat was in frequent use as a ‘pick-up truck’ in the days before roads were paved.

As outboard engines and cars became more popular, most catboats went unused with their wooden frames left to rot. The Cayman Catboat Club was set up in 1998 to preserve the art of building and sailing

Cayman’s iconic boats.

“There are very few of the older generation left with the skills to build a catboat in the old way,” said Jerris Miller, president of the Cayman Catboat Club. “Our aim is to inspire and educate the next generation to make sure catboats are not lost to the past. We are delighted to have another operating catboat and would like to thank Cayman National for making such a valuable donation to the Club. This marks a milestone in the evolution of Cayman Catboat Clubs’ desire to create a fleet of one-design catboats, made to a specific plan of an existing Cayman Catboat, and replicable by anyone familiar with the old time Caymanian boatbuilding techniques. The “Truman B” is an exact replica of 68-year-old “Captain D” and begins a one-design fleet that will allow us to invite international sailors from other countries with Caymanian dysphoria in North, Central and South America, where over 100 years ago,

Caymanians took the catboat building tradition, which is still alive today.”

Cayman National has a long record of celebrating the cultural importance of Cayman’s seafaring history. Most recently, Cayman National was lead sponsor at the National Trust’s fundraising event for National Maritime Day which was held on 22 May at the Cayman Collections Centre where many maritime heritage artefacts are on display. Cayman National is also sponsoring the Fair Weather, the last Caymanian-built schooner still afloat that has been restored in England and is due to arrive back in its home port next month.

“Over the past 50 years since Cayman National Bank was founded, Cayman has changed immeasurably,” said Flowers. “While we must adapt and modernize to stay up to date, as a company or a country, it is also important we recognize and celebrate our roots and where we have come from.”

# Infrastructure Minister wowed by students' technology focus on addressing community issues

## *Minds Inspired SDG Inter-School Challenge winners discuss their "Bus 345" app solution with minister responsible for transport*

Students who developed a technology driven solution to enhance the passenger experience on Cayman's public bus network have impressed senior officials from the Ministry of Planning, Agriculture, Housing and Infrastructure, including the minister Hon. Johany "Jay" Ebanks, who has responsibility for public transportation.

A team of seven students from Grace Christian Academy presented their "Bus 345" app to the ministry team on 11 June, after winning the top prize in the SDG Inter-School Challenge organised by Dart's Minds Inspired education programme earlier this year.

The Grace Christian Academy team conducted a survey of more than 300 passengers and 30 drivers which showed 70% of users consider the current bus service unreliable. The team researched past attempts at a bus app and spoke with local technology providers as they developed their carefully researched prototype for the app, which supports SDG Goal 11 Sustainable Cities and Communities.

After hearing about the students' winning proposal, Ministry officials requested the opportunity to meet and hear further from them, along with another team from St Ignatius Catholic School who also identified the bus system as an area for improvement, having initially considered bike lanes for their project. Their primary focus was on the congestion near the multiple schools

on Walkers Road and the lack of safe alternatives to cars at school pick-up time.

"The first thought that came to my mind was 'wow'. The children have put in a lot of work into this," said Minister Ebanks, adding that the students' proposal aligned with what his ministry was considering. "Their mindset is exactly where we want to be. I'm glad to see they're thinking exactly what the Ministry is thinking, where we have to integrate a new app system, a GPS and camera system in the buses, so that we can reduce the waiting times for people who want to catch the bus service down to 15 minutes."

Ebanks lauded Dart for initiating the Minds Inspired Inter-School SDG challenge to get young people to think of sustainable solutions to Cayman's most pressing issues. "I loved the activity. I loved the whole concept of what they put together. I'm a hundred percent sure the Ministry will be taking everything on board. We're all on this bus together and we want to see this to the end and get this done."

Minister of Sustainability and Climate Resiliency, Hon. Katherine Ebanks-Wilks also attended the presentation.

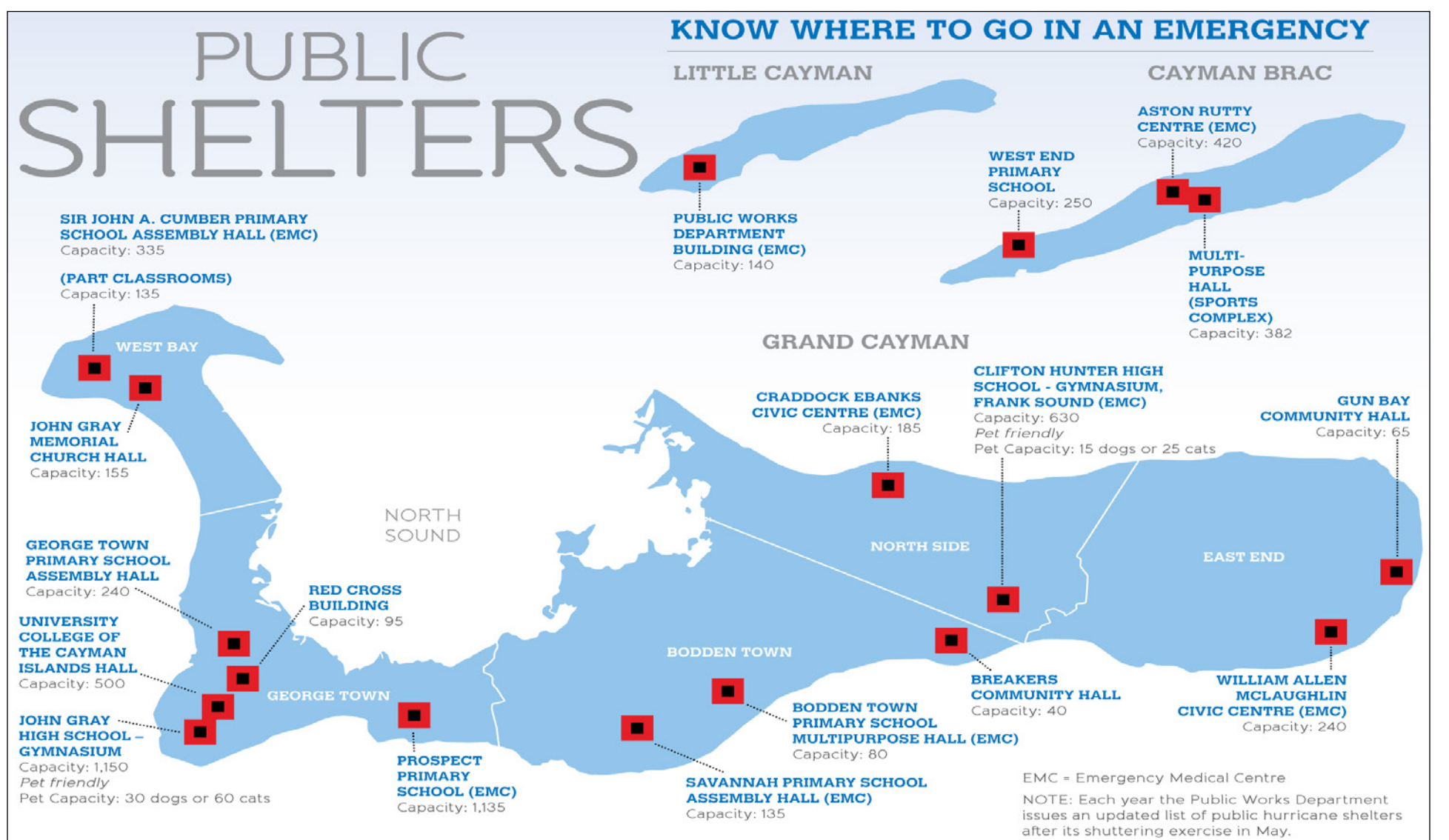
Glenda McTaggart, Dart's senior manager for education programmes, said: "Getting the attention of government's decision-makers will help them see the importance of what we're doing with the SDG challenge. They won their school \$1,000 to help their school advance sustainability initiatives and each received reference letters from Dart's CEO Mark VanDevelde.

The team from St Ignatius included Co-sette Brendel, Bethany Mitchel, Khobika Rajeshkannan, Yuktha Sandeep Kumar, Isaac Conly, Jeffrey Rivas Jr., and Daniel Sunico.

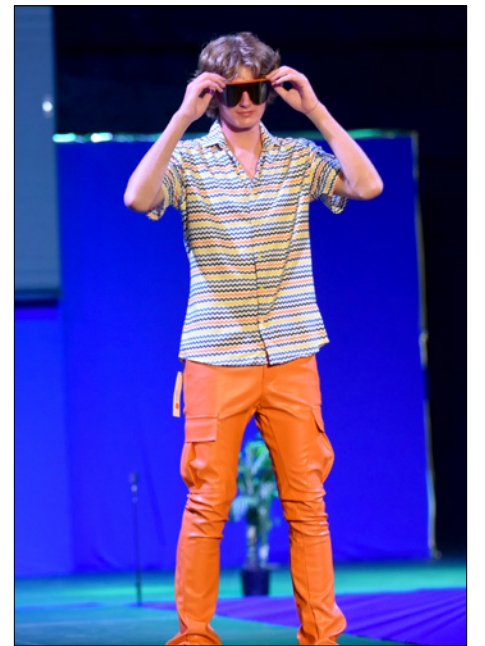

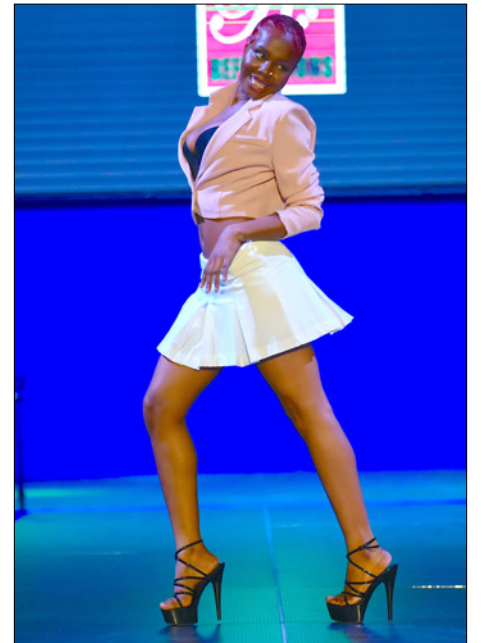

## Qualifications of Electors

90(1) Subject to section 91, a person shall be entitled to be registered as an elector in one electoral district only, but he or she shall not be entitled to be registered as an elector for elections to the Legislative Assembly unless—

- (a) he or she was, on the day immediately preceding the date of commencement of this Constitution, entitled to be registered as an elector; or
- (b) he or she –
- is a Caymanian; and
  - has attained the age of eighteen years; and
  - is resident in the Cayman Islands at the date of registration; and
  - has been resident in the Cayman Islands for a period or periods amounting to not less than two years out of the four years immediately preceding the date of registration;
- or
- (c) on the day of the issue of a writ ordering an election, he or she is otherwise qualified under paragraph (b) but has not attained the age of eighteen, but he or she will attain that age on or before the polling day at the election.

## Disqualifications of Electors

91(1) A person shall not be entitled to be registered as an elector in any electoral district who—

- subject to subsection (2) is serving a sentence of imprisonment (by whatever name called) exceeding twelve months imposed on him or her by a court in any country or substituted by competent authority for some other sentence imposed on him or her by such a court, or is under such a sentence of imprisonment the execution of which has been suspended;
  - is a person certified to be insane or otherwise adjudged to be of unsound mind under any law in force in the Cayman Islands; or
  - is disqualified for registration as an elector by any law in force in the Cayman Islands relating to offences connected with elections.
- (2) For the purposes of subsection (1)(a)—
- where a person is serving two or more sentences of imprisonment that are required to be served consecutively he or she shall, throughout the whole time during which he or she so serves, be regarded as serving a sentence exceeding twelve months if (but not unless) any one of those sentences exceeds that term;
  - no account shall be taken of a sentence of imprisonment imposed as an alternative to or in default of the payment of a fine; and
  - no account shall be taken of a sentence of imprisonment imposed by a court outside the Cayman Islands other than a sentence on conviction of an offence constituted by conduct which, if it occurred within the Cayman Islands, would constitute an offence punishable under the law of the Cayman Islands by imprisonment of twelve months or any greater punishment.
- (d) A revised list containing the names, street address and occupation of all persons qualified to vote in the said district –
- whose names appear in the current Register of Electors; or
  - who have submitted to the registration officer a duly completed and signed application for registration in Form 4 will be available at the Elections Office in George Town, the District Administration Office in Cayman Brac and the Post Office in Little Cayman for a period of twenty-one days beginning on the **19th day of July, 2024**.
- (e) copies of Form 4 may be obtained at the following places –
- any post office or sub-post office;
  - the registering office for any electoral district; or
  - the Elections Office
- (f) The registering officer for the electoral district(s) is **Kerry Nixon**.

A Private Members Motions moved by West Bay West Member of Parliament, the Honourable McKeeva Bush, and seconded by Bodden Town West Member of Parliament, the Honourable Chris Saunders seeks to increase Caymanian ownership of businesses.

Private Members Motion No. 12/2023-2024 states:

*“Whereas the Cayman Islands Constitution Order 2009 affirms the Cayman Islands as a country that manages growth and maintains prosperity, while protecting its social and natural environment*

*And whereas the Section 16 (4) of the Cayman Islands Constitution Order 2009 recognises that preference may be given to Caymanians with regards to ownership of businesses;*

*And whereas the Trade and Business Licensing Act recognises that Caymanians should own and control non less than 60% of a local business;*

*And whereas the number of Local Control Licenses issued is more than 200;*

*And whereas our Islands continue to develop at a fast rate;*

*And whereas business opportunity continues to grow as the population has increase;*

*And whereas Caymanians are feeling left out due to the many foreign nationals being involved in certain businesses;*

BE IT RESOLVED that Government takes immediate steps to amend the Trade and Business Act to increase the percentage ownership by Caymanians from 60% to 100% for the following business activities:

1. Real Estate sale and property management companies

2. Construction businesses up to KYD \$1.5 Million

3. Car Rentals

4. Water-sports operations

5. Light technology up to KYD \$2.5 Million

BE IT FURTHER RESOLVED that Government places a moratorium on the issuance of Local Companies Control Licenses.

BE IT FURTHER RESOLVED that Government immediately takes the necessary steps to ensure that properties in Cayman are only purchased and set aside for Caymanians only, by the following means:

1. That foreign developers building apartments, hotels and such developments pay to the Government a 5% fee off the top of the value of said developments;

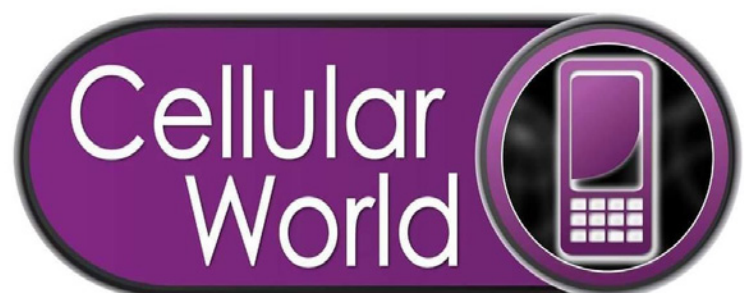
2. That such funds be set aside by the Government to purchase properties that are earmarked to be purchased by Caymanians only;

3. That when such properties are pur-

chased by Caymanians it cannot be used for “land banking” and can only be sold another Caymanian; and

4. That the maximum amount of lot that can be bought by any Caymanian through the above means by two lots.

BE IT FURTHER RESOLVED that Government takes the necessary steps to ensure that the Cayman Islands Development Bank is given the necessary resources to assist qualified Caymanian businesses and qualified Caymanian entrepreneurs with the necessary funding to engage in business activities that are owned 100% by Caymanians.”

A new Incinerator is in full operation to process the biohazardous waste generated in the Sister Islands. Located in the Cayman Brac landfill, the new equipment was inaugurated by the Premier Honourable Juliana O'Connor-Connolly on Friday, June 21, 2024.

"It was an honour to have the Premier cutting the ribbon to mark the formal opening of this new incinerator serving the communities of Cayman Brac and Little Cayman. This new state-of-the-art equipment is ensuring the safe disposal of all biohazard waste generated in the Sister Islands", said the DEH Director, Mr. Richard

ard Simms.

The incinerator is an MP-500 manufactured and installed by Addfield Environmental Systems Limited from the UK. It has been specified to handle the type and quantity of medical waste generated in the Sister Islands.

The whole equipment is enclosed within a weather proof 20ft container. The benefits of this type of installation included reduced civil and building works requirements, in addition of extremely quick installation time and added mobility, should it be required to operate at another location in the future.

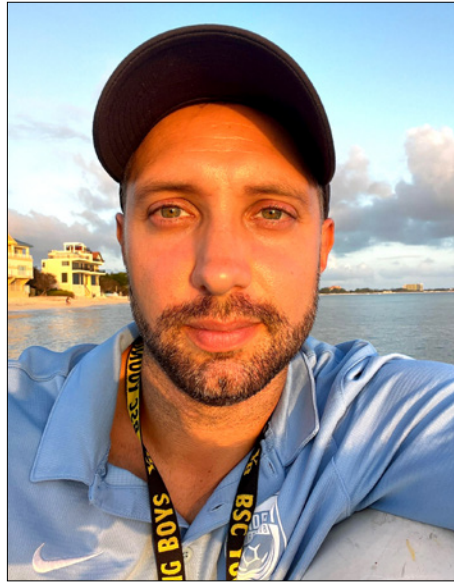

## Step Four: Rest

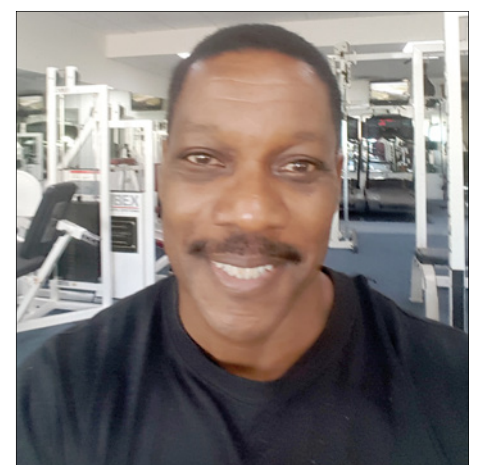
As relaxing as vacation days are, most end with the feeling of exhaustion. Make catching up on sleep a priority over the next few days.

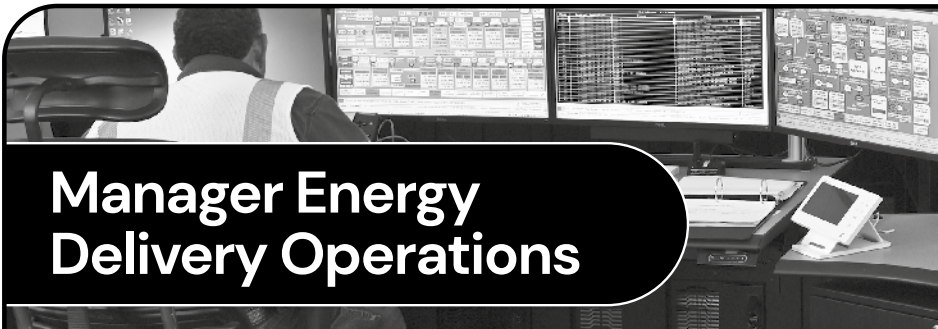

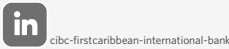
