







Residents and visitors in the Cayman Islands are bracing for Hurricane Beryl as the storm barrels toward the Islands, after making landfall on Carriacou, Grenada early Monday morning.

The storm, which is being fueled by record warm waters now holds the distinction of the earliest category 4 storm recorded in the Atlantic, taking just 42 hours for the storm to transform from a tropical







Constitution Day message from His Majesty the King

Sanitation During and After a Hurricane

The Water Authority would like to urge the general public to have adequate quantities of potable water. They should also have a sufficient supply of water to flush their toilets if there is an interruption in the piped water supply.

Water can be stored in buckets for non-potable use, should piped water not be available. To conserve water, remember to only flush solid waste by pouring water into the tank.

In case you run out of non-potable water prior to the restoration of piped water, be prepared to safely dispose of human wastes, especially Number 2. Proper disposal of per-



sonal waste is very important in order to minimize public health hazards. Using basic materials, suitable temporary disposal may be accomplished by placing waste in a watertight plastic bag and securely closing the bag. Collect and store all such bags in a large, sturdy garbage bag in a safe and restricted area until DEH can collect it.

depression to a major hurricane According to the National Hurricane Center, "This is an extremely dangerous and life-threatening situation," with the storm continuing to strengthen.

At Press time on Monday the Cayman Islands were under a Hurricane alert with stores around the Islands being swamped with shoppers seeking supplies and scurrying to scoop up whatever goods they could in preparation for the possibility of the storm making landfall in the vicinity of the British Territory on Thursday.

Cayman Islands Premier, the Honorable Juli-O'Connor-Connolly ana convened an emergency Caucus meeting on Sunday 30th June to address preparations for the possible arrival of Hurricane Beryl.

The meeting focused on coordinating efforts to ensure the safety and well-being of residents and visitors of the Cayman Islands in anticipation of the hurricane's potential impact.

These included:

from the Cayman Islands' National Weather Service, which were reviewed to understand the potential risks and impact areas.

2. The Emergency Response Plan: Strategies for emergency response and resource allocation to ensure readiness.

3. Efforts to coordinate with local agencies and emergency services to streamline response efforts.

4. The Public Communication Plan: A comprehensive communication plan that was developed to provide timely advisories and instructions to the public.

5. Additional Preparations: Other urgent matters related to hurricane preparedness were addressed to enhance overall readiness.

Premier O'Connor-Conolly emphasized the importance of prompt and decisive action to safeguard the community, with all caucus members actively participating and bringing their concerns and recommendations to the planning and decision-making process.

As the storm pummelled Carriacou; one of the islands of Grenada, winds increased up to 150mph (240km/h) on Monday.

Hurricane warnings were in effect for Barbados, Grenada, St Lucia, Tobago, and St Vincent and the Grenadines as thousands of people hunkered down in homes and shelters hoping for the best.

20 years ago, Hurricane 1. The latest updates Ivan made landfall in Grenada, when it passed directly over the island on September 7, 2004 with winds of over 135 mph (217 km/h). The island, in the words of a Caribbean disaster official suffered "total devastation." at that time, with at least 89% of the small island - or 28,000 of 31,000 homes experiencing damage.

Residents in the Cayman Islands who were in Grand Cayman during 2004, will also remember the fury of Hurricane Ivan, which hit our shores as a Category 5 Hurricane, ripping up the Island's shoreline and leaving rubble in its wake.

Caymanians, visitors and residents are hoping history will not repeat itself and have been watching the situation in the Caribbean Sea very closely.

Hurricane Beryl is the second named storm of this Hurricane Season, which is expected to be the busiest ever with an estimated 23 named storms.



Getting ready for Beryl's approach



Caymanian Times Publisher spoke with Cayman Islands National Weather Service Director General John Tibbetts and Dani Coleman, Director of Hazard Management Cayman Islands, about preparations for Hurricane Beryl.

Dani Coleman said that government was ready to go as far as preparations were concerned in the lead up to Hurricane Beryl's possible impact on Wednesday and they were also working hard to ensure the public was likewise fully prepared. Meetings had taken place on Monday at a high level and the NRA and Public Works Department were working together to ensure sand was being made available for people to use for sand bags. Sandbags were being targeted for the most vulnerable communities, Ms Coleman said, and they were working with MPs to ensure the most vulnerable had them.

She acknowledged that there was a lot of work ahead of her department.

"The same amount of work and preparations go into a Cat 5 as they do a tropical storm," she confirmed. "We wouldn't want to be caught off guard." Mr Tibbetts said at the time of the interview Hurricane Beryl had just passed through Grenada with 150mph winds. They had been monitoring the system from the time it was a tropical wave since it was out east in the Caribbean and had watched it develop.

"Everybody is looking at thing in amazement," he said. "It is ground breaking in that we don't usually get Cat 4 hurricanes at this time of the year. Usually storms that occur in June are weaker in nature. You might get a Cat 1, but certainly not a Cat 4, so we weren't expecting that level."

The system was moving WNW at about 20mph and was forecast to weaken as it approaches Jamaica and then the direction has it skirting around 125 miles south of Grand Cayman, he said. That put Grand Cayman within the arc that would receive tropical storm force winds. The sister islands were on the outer fringes of it, just outside the range of tropical storm force winds, so it looked as if the sister islands were going to be spared.

"The track has really been dancing north and south so we really need to get a handle on exactly where this storm is going to," he stated.

Trust the experts


Mr Tibbetts said the public should beware of "armchair experts" who were not qualified to post information, especially when they scare-mongered about estimated wind gusts that were unlikely in the Western Caribbean, where the storm was expected to weaken.

Ms Coleman said that it depended on the magnitude of the storm as to how many shelters would eventually open. All were ready to open and all staff manning them were fully trained, she confirmed. They are working closely with Fosters for extra supplies if they need them.

"The system is very well versed. We have rehearsed it over and over again so everybody can sustain it," she said, stating that the staff were all prepared to go when the storm hits and afterwards doing post work such as damage assessment etc.

Keep vigilant

Mr Tibbetts said that he was concerned





that if Beryl missed Cayman, people would be too complacent about another storm coming later in the year following the same track.

"If you come with that mindset, you might be caught in a very compromised position," he worried. "Each storm is different."

The fact that the storm looked as if it was weakening as it was coming into the western Caribbean was highly unusual.

Ms Coleman said they were so many variables to storms, and people needed to take into consideration many differences to the island in comparison to 20 years ago when Ivan hit. There was new development on island, as well as a lot more people on the island, which made for variables from a human, scientific and geographical perspective.

What to expect

The rainfall forecast was just 3 to 6 inches which was quite unusual, Mr Tibbetts said, as he expected more, but the fact that Cayman was already saturated didn't bode well for Cayman. The system was going to be close to Hurricane Grace, he believed.

The system was expected to be a Cat 1 to 2 passing to the south of Cayman so still quite different to Grace which was an intensifying when it hit Cayman.

Ms Tibbetts said the National Hurricane Centre was expecting a surge of between 6-9 feet along with the hurricane as it was currently, and Cayman was expecting about 5 feet of storm surge. He said they had been advised that the storm surge, combined with the wave action, would possibly see wave heights from 17 to 21 feet. Tides had been running high so that added to the complication but the storm was coming in on a low tide. The bulk of the impact from storm surge would be on the south coast, he believed.

Ms Coleman said it was essential that people had their family hurricane plans in place, especially for children and pets.

"We just want to make sure everybody is ready to go no matter what this week holds," Ms Coleman stated.

Ms Coleman wants people to download the National Emergency Notifications system App to be found at https://nens.gov.ky/ so they could keep up to date on everything that was happening.

Mr Tibbetts said that Cayman would be on the backside of the storm some time on Thursday when it would be south west of Cayman, so by that time the tropical storm force winds would have subsided.

Ms Coleman said the all clear as based on the weather, damage assessment, road issues, medical transportation issues, and so forth.

"Please don't come out unless you really have to in the first few hours. Keep informed and make sure you know your hurricane flags and you're constantly tuned into official sources," she advised.



Cayman Islands Visitation Climbs Steadily as the Destination Sees a Significant Increase of Inbound Seats and Flights

The Cayman Islands are experiencing a steady uptick in visitation, with the destination recording 34,882 total stayover arrivals in May 2024, an increase of 452 visitors compared to May 2023.

To date, the country has welcomed 209,135 visitors reaching 90% of 2019's total stayover visitation between January and May 2024. This figure marks the second highest visitation recorded for a calendar year after 2019 and represents a 7.3% increase from 2023.

The United States continues to be the largest source market for stayover visitors in the Cayman Islands, contributing 83.2% of total visitation. In May 2024, US visitors accounted for an 84.7% share of total arrivals, closely on par with the 85.2% in May 2023.

Canada remains the second largest source of visitors for the destination at 7.5%, followed by Europe at 4.8%, maintaining similar figures from 2023. Notably,

arrivals from Canada grew by 34.1% in May 2024 compared to May 2023, representing a 5.2% share of total stayover arrivals, up from 4.0% in May 2023.

Arrivals from the UK and Ireland totalled 7,041 for January-May 2024, a 3.9% increase from 6,778 in 2023, maintaining a 3.4% share of total year-to-date stayover arrivals.

Visitation from Continental Europe also saw a substantial rise in January-May 2024, with arrivals up 14.8% from 2023, contributing a 1.4% share of total yearto-date stayover arrivals, up from 1.3% in 2023. Germany, Italy, Switzerland, and France were the top European countries for visitation in May 2024. Latin American arrivals were up 2% in May 2024, but impressively, South American arrivals increased by 25.8% compared to May 2023.

Increasing Airlift

May 2024 was an auspicious month for inbound seat capacity and flights to the Cayman Islands. According to the International Air Transport Association (IATA) there were 363 flights in May 2024, up 31 incremental flights from May 2023.

Inbound airline seats from the US, UK, and Canada rose by 7% from May 2023, jumping from 57,121 to 61,051 in May 2024. The most sizable increase of inbound seats was from Canada, which saw a 65% rise with 2,331 more seats compared to May 2023. This growth in number of flights and inbound airline seats sets a positive outlook for the future with Summer 2024 bringing more flights to the destination:

• Starting June 2024, American Airlines will continue its daily summer service from Dallas and add a Saturday flight from 4 June to 5 August, 2024.

• Southwest Airlines has launched a daily service between Orlando and Grand Cayman as of 4 June 2024.

• JetBlue Airways will add a second flight from Boston on Mondays starting 28 October 2024 providing visitors the option to travel nonstop to Grand Cayman on Saturdays and Mondays.

• Sun Country Airlines will begin offer-

ing twice-weekly flights from Minneapolis to Grand Cayman from 20 December, 2024, to 12 April, 2025.


• Starting 20 December 2024 Delta will be offering three weekly flights from Minneapolis-St. Paul to Grand Cayman

Commenting on the growth in visitation in Q1, increased airline seat capacity from key source markets and new upcoming flight services to Grand Cayman, Mrs. Rosa Harris, Director of Tourism shared, "We are pleased to see the steady growth in visitation to the destination continue from Q1.The Cayman Islands is an attractive destination in the Western Caribbean and our tourism product offering is further enhanced by additional room stock with the opening of boutique hotel VIDA Cayman Islands in Barkers West Bay and Hotel Indigo Grand Cayman on Seven Mile Beach. With a successful combo of new accommodations and increased flights services, The Cayman Islands Department of Tourism anticipates that that our tourism performance will continue on a strong recovery trend."

UWI gets a 100% global ranking New Times Higher Education Impact Rankings reveals perfect score for 'SDG Partnerships'

The University of the West Indies' (The UWI) strategy of focusing on the United Nations' Sustainable Development Goals (SDGs) in building out its academic reputation and global research profile has produced a perfect score in the latest Times Higher Education (THE) Impact Rankings. Over the past decade, the University has strategically established joint global centres and initiatives with other respected universities to provide advocacy and development outcomes around sustainable development. Impressively, within THE's series of metrics used to evaluate the performance of the individual SDGs, The UWI earned a perfect score of 100% for its relationships to support the goals in pursuit of SDG 17: Partnership for the Goals.

Vice-Chancellor Professor Sir Hilary Beckles responded to Times Higher Education's report, saying, "Our vision for

The UWI requires the implementation of multiple strategies, and we are very

proud that the work of our faculties in particular has won the recognition of the global university environment. This is a great moment for The UWI".

THE's Impact Rankings identify and celebrate universities that excel in advancing multiple SDGs, evaluating their research, stewardship, outreach, and teaching. The UWI also earned notably high scores in collaborations and health services in assessing SDG 3: Good Health and Well Being; for its proportion of women receiving degrees in assessing SDG 5: Gender Equality, for environmental education measures as part of its Climate Action (SDG 13) and Research into partnerships for the goals under SDG 17.

The school combines The UWI's two decades of experience and excellence in online education with its steadfast commitment to the SDGs, making it a pioneering institution in this field.

This is The UWI's fifth consecutive year participating in the prestigious global impact rankings.

Although the University has consistently been ranked among the best in the world by THE, recognition in this niche area of SDG impact is significant as it acknowledges the intentional generation and dissemination of knowledge to support various UN goals as part of The UWI's strategic plan. on The Further Delayed Project ReGen

My Progressive Opposition colleagues and I, along with many Caymanians and residents, are deeply disappointed with the Government's absolute failure to make meaningful progress with the ReGen Sustainable Waste Management Project.

This lack of progress, as reported in the media, has left the Project Financial Close agreement and the Environmental Impact Assessment process in a state of limbo. A situation that three years of dithering and delay by the PACT/UPM Government have put them in.

This Government's failure to complete the work on the financial close, having missed the project deadlines time and time again, has significantly increased the project costs for the country and its citizens. These inexplicable delays have created uncertainty and risk.

The PACT/UPM Government's term will end in about ten months, and the country will have regressed in providing a sustainable solution to our waste needs and failed to close the current landfill. This inaction could lead to significant environmental and financial consequences.

ReGen was that sustainable solution, and if completed, it will provide the country with an environmentally friendly waste management system that would vastly reduce landfill needs

for many decades. Composting and recycling would increase significantly, and the project will also provide Grand Cayman with sustainable 'energy from waste' that would be sold to CUC and help to deliver our energy transition targets. It would also safely extract the landfill gas trapped in 'Mount Trashmore' for electricity production. Landfill gas that now contributes to dangerous fires and leaks into the atmosphere at a rate of about 23,000 tonnes a year is an environmental hazard. The landfills in Cayman Brac and Little Cayman would be closed, and garbage would be shipped for processing at the ReGen facility in Grand Cayman. Without ReGen, that will not happen.

That sustainable waste solution is within our grasp if the Government can complete the contracting process, but I am increasingly concerned that all the benefits of ReGen are being thrown away.

During the 2023 budget session, Minister Katherine Ebanks-Wilks, the Minister of Sustainability and Climate Resiliency, confirmed that funds were budgeted to cover two years of work on the landfill project. I also understood that the ReGen Financial Close was still in progress.

However, six months later, the ongoing delay in finalising the ReGen project, with the Government saying nothing, is increasingly concerning.

Meanwhile, the periodic dump fires and the smell from the landfill are constant reminders of the urgency and importance of solving this issue - action is needed now.

As I have often said, Project ReGen is not only the best waste management solution for our Islands but also the single most significant sustainability project currently envisaged by the Government. Its importance cannot be overstated, and we are running out of time to implement it. Minister Sabrina Turner, who has Ministerial responsibility for the George Town Landfill, confirmed in the House in February that if the Government fails to complete the ReGen waste-to-energy project, the country will have to continue landfilling at a new site. She did not say where this would be — whether in Bodden Town, West Bay, North Side, East End or perhaps another 'George Town dump'.

Residents across our Islands are rightly concerned that their community may yet be targeted as the site for a new dump.

The Government must come clean and advise the country at the next meeting of Parliament in July on what is happening with the ReGen project and whether any progress will be made before the next election.

If no solution is forthcoming, tell the country where they have identified to begin a new Landfill. What is the expected timeline for developing it, and what is the anticipated cost? How would the disastrous environmental impacts of such a decision be mitigated? What abortive contract costs would have to be written off?

There are more questions than answers because the PACT/UPM Government has continued to fail to complete the ReGen contract and remain silent about its plans for waste management.

CUC ANNOUNCES SUBMISSION OF CERTIFICATE OF NEED FOR RENEWABLE ENERGY

Caribbean Utilities Company, Ltd. ("CUC" or the "Company") has submitted a Certificate of Need ("CON") as outlined in the Company's Transmission and Distribution Licence (2008). The CON is defined as 'a certificate that the Licensee prepares and submits to the Authority, which sets out the Licensee's requirement for the incremental amount of capacity for which the Authority would solicit'.

The National Energy Policy ("NEP") 2024-2045, outlines that the Cayman Islands is to transition to 70% renewable energy sources by 2037 and 100% renewable energy resources by 2045. CUC is an advocate of adding more renewable energy to the grid that will allow for cleaner and more cost affordable energy for the people of Grand Cayman.

CUC's Transmission and Distribution ("T&D") Licence calls for CUC to issue a CON to the regulator when CUC identifies the need to procure firm capacity resources needed for the reliability of the grid. However, CUC has identified more sustainable renewable energy resources augmented by smaller quantities of firm capacity that could be procured to provide the required level of reliability to the grid for the peak demand season of summer in 2027. This submission, should it be accepted, will allow for the targets of the NEP to be realized as well as to substantially reduce costs to consumers.

In August 2021 CUC submitted a proposal for utility scale solar combined with battery storage to add "firmness" to meet the identified 2024 capacity requirement as an alternative to a CON for firm diesel capacity. The Company received approval of this alternate request from the regulator with the generation to be procured through a competitive bid process. Any renewable energy resources added under the 2021 request will reduce the amount needed to be procured to satisfy this CON.

In July 2023, Grand Cayman reached a historic peak load of 124.1 megawatts ("MW") of energy demand. This historic peak was exceeded in May 2024 when a new peak load of 127.9 MW was registered. Peak demand in August 2021 was 113.5 MW.

In recognition of the changing and growing need for energy on



Grand Cayman, the submitted CON calls for a combination of 36.1 MW of firm capacity and 100 MW of solar plus storage to be connected by June 1st, 2027. Should the Company's certificate of need be accepted, the procurement of the proposed resources will reduce costs to consumers and meet or exceed, the incremental NEP 2027 targets allowing for 39% of renewable energy penetration to be achieved by 2027 and a reduction in the 2019 CO2 emissions by 28%. Labour set for big win

Voting is imminent in the UK general election on Thursday (4 July) and the polls indicate this election is already over as a contest and has been pretty much since the vote was called six weeks ago.

Last Wednesday night was the final head-to-head debate of the campaign and it was also realistically Prime Minister Rishi Sunak's last chance to make a dent on Labour leader's Keir Starmer huge lead in the polls. But, like previous debates, it was pretty much an insignificant affair.

Sunak went on the offensive for the Conservatives, repeatedly interrupting Sir Keir and accusing him of lying to voters about not putting up taxes if elected to government. Nevertheless, a snap poll immediately after found that Sunak made little or no difference to people's perception of Labour, who are clearly heading for a huge majority win. It has been a faltering campaign from the Tories, clearly poorly choreographed from the outset.

It all started outside 10 Downing Street, Sunak getting drenched in the pouring rain, while Labour's iconic 1997 campaign tune 'Things can only get better' blared from speakers nearby. And the Conservatives have never gained any momentum since then.

There was the D-Day outrage, when Sunak drew widespread criticism for leaving World War II commemorations in France early to return to the UK for a TV interview.

In recent weeks the Conservatives have been dealing with at least five party members privy to the date of the election betting on that information before it was called by Sunak. Labour is also under the spotlight, but to a much lesser extent; a Labour candidate bizarrely bet on himself to lose.



Labour voters will turn out in force

Nigel Farage's Reform Party became the latest party to generate controversy, last week. Some of its campaigners were filmed by an undercover TV team reportedly making anti-immigrant, homophobic and racist comments.

Polling for the election indicates the Conservatives are losing support mainly to Labour on the left, but also to Farage and Reform on the right.

And the potential irony of people voting for Reform is that they will split the vote on the right of the spectrum and hand a lot of easy seats to Labour, thereby making Starmer's path to lead the country much easier.

Analysts no longer question whether Labour wins a majority, but just how big that majority will be.

Latest polling from YouGov - one of the prominent election research companies in the UK - has Labour on 37%, 17 percentage points clear of the Tories. But that gap was 21 points earlier in the campaign. Nevertheless, a big Labour win is clearly guaranteed.
