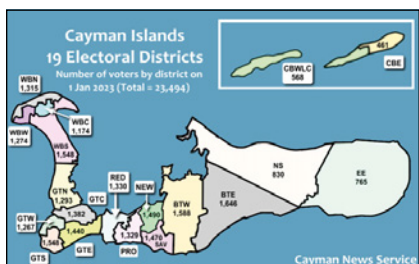

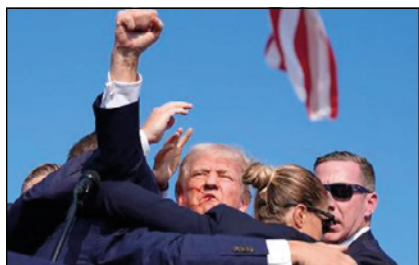

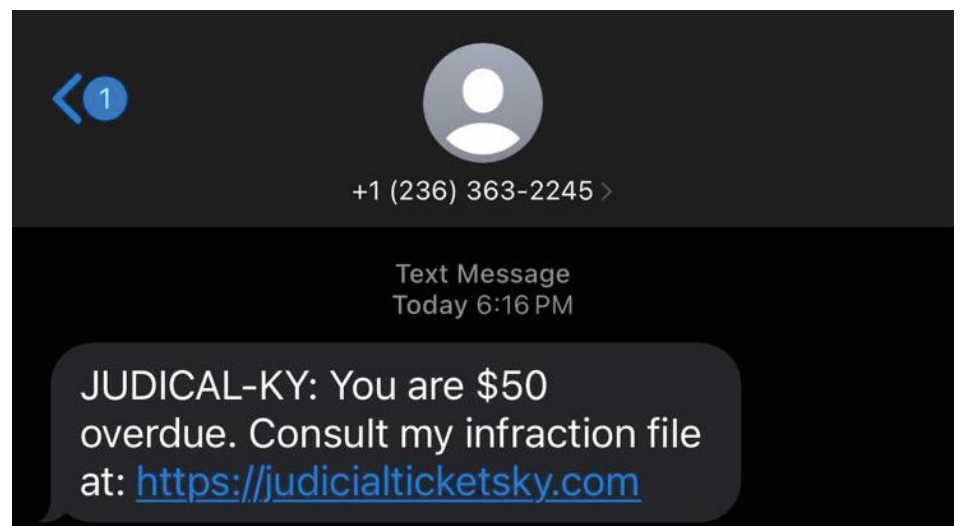

Renewal Deadline Approaches for Liquor Licensees

Holders of liquor licences, including licensees with music and dancing licences, in Grand Cayman are reminded that the renewal deadline for these licences is 4pm on 16 August.

Renewal applications must be submitted to the Department of Commerce and Investment either online, or via its first-floor counter in the Government Administration Building, by the deadline in order to be added to the meeting agenda. The counter is open Monday to Friday, 9 am to 4 pm.

Decisions for renewals will be made at the annual liquor licensing session on 3 September. The new licence period begins 1 October 2024.

License holders are also advised that licenses expiring on 30 September 2024 must be renewed at this annual session if

they are to operate for the new license period.

World-renowned Physician Dr Devi Shetty Unveils Second State-of-the-Art Facility on Grand Cayman

healthcare throughout the Cayman Islands and beyond.

The new 70,000-square-foot hospital, built for over US\$100 million, includes a state-of-the-art Intensive Care Unit (ICU) and a Post-Anesthesia Care Unit (PACU) with 12 fully equipped beds for critical and post-operative care. The spacious inpatient facilities feature private rooms and a VIP Suite designed for optimal comfort and efficient recovery.

Complementing the flagship tertiary care hospital on East End Grand Cayman, the Camana Bay facility features an Emergency Room (ER) equipped with 10 beds to handle a wide range of urgent medical situations promptly and efficiently. The Level 3 Neonatal Intensive Care Unit (NICU) features four specialised beds for

critically ill newborns and one family-integrated care room to promote family involvement. Additionally, the hospital offers labour and delivery suites, including three modern labour and delivery beds and three triage beds, ensuring a comfortable and efficient birthing experience.

"Health City at Camana Bay represents a significant advancement in healthcare infrastructure, ensuring that residents and visitors have access to comprehensive, top-tier medical services," said Dr Devi Shetty, founder of Narayana Health, Health City's parent company. "From emergency care to specialised treatments and advanced diagnostics, our facility is poised to set a new standard in healthcare excellence across The Americas," he added.

Health City at Camana Bay also provides dedicated kidney dialysis care with two specialised beds and cutting-edge diag-

nostic imaging services, including a 3T MRI, PET CT, and a mammogram machine, ensuring accurate diagnosis and treatment planning.

This state-of-the-art medical campus features a robust robotic surgery programme and a Radiation Oncology Centre, which opened in March 2023. This will later expand to offer comprehensive and advanced oncology, including bone marrow transplantation and CAR-T Cell therapy, enhancing the medical oncology, hemato-oncology, and surgical oncology services already available.

"Our new medical campus expansion will provide greater healthcare security for the Cayman Islands and the region, offering residents and Caribbean nationals access to more services without the need to travel further afield," said Health City Chief Business Officer Shomari Scott. "It ensures all major medical-care gaps are covered, safeguarding the ongoing health

and safety of our people," he said.

"The new Cancer Care Centre, along with our existing cardiac, orthopaedic and other specialty facilities, will ensure that no Cayman patient will ever need to leave our shores for treatment, and no Caribbean national will need to navigate the costly and complex healthcare systems abroad for treatment," stated Dr Binoy Chattuparambil, Health City's Clinical Director and Chief Cardiac Surgeon.

Narayana Health brings extensive bone marrow transplant experience. This, along with collaboration with Dana-Farber Cancer Institute, a Harvard Medical School teaching affiliate and a global leader in cancer care and research, means Health City will continue providing outstanding oncology care services for domestic, regional and international patients.

Cayman Enterprise City (CEC) is thrilled to announce the installation of vibrant new artwork by Caymanian Digital Artist, Michael Mothen also known as “BananaArtKid”, at the Rotary Central bus shelter on Fairbanks Road. The project is part of a “Digital Artist in Residency” initiative, which supports Cayman’s digital artist community through innovative projects, programming, and creative workspaces.

The CEC Digital Artist in Residency initiative, in partnership with Enterprise Cayman and Notable Island, is designed to elevate the profiles of local digital artists by providing opportunities for exhibitions, professional development, and brand collaborations. The programme aims to foster a dynamic art scene while supporting

artists who are creating new work using innovative technology. The Digital Artist in Residency programme will initiate the launch of CEC’s corporate art collection and the bus shelter takeover is the first of a series of projects that the artist Michael Mothen will be working to produce.

“Rotary Central thanks Cayman Enterprise City for recognizing Cayman’s local artists and congratulates BananaArtKid for teaming up with CEC on this most innovative use for our bus shelter advertising panels. We are thrilled that one of our bus shelters will be used for the promotion of amazing local talent like BananaArtKid and will also help to beautify the surrounding neighborhood as well as continuing to provide much-needed shel-

ter from the elements for local citizens,” said Michaël Darchis, Rotary Central Bus Shelters Sponsorship Coordinator. CEC’s financial donation towards the bus shelter will support Rotary Central’s ongoing efforts to improve local communities, including providing essential services and improving the quality of life for residents.

The bus shelter artwork features BananaArtKid’s illustrations of the first recorded catboat, built in 1904 in Cayman Brac by Daniel Jervis, sailing at night (featured on the inner panels) and at day coming back home to Cayman (featured on the outer panel). As noted by the artist, “These sail boats were used to fish and catch turtles by our forefathers in Cayman. The order of the day was survival, and the

catboat was the tool and vessel for many. She was blue like the ocean”. Mothen’s vivid installations are filled with hidden gems that celebrate Caymanian life. Among these details are the yellow and white butterflies that flutter abundantly in the neighborhood during spring, a green sea turtle representing the island’s rich marine heritage, and a traditionally dressed Caymanian woman using a conch shell to signal the catboat’s homecoming. These elements combine to create a tapestry of local culture and beauty, inviting viewers to explore and appreciate the intricate details of Cayman’s environment and heritage.

Michael expressed his gratitude, saying, “I feel like it’s telling a story by going from day to night or night to day with the catboat coming home. It’s an honor to share my vision with the community, and I’m very grateful for the opportunity to be part of the CEC Digital Artist in Residency programme.”

CEC and Enterprise Cayman are committed to supporting local talent, creating innovative growth-oriented spaces, and fostering a dynamic community of innovators and entrepreneurs. CEC’s new Signal House facilities and 2474 Café features a series of work by Shane Aquart, who signs his art “Dready”. The work is testament to

ELECTORAL BOUNDARIES COMMISSION REPORT REJECTED!

If there's one certainty about Cayman's next general election due next year, it's that it will be conducted with the existing districts, constituencies, and electoral boundaries. The Cayman Islands currently has 19 single member electoral districts.

Those will remain unchanged despite a comprehensive review detailed in a 100-page report submitted to the Government last year by the 2023 Electoral and Boundaries Commission (EBC).

The Cayman Islands Government (CIG) Cabinet meeting report of June 27th 2024, which only started circulating publicly in the past week, confirms that the United People's Movement (UPM) administration has rejected the recommendations of the Electoral Boundary Commission appointed in January 2023.

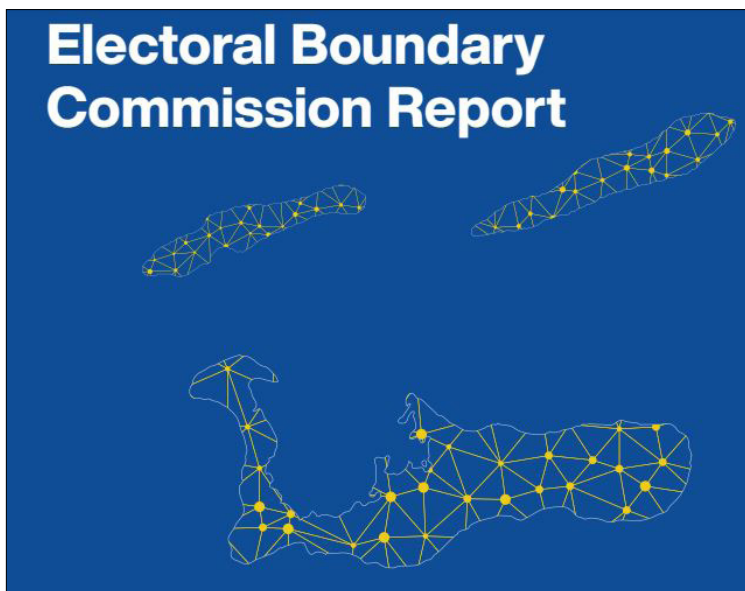
"At this meeting Cabinet approved the tabling of a Motion in the upcoming meeting of Parliament by the Hon. Premier proposing the acceptance of an Order from the Governor to reject all recommendations contained in the 2023 Electoral Boundary Commission Report and to seek the Governor's support in accordance with Section 89 (1) of the Constitution, to establish a new Electoral Boundary Commission with revised Terms of Reference (TOR) to ensure equitable representation and comprehensive consultation."

That means that the EBC report to review the district and constituency boundaries has been effectively 'sent back to the drawing board'.

It's still not clear why the report was rejected as no reason has been given by either the Government or the Governor's Office. Also unclear is the setting up a new Electoral Boundaries Commission with "revised Terms of Reference (TOR) to ensure equitable representation and comprehensive consultation."

The three-member Electoral and Boundaries Commission (EBC) set up in January 2023 by former Governor Martyn Roper,

districts."

The audience also urged that North Side and East End in particular be maintained as separate constituencies. Adjustments to other districts and constituencies were also considered.

The 2023 report narrowed down to four options with the EBC recommending that the 'six traditional districts' remain unchanged but with adjusted constituency boundaries intended to reflect a more balanced population amongst them.

"Following the dictates of the Constitution, and in keeping with the views expressed by the public during the public hearings, the approach adopted

by the EBC was to continue to respect the boundaries of the six traditional districts and to award to each traditional district at least one constituency."

It concluded: "Therefore, while every effort was made to ensure equal populations of the constituencies within the six traditional districts, there is considerable population variation across these six traditional districts."

In its report on the 2021 election, the Commonwealth Parliamentary Association (CPA) had questioned the wide population disparities across the constituencies and recommended that those should be reviewed.

had submitted its report last October following wide-ranging public consultation. It was chaired by Lisa R. Handley PhD with local attorneys Dr A. Steve McField and Adriannie Webb who had served on the previous 2015 Commission.

It's known that there have been concerns in several circles including the Opposition over the lack of action by the UPM administration on the report and its recommendations.

The commission held nine public consultations and reported that "In almost all of the meetings, members of the audience expressed strong support for constituency boundaries that respected traditional dis-

Contract Signed for Central Scranton Park

The Ministry of Tourism and Ports is pleased to announce the signing of a contract with Robson Construction, enabling work to commence on Building 1 -which, on completion will provide a fully equipped youth centre facility. The contract was officially signed on Thursday, 11 July 2024, by the Ministry of Tourism's Chief Officer Stran Bodden and Jeremy Bodden representing Robson Construction. Building construction is scheduled to commence mid- August and is expected to be completed by January, 2025.

The Central Scranton Park project, spearheaded by the Ministry of Tourism and Ports, is designed to provide a safe, communal area in the heart of George Town. The space will promote sports, recreational activities and community engagement for residents of all ages.

Covering an area of over 3 acres, the Ministry intends for the Park to be completed in two Phases. Phase 1, in addition to the construction of the youth Centre, also encompasses essential landscaping work, including the installation of water features around the pond, while Phase 2 involves the construction of a seniors' centre, a bathroom block and a multi-purpose court for various sports including basketball, football.

Tenders relating to both phases of the Central Scranton Park project are currently published on the governments Bonfire Central Procurement System. Interested parties wishing to bid on the projects have until 29 July 2024 to do so before the procurement timeline closes.

Hon. Kenneth Bryan, Minister for Tour-

ism and representative for the George Town Central Constituency expressed his enthusiasm saying, "I have been working closely with the Minister of Planning, Agriculture, Housing, Infrastructure, Transport and Development (PAHITD) and teams from the Public Works Department to develop preliminary plans and site

drawings that I look forward to sharing with the public."

"The provision of this type of facility is long overdue," the Minister continued, "as the Central George Town area has very little space allocated for community and recreation activities. In fact, studies have shown that only 0.1 percent of public open greenspace currently exists within this area, which highlights the urgent need for this type of public amenity. Once completed, the Central Scranton Park will provide a beautiful, community-friendly space that will be a tremendous asset to the George Town area, and I am confident that it will encourage residents to not only walk and exercise, but to also socialise together in a safe, communal environment."

While minor preliminary works, such as site clearing in preparation for the first stages of the park's development have already commenced, the official groundbreaking ceremony will take place on Thursday 12th September, 2024. The groundbreaking ceremony will be open to the public and the Ministry is encouraging residents from communities all across Grand Cayman to attend, as the event will provide an opportunity to view visual renderings of the park and learn more about its development.

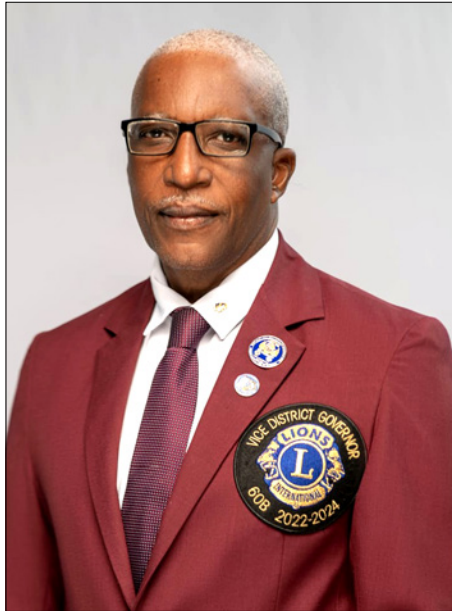
Lions around the region answer call for Hurricane Beryl relief

ASSASSINATION ATTEMPT ON FORMER PRESIDENT TRUMP

America is reeling from the attempted assassination of former President Donald Trump at a rally in Pennsylvania on Saturday.

Mr Trump who escaped with only being shot in the ear was immediately pushed to safety by his security agents and rushed off the stage.

US Secret Service agents fatally shot the assailant named as 20-year-old Thomas Matthew Crooks, who is said to have fired the shots from an elevated position outside the rally venue.

One person who was attending the rally was killed by the gunman and two other spectators were critically injured, the Secret Service said.

Moments after the shooting while he was being helped to safety by his security agents, Mr Trump could be seen with blood streaking down his face and pumping his fist in the air, urging his supporters to "Fight! Fight! Fight!"

No motive has been given for the attack on Mr Trump. A full investigation is being launched into the incident including the security cordon around the former President. His attacker Thomas Matthew Crooks is said to be a member of the Republican party.

According to media reports, one witness said they saw a man with a rifle outside the Trump rally and tried

to point him out to police before he opened fire.

Mr Trump who was briefly hospitalised after the shooting is said to be 'doing well'.

He has issued a statement on his social media platform, Truth Social saying: "God alone" prevented "the unthinkable"

from happening and called on Americans to "remain resilient" and show "our true character. We will FEAR NOT, but instead remain resilient in our Faith and Defiant in the face of Wickedness. I truly love our Country, and love you all, and look forward to speaking to our Great Nation this week from Wisconsin," he wrote.

President Joe Biden along with new British Prime Minister Sir Keir Starmer have been among the first to condemn the assassination attempt on Mr Trump, which they also see as an attack on America's democracy.

Mr Biden said there was "no place in America for this. We must unite as one nation to condemn it. It's sick, it's sick. We cannot allow for this to be happening. We cannot be like this. We cannot condone this," he added.

UK Prime Minister Sir Keir Starmer said: "I am appalled by the shocking scenes at President Trump's rally and we send him and his family our best wishes. Political violence in any form has no place in our societies and my thoughts are with all the victims of this attack."

Meanwhile, former US presidents Barack Obama and Bill Clinton have added their voices.

"Although we don't yet know exactly what happened, we should all be relieved that former President Trump wasn't seriously hurt and use this moment to recommit ourselves to civility and respect in our politics," Mr Obama said in a social media post.

Former president Bill Clinton stated: "Violence has no place in America, especially in our political process."

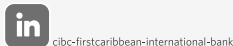
