

RE-GEN WASTE-TO-ENERGY PROJECT 'DUMPED'

An alternative to the abandoned Re-Gen waste to energy project at the George Town landfill site must now be a priority after the United People's Movement (UPM) government 'dumped' the current project proposal.

Giving a long-awaited update on the ne-

gotiations with the DART-led consortium, Hon. Minister for Minister of Sustainability and Climate Resiliency, Katherine Ebanks-Wilks, announced the termination of the project.

She was initially responding to a question in Parliament from her predecessor in that portfolio, ex-Premier Wayne Panton, who currently sits as an independent member for Newlands.

"Can the Hon. Minister update the House on the region project in particular; A - has any decision has been made? B - what are the current project dates, and C - what is the current long stop date?" the former Premier asked.

National Tourism Plan is launched

The National Tourism Plan was officially tabled in Parliament, on Wednesday, 24 July 2024 by Tourism and Ports Minister Kenneth Bryan. The NTP is being touted as a "road map for enhancing the competitiveness of the Cayman Islands tourism industry while ensuring the sustainability of our cultural and natural capital".

Minister Bryan explained that the Plan included strategic initiatives aimed at enhancing visitor experiences, promoting environmental conservation, and fostering economic growth.

"From innovative marketing campaigns to investments in infrastructure and workforce development, each aspect of this plan is designed to propel us forward on the path to recovery and success," he said.

Director of Tourism, Rosa Harris, said since its establishment, the mission of the Cayman Islands Department of Tourism had been to attract and retain visitors to the Cayman Islands by developing and implementing sustainable policies and initiatives in collaboration with all stakeholders for the benefit of our people.

In the NTP, Ms Harris spoke of the need for future-proofing Cayman's tourism product.

"The population of the Cayman Islands has grown significantly since the last version of our plan," she confirmed. "This grow-

ing population, and a growing demand from visitors to choose Cayman as their warm weather destination of choice, presents our islands with an opportunity to ensure that we not only manage tourism well, but that we also manage it sustainably."

The National Tourism plan provided Cayman with a roadmap to maximise and spread the benefits of tourism development across the three Cayman Islands, she said, but warned that a map was only useful if you follow the directions.

"To be successful, this plan requires the full partnership, participation and collaboration of all our tourism stakeholders including hoteliers, restaurants, retail, ground transportation, tours and attractions to challenge how we've done business in the past and change how we do business moving forward," she commented.

Some of the goals of the NTP include to expand and diversify Cayman's domestic tourism product, promote and grow sports and event tourism, diversify the tourism product with greater eco-tourism focus and expand into emerging and secondary

tourism markets. The Cayman Islands will be marketed to high net-worth visitors, Cayman Airways routes will be expanded, and Cayman Brac and Little Cayman will be promoted. In addition, cruise tourism would be "reimagined" and infrastructure will be increased and improved in the eastern district.

Minister Bryan said that it would be essential that Cayman remained "adaptive and forward-thinking", continuously evolving to meet the changing needs and expectations of visitors in a post pandemic environment.

"By embracing innovation, sustainability, and the aspirations of our people, we can ensure that the Cayman Islands remain a premier destination for generations to come," he said. "The recommendations in the NTP are intended to ensure that we spread the benefit of tourism development throughout the country."

Min. Ebanks-Wilks who had already prepared a detailed statement on the matter to be presented to Parliament and the nation during the sitting, confirmed that project, the largest ever planned for Cayman had been shelved. The cost over the estimated lifetime of the project is reported to have ballooned from around an initial half a billion dollars.

"Following a recent meeting of the Cabinet, it was collectively decided the Cayman Islands Government(CIG) will begin taking the necessary steps to exit the project with the Dart-led consortium in respect to the project in an effort to find a more affordable option for our country."

Prior to her taking on the portfolio responsibility, the ReGen project was handled by former premier Wayne Panton of the then-PACT coalition, which had inherited it from the previous PPM government then headed by current Speaker Sir Alden McLaughlin. The overall project planning dates back to 2017.

Calling the ReGen project "critically important", ex-Premier Panton who was directly involved with the contact negotiations, said there were "significant cost elements".

"Given what we have learned, what has led the government to conclude that doing a different procurement for the same or greater outcomes would be cheaper, would cost less?" he queried.

Min. Ebanks-Wilks replied that the Cabinet and the Government came to this decision "based on all of the different factors; the risks, the the financial constraints that the Government was going to find themselves in later down the long term forecast, and as a result of that it did not appear to be the most prudent and responsible decision to continue with the project at this stage."

She could not share any information on the question of the cost for a new procurement process but stated: "I know that is a very significant cost, and putting it back out to procurement, given all of the concerns that have been raised has given the government the decision to end the project at this stage."

Former finance minister Chris Saunders, whose exit from the then PACT gov-

ernment was reported to be linked to his concerns over the spiralling cost of the ReGen project, backed the UPM government's move.

"I just want to thank the Government for such making such a bold decision. I fully support it," he affirmed. Seeking the release of a report from the Auditor General on whether the project was value for money, Mr Saunders hinted that "the last number I saw was over US \$2 billion over 25 years."

Responding, Min. Ebanks-Wilks advised it isn't the Cabinet that determines whether that report is released, adding that: "However, value for money was also considered when we looked at the project."



The issues of the rising costs associated with ReGen project was also the focus of a series of questions by the main Opposition PPM (People's Progressive Movement) which had initiated it while in office.

One was about the stench from the dump permeating distant neighbourhoods.

PROGRESSIVES SHRED DECISION TO SCRAP RE-GEN PROJECT

The main opposition Peoples Progressive Movement (PPM/Progressives) has blasted the United People's Movement (UPM) government's decision to scrap the ReGen waste-to-energy project at the George Town

Following a series of probing questions in Parliament, the Progressives issued a press statement targeting what it called the governments failure over the issue.

"The Government's decision to abandon the ReGen project is not just a failure of good governance and political will but a pressing issue that demands immediate attention. It represents a devastating setback to the sustainable development of the Cayman Islands," the party stated.

According to the letter signed by Progressives leader Roy McTaggart, while they understand the need for financial prudence, the Government's abrupt cancellation of the Re-Gen project without presenting a viable alternative is a significant setback for the Cayman Islands."

It said the landfill remains an environmental and fire hazard, and with its capacity nearing exhaustion, this decision puts the community at immediate and significant risk.

"The Minister stated that the landfill still had another 5-6 years of capacity. With recent population growth and increasing waste volumes, this must be at the very upper end of estimates. Even if she is correct, the Government must locate another landfill somewhere as it is now inevitable that Cayman will need more landfill space."

The opposition party argues that it will take time to find and prepare any new landfill area, and poses the question: "Have they identified a location? Which community on our Islands now faces being blighted by a new landfill location because of this Government's failure?"

It also dismissed the claim by Hon. Min. for Sustainability and Climate Resiliency, Katherine Ebanks-Wilks' that the project had become too expensive. According to the Progressives, that "resulted from the dithering and delay from the PACT and the UPM Gov-

ernment over the past three years. The fact is that this Project has never been a priority for the Government.

While in government, the Progressives had initiated the start of the planning and negotiations for the waste-to-energy project in 2017, the largest infrastructure undertaking ever in the Cayman Islands.

"The Progressives, who initiated the negotiations, have consistently prioritised the ReGen project as a solution to the waste management issue," the party said defending its record on the matter.

It says the projected costs have now reportedly escalated from an initial \$670 million to an unsubstantiated \$2 billion, for which it blamed the last two governments.

"There is no doubt that the Government irresponsibly delayed the Project following the election, and no progress was made to meet the deadline for financial close that had been agreed. The then-premier told the Country he had other priorities. The Country has been left to count the cost of PACT getting the priorities wrong. That mistake caused the Country to lose the cost certainty contained in the agreement signed by the Progressive administration."

The Progressives say they pointed out then and have repeatedly warned since that "the consequence was inevitably skyrocketing costs and increased risks - the very things the





Minister has now said have prompted her decision to abandon the Project."

The party also said that it is unimpressed by the Min. Ebank-Wilks statement that the Government will now go back to the drawing board by revising the solid waste management strategy and then starting a new tender process from scratch.

"Quite apart from the ongoing risks that the time this will take will cause, has she thought through the deliverability of that approach? Who in the market will want to tender for the new Project after witnessing this failure to

get the ReGen project over the line after seven years of negotiation?", the PPM/Progressives wondered in their statement.

According to the Progressives, at the very least, potential contractors will attach a significant risk premium to any bids they make.

"There are significant questions that the Minister must answer. .. The Minister's decision to abandon ReGen has created more uncertainty and risk for our Country. We must ensure that the right path is now taken out of the chaos caused by the Government's dithering and delay."

The course will be offered in person, with expert instructors available to guide students through the theoretical aspects and the crucial hands-on technical skills in the practical sessions.

Students will be assessed at intervals throughout the course and have a summative assessment at the end of the programme to ensure they have met the standards to sit the accreditation examination.

Kamarla King, a phlebotomist of 14-years who works in the HSA's Pathology Laboratory, stated that the profession of phlebotomy is crucial to the

healthcare field: "As a phlebotomist, I've seen firsthand how a single vial of blood can unlock answers to life's most pressing health questions. We draw and collect blood for laboratory tests, transfusions, research, or blood donations—helping to connect a patient's symptoms and their solutions. Reminder to Submit Declarations to Register of Interests

The Commission for Standards in Public Life (CSPL) reminds all Persons in Public Life to submit their 2024 declarations to the Register of Interests by Tuesday, 30 July. In accordance with the Standards in Public Life Act, Persons in Public Life are required to declare their interests, income, assets and liabilities for the annual period ending 30 June 2024.

Declarations may be submitted online via the Register of Interests portal, which users can access with their Cayman Islands Government eServices account. Using the portal is easy and convenient, with features such as auto-save, the ability to duplicate declarations from previous vears and the convenience of being able to view all previously submitted declarations in one location. Tutorial videos, guidance notes and FAQs are also available on the

CSPL website to assist with the declaration process.

The following persons are required to submit annual declarations utilising Schedule 1:

- · Members of Parliament, including the Speaker.
- · Chief Officers and Deputy Chief Of-
- · Chief Financial Officers and Deputy Chief Financial Officers.
- Heads of departments, sections or units and their deputies, as well as any other organised entity within a ministry or portfolio, statutory authority, statutory body, government company, department, section or unit and their deputies.
- Chief executives of statutory authorities, government companies and their
- · A person holding a full-time or parttime position in a public authority who engages in an activity that is in conflict, is likely to conflict, or may be perceived to conflict with, his position in a public authority.

The following persons are required to submit annual declarations utilising Schedule 2:

· Members of governing bodies of statutory authorities.



- Members of governing bodies of government companies.
- Members of all Commissions created by or under the Constitution.

2024 National Gun Amnesty extended

The RCIPS is currently in its fourth week of the National Gun Amnesty which began on the 1st July, 2024. So far, two firearms along with a significant amount of ammunition and two spear guns with additional spears have been handed into police.

Due to the disruption caused by the passing of Hurricane Beryl, the RCIPS is extending the Gun Amnesty until Sunday 11 August. Until this date, persons will be able to hand in all illegal guns, gun components and ammunition without fear of prosecution, no questions asked.

"We are grateful that members of the community have been taking advantage of the gun amnesty, however, we know that there are at least 90 illegal guns that remain a danger to our communities and have disrupted the lives of our citizens", says Chief Superintendent Brad Ebanks. "We hope that for the remainder of the amnesty we see those 90 firearms come off our streets. This amnesty is a safe and sure way to do the right thing. Take advantage of the gun amnesty and turn in illegal guns and ammunition, using one of the four options provided. I would also like to address those persons who



know someone who is in possession of an illegal firearm. You too have a role to play. Do the right thing and help us reduce the number of illegal firearms in the community. Say no to guns. Say no to violence. Make the Cayman Islands Safer."

Four options have been provided to the public in order to surrender guns, ammunition and any other weapons including drop off, pick-up, via a trusted party and via crime stoppers. Further information on how to hand in firearms are provided on the RCIPS website. The Ministry of Education (MOE) and Department of Education Services (DES) are pleased to announce the successful conclusion of their expanded Summer School 2024 Catch-Up Programme. The three-week initiative designed to help students bridge learning gaps and achieve academic success, has made significant strides in supporting student learning.

Building on last year's foundation, the programme expanded its scope to include Year 4, 5, and 6 students requiring additional support in English and Mathematics. As a vocal advocate of the British Overseas Territories, Sir Lindsay has a strong interest in seeing the operations of the Hazard Management Cayman Islands (HMCI) office, the Cayman Islands Regiment, and Cayman's marine environment.

Sir Lindsay Hoyle, Speaker of the UK House of Commons, said: "It is a huge honour to be the first Speaker of the House of Commons to visit and address the Parliament of the Cayman Islands – so I would like to thank Sir Alden for giving me the opportunity. The Cayman Islands, like all

of our Overseas Territories, are an important and integral member of the British Family, and I hope my visit - and meetings with key figures and organisations - will further strengthen these bonds of friendship."

In honour of this historic occasion, a Meeting of the House will be convened on 1st August at 10:30 a.m. at the House of Parliament in George Town. The meeting will feature addresses by both the visiting and host Speakers, the Premier Hon. Juliana O'Connor-Connolly, and the Leader of the Opposition, Hon. Roy McTaggart.

This special Meeting will highlight the shared values and mutual goals of the UK Parliament and the Parliament of the Cayman Islands, and will provide the dignitaries with the opportunity to formally record their remarks on the significant ceremony.

The Premier, Hon. Juliana O'Connor-Connolly, JP, MP, commented: "We are very honoured and excited about Speaker Hoyle's visit to our Islands. It reaffirms the strength of relationship between the Cayman Islands and the United Kingdom. Speaker Hoyle has always been a champion and supporter of the Cayman Islands and other Overseas Territories, using every chance to underscore that together we are stronger and more prosperous because of the ties that bind us. We look forward to all our discussions with him on matters of mutual interest, including opportunities for strengthened cooperation."

During his notable visit, the House of Commons Speaker will also meet with the Hon. Premier, who recently was elected the President of the United Kingdom Overseas Territories Association. Sir Lindsay will also meet with Her Excellency the Governor to discuss the relationship between the UK and the Cayman Islands.

Her Excellency the Governor Mrs. Jane Owen said: "We are honoured to welcome Sir Lindsay Hoyle to the Cayman Islands. This is the first time a serving Speaker of the UK House of Commons has visited our Islands. The visit provides an opportunity to strengthen the bonds between the UK and Cayman's legislatures and discuss how Cayman is responding to the current national and global context. It also allows us to showcase to Speaker Hoyle these re-

markable islands and our community."

The Cayman Islands Speaker will host the visiting Speaker on a tour across Grand Cayman, including visits to key cultural and historical landmarks such as Pedro St. James, where the first meeting of the Cayman Islands legislature took place in 1831. The itinerary is designed to showcase the rich cultural heritage and history of Cayman, providing an opportunity for the visiting Speaker to gain a deeper understanding of the nation's traditions and advancements.

Following the tour, Hon. McLaughlin will host a formal gala on Friday, 2nd August for current and former Members, Speakers, and leaders of the Cayman community

The UK Speaker has been a vocal advocate for strengthening the diplomatic ties between the UK's Parliament and the Commonwealth nations, particularly the British Overseas Territories. In May 2023, Sir Lindsay unveiled two new stained-glass windows in Speaker's House at the Palace of Westminster, incorporating all sixteen of the Overseas Territories, which he said represented the importance of the "United Kingdom family".

Sir Lindsay was originally elected as Speaker on 4 November 2019, following the resignation of Speaker John Bercow. Sir Lindsay was re-elected to the House of Commons during the most recent UK elections on 4th July, and was re-elected as Speaker of the House of Commons for a second term on 9th July.

Cayman's Olympic Team shines in the City of Light





PARIS — On a rainy and overcast evening, the City of Light shone brighter than ever as a spectacular opening ceremony marked the beginning of the 2024 Summer Olympics. In the middle of the pomp and circumstance that featured world leaders, sporting legends and some of the biggest entertainers in the world was the Cayman Islands Olympic Team.

"The opening ceremony here in Paris was absolutely breathtaking," said Jillian Crooks, who will be competing in the women's 100-meter freestyle in her second Olympic appearance. "It was so beautiful, inspiring and motivational."

The Parade of Nations took place on the Seine River with boats for each national delegation. It marked the first time in Olympic history the opening ceremony did not take place in a stadium.

Crooks was joined in the Cayman Islands boat by her brother and fellow swimmer, Jordan Crooks, as well as track and field athlete Davonte Howell, sailor Charlotte Webster, Chef de Mission Shakeina Bush

and Team Medic Dr. Carl Andrew Brown.

"My experience at the opening ceremony was very eye opening," Howell said. "I believe that the Olympics just became very real for me. The experience is starting to really set in. Seeing all the festivities that Paris has set forward for the opening ceremony is very inspiring."

Aside from being introduced to an estimated global audience of 1 billion people during the Parade of Nations, the Cayman Islands delegation and their boat also grabbed space in pieces written by international media outlets. The New York Times and The Athletic — a sports journalism platform owned by the New York Times Co. with more than 3.5 million subscribers — featured the Cayman Islands in a piece highlighting the best boats of the opening ceremony.

"The entire atmosphere was electric and so unique for an opening ceremony," said Webster, who served as flag bearer along with Iordan Crooks, "The breathtaking performances showcased France's rich



culture and history as a host nation."

Paris 2024 takes place 26 July - 11 August. Paris is the main host city with events held at 16 other cities throughout France and one in Tahiti.

The athletes now turn their attention to their respective competitions.

Jordan and Jillian Crooks are scheduled to be the first Cayman Islands athletes to compete. They will dive in for the 100-meter Freestyle Heats on Tuesday. 30 July at Paris La Defense Arena. The Semifinals rounds for the event will be held later that same day and the Finals are scheduled for Wednesday, 31 July.

Jordan Crooks will then compete in the men's 50-meter Freestyle Heats on Thursday, 1 Aug. The Semifinals will be held later that same day and the Final on Friday, 2 Aug.

Webster sets sail in the women's Dinghy event beginning Thursday, 1 Aug. She'll compete on the Mediterranean Sea with the Roucas-Blanc Marina, in Marseille, serving as the venue. The women's Dinghy even runs from 1-5 August with two races each day. The Final takes place Tuesday, 6

Howell will step onto the track for the men's 100-meter dash Preliminary Round on Saturday, 3 Aug.

The First Round takes place later that same day while the Semi-Final and Final

Track and Field events are held at the Stade de France, in Paris.


