

### 20 Years Since Hurricane Ivan: A Nation Transformed

In the late evening hours of 11 September 2004, Hurricane Ivan made landfall on the Cayman Islands, unleashing devastating winds and storm surge on Grand Cayman. This catastrophic event remains one of the most expensive natural disasters in history, with damages totaling USD 3 billion.

The lasting impact of this historical hurricane would influence the measurement of time for the Cayman Islands - "Before Ivan" and "After Ivan" now divide defining moments in the lives of many.

To honour this milestone, the Cayman Islands Government will commemorate Hurricane Ivan under the theme of Past. Present. Grateful. Resilient. The campaign will feature a variety of touching and educational elements, including the launch of an official Hurricane Ivan webpage and a 20th anniversary documentary. Both will provide first-hand accounts and showcase the extraordinary journey to recovery and the resiliency of the people.

"The campaign serves to recount the story of Hurricane Ivan—our story," said Honourable Premier Juliana O'Connor-Connolly. "It pays tribute to those who endured great suffering, remembers the two members of our community who lost their lives, and celebrates the spirit of resilience that emerged in its wake.



As our population has evolved over the last two decades, we recognise that younger Caymanians and new residents may not have experienced a hurricane firsthand. Therefore, the campaign also aims to raise awareness about hurricane impacts, highlight the development of our crisis management operations, and offer best practices for preparedness and safety.

We also wish to express our gratitude to those who came from near and far to assist in organising communities and rebuilding Cayman after Ivan. Above all, this commemoration is an expression of our gratefulness for the continued mercies, from Almighty God, upon our beloved Isles."

Continuing the Cayman Islands' efforts to keep international stakeholders updated on the strength of our regulatory and commercial framework for financial services, the Deputy Premier, the Hon. André Ebanks MP is leading delegations to the UK and EU, and then to the US, during September.

"Financial services continues to perform exceptionally well for the Cayman Islands, and the public is now well aware of the industry's contribution to public services and projects ," said the Deputy Premier, who is also the Minister of Financial Services and Commerce.

"Having face-to-face discussions with international elected officials and civil servants, and with international industry, greatly helps us as a country to maintain our global regulatory effectiveness and to take advantage of emerging market opportunities," he explained. In the UK the Deputy Premier will meet with government and civil service officials; attend a Cayman Finance roundtable; and speak at Maples London Investment Funds Forum 2024, from 9-11 September. On 12 and 13 September, he will meet with EU and EU Member States officials.

In the US during the week of 15 September, he will attend client meetings arranged by industry; and speak at the Cayman International Reinsurance Companies Association's reinsurance roundtable and the Ogier Funds Symposium.

Accompanying the Deputy Premier in the UK and EU are Government's Deputy Representative for Financial Services to Europe Julie Campbell and Representative to the UK Dr Tasha Ebanks-Garcia, both based in the UK; Director of the Ministry's Regulatory Affairs Unit, Andrea Proctor; Cayman Islands Monetary Authority (CIMA) Managing Director Cindy Scotland and Senior Legal Counsel Stephanie Adolphus; and Cayman Finance CEO Steve McIntosh and Associate Director Samantha Widmer.

Accompanying him to the US are the Ministry's Head of Advisory Services in the Regulatory Affairs Unit, Duwayne Lawrence; CIMA's Head of Insurance Supervision Division Kara Ebanks and Chief Analyst Dane Doctor; Cayman International Reinsurance Companies Association's Chair David Self and CIRCA representative Greg Mitchell; Insurance Managers Association of Cayman Chair Kieran Mehigan; and Ms Widmer and Mr McIntosh.

For the week of 7-14 September the Acting Deputy Premier will be the Hon. Dwayne Seymour MP, and the Acting Minister of Financial Services will be the Hon. Bernie Bush MP. For the week of 16-21 September the Acting Deputy Premier will be the Hon. Johany "Jay" Ebanks MP, and the Acting Minister of Financial Services will be the Hon. Heather Bodden MP.

The Deputy Premier will update the public on the outcomes of his official travel when he returns home.

ary Doctorate of the Arts to the late Bendel Hydes, a pioneering Caymanian artist recognized as the founding father of Caymanian visual art. # **GENERAL ELECTIONS 2025**

Voters are rightly concerned about our 2025 general election. Every 4 years we repeat the cliche that "this is the most important election in our history". That cliche was true for specific reasons in the past, for example during our post Hurricane Ivan recovery and again during the COVID-19 pandemic recovery. However, in 2025 the cliche will be true for much broader and even more important reasons which it is difficult to summarise because they are so complex.

Suffice it to say that our beloved Cayman Islands is at the crossroads. Extreme right or left political ideologies or ad hoc and irrational policies will only lead to the ultimate downfall of our country. We can point to many examples of this around the world. I believe that we must decide to embrace a more centrist/moderate approach to our fiscal, social, environment, development and economic policies in order to correct our current course and then maintain a safe, secure and harmonious society. So yes this is truly the most important general election in our time. If we get it wrong this time, institutionalised corruption will become a reality and the



brewing social disharmony could ignite a level of social unrest that we have never seen in our country before.

I am not a pessimist, but there is no point in us pretending that everything is

okay when clearly we have fundamental problems which require urgent remedies. I have never seen our electorate this disillusioned before and I am concerned that we will have a very low voter turnout unless our people see that there is an opportunity for real change. Lets give Caymanians a reason to maintain our traditional very high voter turnout.

My commentary should not be seen as an indictment on all current MPs because the truth is, some of them are in a position and have the experience to be a part of the course correction !. And it is also true that all political administrations over the past two decades, including the one of which I was a part, have some degree of culpability for our country's current precarious position.

My commentary should also not be seen as an indication that I will be a candidate in the upcoming elections. But what I am sure of is that I will be, at a minimum, volunteering and offering my experience and training to help our country in whatever way I can. I implore other Caymanians who are similarly positioned to do the same and help us avoid a crisis. We will



gain nothing from sitting on the sidelines and hoping that the same team of players on the field can deliver the change we want to see.

At this point in our history all hands are required on deck so let us be the change we want to see. We must know that we owe it to our children and grandchildren to pass on to them a Cayman Islands that is at least as safe and successful as the one that we inherited from our parents. I pray that this post will motivate our Caymanians that can make a difference but who may never have considered seeking political office to step forward as candidates and help to make a real difference this time. ### **LOCAL NEWS** Fund Registrations in Cayman Reach **30K Milestone**

The Cayman Islands continues to cement its place as a global leading investment funds centre by attaining 30,000 funds registered for the first time.

According to the Cayman Islands Monetary Authority (CIMA), as of 4 September the total number of registered investment funds in Cayman is 30,038. Of that, there are 17,080 private funds and 12,958 mutual funds.

CIMA Managing Director Cindy Scotland noted that Cayman's investment funds framework remains prominent among investors for a number of reasons.

"This accomplishment underscores the strength and resilience of our regulatory framework, which continues to inspire confidence from the international funds industry," Mrs Scotland said.

"It is a clear indication that the Cayman Islands remains the funds centre of choice



for fund managers worldwide, reflecting our commitment to maintaining the highest standards of excellence and integrity."

Cayman Finance CEO Steve McIntosh indicated this milestone speaks volumes to the enduring quality of the Cayman product.

"Cayman Finance congratulates the many individuals and organisations whose hard work made this milestone possible, from those on the front lines driving our industry forward, to the policy makers who created the rules of the road and the regulators that make sure the rules are followed," Mr McIntosh said.

Noted the Deputy Premier and the Minister for Financial Services and Commerce, the Hon. André Ebanks MP, "Reaching 30,000 funds registered is certainly a collective country success for the Cayman Islands.

"It speaks to the vision and the work of successive Government administrations; the Monetary Authority, with its respected track record that spans more than 25 years; and the contributions of industry members, from retired pioneers to the cutting-edge practitioners of today.

"It tangibly demonstrates how we in this country work tirelessly together to create a global investment funds centre of excellence, and how we continue to take it from strength to strength."

The current projections indicate the 2024 year-end total will surpass 2023's registrations, building on the steady growth of private funds since the introduction of the Private Funds Act in 2020. Last year saw 16,551 private funds, the previous high for registrations, along with 12,802 as the prior high for mutual funds registrations.

### **Cayman Parliamentarians Attend Annual CPA Regional Conference and** Caribbean Youth Parliament in Guyana

A delegation of Parliamentarians from Cayman attended the 46th Commonwealth Parliamentary Association (CPA) Caribbean, Americas and the Atlantic (CAA) Regional Conference held in Georgetown, Guyana this week, including former Speaker Hon. Katherine Ebanks-Wilks, MP, Minister of Sustainability & Climate Resiliency.

Hosted by the National Assembly of the Parliament of the Co-operative Republic of Guyana, the four-day conference began on 2nd September and included numerous seminars and sessions under the theme of "Democracy: Challenges Facing Modern Parliaments".

The annual regional conference also included the 14th Commonwealth Women Parliamentarians (CWP) CAA Regional Conference, the 17th CAA Caribbean Youth Parliament, and the Annual General Meeting.

Hon. Ebanks-Wilks commented: "As Chairperson of the Youth Parliament Committee, I thoroughly enjoy accompanying our Youth Delegates. Seeing them work hard to prepare and watching it come together at the debate is very rewarding. I also enjoyed attending the Conference of Women Parliamentarians and having the benefit of leaning in and learning from other females in the profession."

The CAA Region of the CPA is governed by its own Executive Committee and is comprised of 19 legislatures, including the Cayman Islands, Trinidad & Tobago, Barbados, and Turks and Caicos.

Half a dozen sessions were held on Parliamentary topics including etiquette, parliamentary privilege and immunity, paperless parliaments, Hansards, and the role of the Clerk. Assistant Clerk Ms. Nordra Walcott presented at the conference on



the vital function the Clerks serve in legislatures. "I'm honoured to have had the opportunity to discuss with our regional clerks the importance of our roles, and to learn about our individual differences across the region," said Ms. Walcott.

The always-energetic Youth Parliament debate took place on Thursday, 5th September, and can be replayed on the Government of Guyana's YouTube. Two of Cayman's outstanding Youth Parliamentarians participated in the debate, including this year's YP Premier, Ms. Jhenelle Colquhoon, and YP Leader of the Opposition. Ms. Keira Bodden.

"This year's debate was on the inclusion of youth leaders in regional deci-

sion-making, a topic I believe is quite important and pressing in our region," said Ms. Colquhoon. "Overall, I was deeply enriched and empowered by the presentation of other regional youth, and their influence has left an indelible mark on my thought processes and personal convictions."

The debate focused on enhancing governance by including youth in legislative bodies. Ms. Bodden shared that the regional rebate benefited her "by ensuring that the perspectives and voices of [her] generation are represented and valued in policy decisions whilst also empowering [her] peers to become more involved in governance."

Former Commonwealth Secretary-General and former Foreign Minister of Guyana Sir Shridath Ramphal passed away just before the start of the conference. The Premier, Hon. Juliana O'Connor-Connolly commented on his passing in a statement issued by the Government this week.

### Six Fire Officers Trained as Hazmat Instructors



The Cayman Islands Fire Service (CIFS) has announced that six fire Officers, along with participants from other emergency response agencies and authorities, have successfully completed an internationally recognised Hazardous Materials Instructor course. The training, hosted by Hazard Management Cayman Islands (HMCI) as part of an ongoing partnership, was designed to equip participants with the necessary skills, knowledge and expertise to become qualified hazmat instructors.

The week-long comprehensive course combined theoretical lessons with handson exercises, providing an immersive learning experience for the Officers and enhancing their preparedness for any potential incidents involving hazardous materials.

During the training, the Officers received in-depth instruction on how to deliver the programme, gaining invaluable knowledge and practical skills under the guidance of experienced instructors from the United Kingdom. The participants learnt the fundamentals of handling dangerous goods, refining techniques for identifying various classes of hazardous materials, and demonstrating best practices for managing different classifications with a range of specialised equipment.

Commenting on the training, Chief Fire Officer, Randy Rankin said, "Our Officers are now better equipped to respond to and teach others about a wide range of emergencies involving hazardous materials, significantly enhancing CIFS' overall readiness and response capabilities."

"We are proud of the accomplishments of our officers and the broader group of participants. Their successful completion of this course marks an important step forward in ensuring the safety and security of our community," CFO Rankin added.

The other participating agencies and authorities included the Cayman Islands Regiment, Health Services Authority, Port Authority of the Cayman Islands, Cayman Islands Coast Guard, and HMCI.

### **Prison Director receives award**

Claira Range, Cayman's first Director of Female Rehabilitation who pioneered the opening and development of Fairbanks Female Prison, has received an Honorary Doctorate of Humane Letters and a Global Life Time Achievement Award. The award ceremony took place last month in New York where she was recognised for services in the fields of youth, community development and government.

Mrs Range has given more than 45 years of service to the Cayman Islands and has been the only female to aspire to the position of Deputy Director, and made her strides to that post through hard work, dedication, and resilience. Her position until today is still an historic achieve-

ment in the Cayman Islands.

She is a pioneer and first Director of Youth Justice at the Eagle House Young Offenders Institution, where she has continuously worked in close partnership with the Cayman Islands community and others in the Criminal Justice System to achieve common objectives.

Dr Marvin Simpson, Global Educational Consultant, gave some thoughts:

"Through her insight and quest for rehabilitation of female offenders, she has been involved in promoting and developing a promising network of prison and community provision for women which has developed through the probation and the voluntary sector working closely together, projects that provide effective rehabilitation in Fairbanks Female Prison and the community by tackling a range of problems, including drug and alcohol dependency. This is combined with education and interventions aimed at helping women offenders come to terms with issues such as physical and sexual abuse," he stated. "Although these programmes and network of provision have been designed in order to divert women from crime and custody, the learning has also been applied to male offenders, particularly in a coordinated approach to those with more complex issues underlying their offending."

Dr Simpson went on to say that Mrs Range was considered as a mother to both

adult inmates, juvenile, young offenders, and staff alike. She unremittingly offers guidance, support, affection, and her personal resources to assist anyone in need.

"I believe Mrs Range has distinguished herself as a hard working role model who has had a positive effect upon the lives of many men and women. The personal sacrifices she makes to the development of people through financial and other means in her community has not gone unnoticed. Mrs Range has received many awards, honours, and recognition for her work, including receiving the British Empire Medal in recognition of meritorious civil service by His Majesty King Charles," he added.

### Survey reveals best paying jobs

If you want to earn the big bucks in the Cayman Islands then it is best to get a job in accounting or the legal industry where salaries average \$9,743 a month. On the other end of the scale, those working in mobile food services activities could look to earning on average \$2,513 a month.

These findings have come about from the Economics and Statistics Office newly released Occupational Wage Survey 2023 Report. The Survey was conducted across all types of businesses from October 2023 to March 2024. 745 respondents supplied data on the 16,694 employees represented in the Report.

The Report is made up of tables showing the average monthly basic earnings and monthly total compensation for each occupation coded according to the International Standard Classification of Occupations. Basic earnings is comprised of basic salary and wages, including overtime pay. In contrast, total compensation comprises basic earnings and other compensation types (acting or duty allowance, commission, bonus, gratuities, and tips).

The average monthly total compensation in the Cayman Islands was \$5,043. Male employees had an average monthly total compensation of \$5,155, while female employees had \$5,012.

The average monthly compensation for Caymanian employees was \$5,335, while the corresponding average for non-Caymanian employees was \$4,615.


Employees from the following industries had the highest average monthly total compensation: Professional, scientific, and technical activities (mainly legal and accounting) earned \$9,743 monthly, and Financial and insurance activities earned \$8,954 monthly.

Employees from the following sectors had the lowest average monthly compensation: Accommodation Services earned \$2,491 monthly, and Restaurants and Mobile Food Services Activities earned \$2,513 monthly.

The median monthly total compensation was \$4,100, lower than average. This indicates that most employees (62%) had total compensation less than the average of \$5,043.

The Report also shows the percentage of employers (excluding households as employers) who indicated providing various benefits and allowances, including the following: health insurance – 93.7%; pension - 31%; vacation leave – 91%; bonus - 57.1%; and training and education

– 57.1%; and training and education allowance – 35.9%.






