Police Issue Reminder on Leaving Children or Animals in Unattended Vehicles





Eight new honourees were inducted into the International Scuba Diving Hall of Fame on 28th September, at the Indigo Hotel. Its an incredibly prestigious and unique event, which holds the attention of the whole diving community around the world

It was a celebration of some of the most wonderful people on our planet – people who have dedicated their life to exploring, charting, filming and teaching others about the magical and mysterious other realm which covers two thirds of our globe, and yet most people never get a chance to visit. We know about it and experience it because of them, and they never get tired of warning us of the need to protect it. Vast though it is, it is also as

fragile as it is strong, fearsome, and beautiful.

The awards were divided into two main sections – those living in the Cayman Islands – and those living in other countries. Since the earliest days, when visionary pioneer Bob Soto began the very first dive operation here in the 1950s, the Cayman Islands has been regarded as one of the jewels of the diving world.

Minister of Tourism, Hon. Kenneth Bryan, said "This is an event that holds great significance to Cayman. Tonight, we are here to celebrate and honour pioneers, leaders and emerging talent whose dedication, passion, and innovation have profoundly impacted the world of scuba diving.

"They remind us of our responsibility to preserve and protect our marine environment, not only for

now, but for future generations to come."

"As one of the world's premier dive destinations, we are immensely proud of the role our islands have played in shaping the dive industry over the years. Our commitment to preserving our pristine marine environment remains unwavering, and we are dedicated to maintaining the Cayman Islands as a world-class location for divers, marine scientists, and conservationists alike."

ISDHF Chairman Steve Broadbelt said:

"We are fortunate to welcome back Dan Orr, a previous inductee, to be the keynote speaker. Dan is a legend in the industry, and his career is one we can all learn from. It was great to see how many nominations we received and I'm especially proud that we are recognising four local honourees. I encourage you all to take time to reflect on those you know in the industry who are making a difference and consider nominating them next year."

This year's Cayman Islands Honourees include three long-serving individuals in the local scuba diving industry: the late Captain Ertis Ebanks, Barbara MacDowell, and Joanna Mikutowicz. Andrew Ebanks, an entrepreneurial and passionate Caymanian, is this year's Emerging Honouree.

The late Captain Ebanks was a leading pioneer in the water sports industry as one of the first people to offer snorkelling tours to visitors in the early 1950s. Captain Ebanks was passionate about the sea from a young age teaching his peers to fish and later building and launching a 61-foot boat in West Bay.

MacDowell, better known as "Barbie" to those in the industry, has been an instructor, boat captain and photo pro in Cayman Brac for more than 30 years. Over the years, many of Cayman Brac's young people have been trained by her to dive the local reefs and walls.

Mikutowicz of Divetech, is a dedicated member of the Cayman Islands diving community. As a PADI Course Director and Normoxic CCR Supervisor she has issued over 1,800 certifications and logged more than 15,000 dives globally. Her start in the industry began in 1997 with her certification at Bob Soto's Dive Center in Grand Cayman.

The Emerging Honouree category recognises young and upcoming Caymanians making significant contributions to the industry and was introduced in 2017. Andrew Ebanks is a third-generation seaman and continuing his family legacy in the Cayman Islands water sports industry. His start in the industry began in 2007, where he quickly advanced from deckhand to being a captain and trainer at Nativway Watersports. He is a passionate advocate for Caymanian heritage and marine tourism.

In the International Section, there were four new inductees:

Claudio Guadabassi from Brazil is a visionary entrepreneur and diver who has significantly shaped the diving industry in Brazil. Starting his diving career at 16, he quickly became an instructor and later completed globally in freediving and spearfishing as part of the National Team. In 1971 Claudio founded Claumar Dive Center, one of South America's oldest dive centres, which has trained generations of dive professionals.

Margo Peyton, driven by her passion for the ocean and family, founded Family Dive Adventures and Kids Sea Camp in 2000 to create family-friendly dive experiences. Since then, Kids Sea Camp has certified over 7,000 young divers, including those with special needs.

Enric Sala, from Spain, is a National Geographic Explorer-in-Residence and dedicated conservationist, known for his work in raising global awareness about the importance of a healthy environment. After serving as a professor at Scripps Institution of Oceanography, where he helped establish the Centre for Marine Biodiversity and Conservation, Sala returned to Spain in 2006 to take up a position in marine conservation ecology.

Since 1993, John Thet from Singapore has played a crucial role in promoting scuba diving and ocean conservation across Asia. Co-founding the world-renowned Asian Geographic Magazine.

Government Issues Loan Facility RFP via Procurement Site

The Ministry of Finance and Economic Development (MFED) has issued a Request for Proposal (RFP) via the Cayman Islands Government (CIG) official procurement site for the provision of a CI\$150 million loan facility.

Issued on 27 September, the RFP is open until 18 October and is the execution of borrowing approved in the 2024-2025 Budget by Parliament's Finance Committee in December 2023 and thereby legally empowering the Government to borrow up to a total of CI\$150 million over the two-year period.

At that time, it was approved by all Members of Parliament that CI\$27 million in loan funds would be drawn down in 2024 and a further CI\$123 million in loan funds would be used in 2025 for a total of CI\$150 million in planned borrowing over the two-year Budget period.

Although the two-year Budget provides for CI\$27 million to be borrowed in 2024, from 1 January to 30 September 2024, the Government has thus far not incurred any new borrowing for the year. According to the RFP, the first tranche of the proposed loan will be drawn down in late November of this year.

Over the 2024 Budget period, the Government budgeted for a total of CI\$172 million in Capital Expenditures.

It should be noted that the Government incurs two types of expenditure:

- 1. Capital Expenditure, which is used to fund major projects such as roads, buildings and other infrastructure related projects; and
- 2. Operating Expenditure, which is used to fund operations such as Personnel Costs, rent, and other consumables.

This loan facility is to fund a portion of the Government's Capital Expenditure, not Operating Expenditure, over two years.



While the Government currently has an Operating Surplus, the Surplus is not sufficient to cover the planned Capital Expenditure. The budgeted Surplus, which is the Government's Revenues less its Operating Expenditure, for the 2024 Financial Year was CI\$43 million whereas the budgeted Capital Expenditures for 2024 amounted to CI\$172 million

Hence, although a Surplus is budgeted to exist, the Surplus is not sufficient to cover the planned Capital Expenditure in its entirety, and borrowings are therefore incurred to bridge the gap.

The 2024-2025 Budget documents note the Capital Investments into Ministries, Portfolios and Offices intended for the budget period as well as Government's Equity Investments in its Statutory Authorities and Government Owned Companies.

The major investments in this category were budgeted as follows:

- CI\$31.9 million in 2024 and \$33.9 million in 2025 for the continued expansion of educational facilities;
 - CI\$14.0 million in 2024 and \$12.5 million

in 2025 for the expansion, and further development of the road network;

- CI\$11.8 million in 2024 and \$8.6 million in 2025 for various park and district upgrades, civic centres and jetties; and infrastructure and development;
- \$12.1 million in 2024 and \$9.1 million in 2025 as Equity Investments in Cayman Airways:
- CI\$10 million for the acquisition of beaches and other lands for conservation, protection, and securing the Cayman Islands environment;
- \$8.0 million in 2024 and \$7.0 million in 2025 as Equity Investments in the National Housing Development Trust to allow an expansion of housing stock in the Islands;
- CI\$7.4 million in 2024 and \$4.2 million in 2025 for the improvement to the prison facilities; and
- CI\$3.8 million per year in 2024 and 2025 for land acquisition.

During the 2024-2025 Budget Debate, Premier and Minister for Finance Hon. Juliana O'Connor-Connolly noted that, inclusive of the planned borrowing, the 2024-2025 Budget is in full compliance with the Principles of Responsible Financial Management as prescribed by the Public Management and Finance Act, or PMFA and those specified in the Framework for Fiscal Responsibility (the FFR).

She also noted that inclusive of the CI\$150 million loan, Cayman's debt to GDP ratio will still be under 10 per cent - making it one of the best ratios in the world. Comparatively, Japan's debt ratio is over 200 per cent and the United Kingdom's is approximately 100 per cent. As of 31 August 2024, the Government's debt balance was CI\$424.4 million.

Pursuant to sections 6 (1) and (3) of the Procurement Regulations, all projects costing CI\$100,000 or more must be published on the website designated by the Central Procurement Office (this designated website is called Bonfire). Additionally, section 7 of the Procurement Regulations afford Government the opportunity to secure the best possible price and to promote competition in the market

As the Government is expected to incur costs of more than CI\$100,000 in interest costs and other fees, the Procurement Act requires the public tendering of this loan facility.
