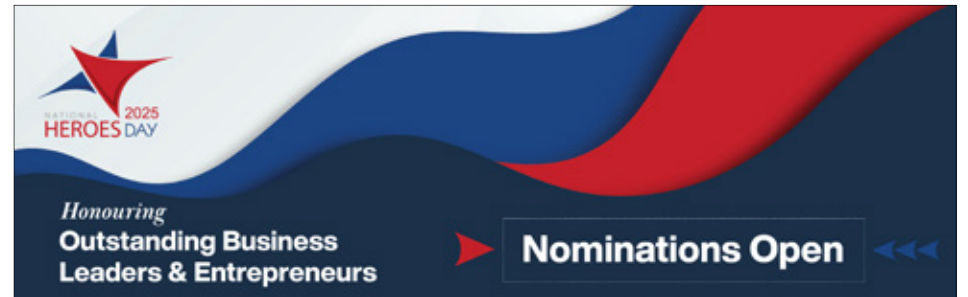
National Heroes Day 2025 Welcomes Nominations: Celebrating Icons of Business and Entrepreneurship

Interest Rate Changes

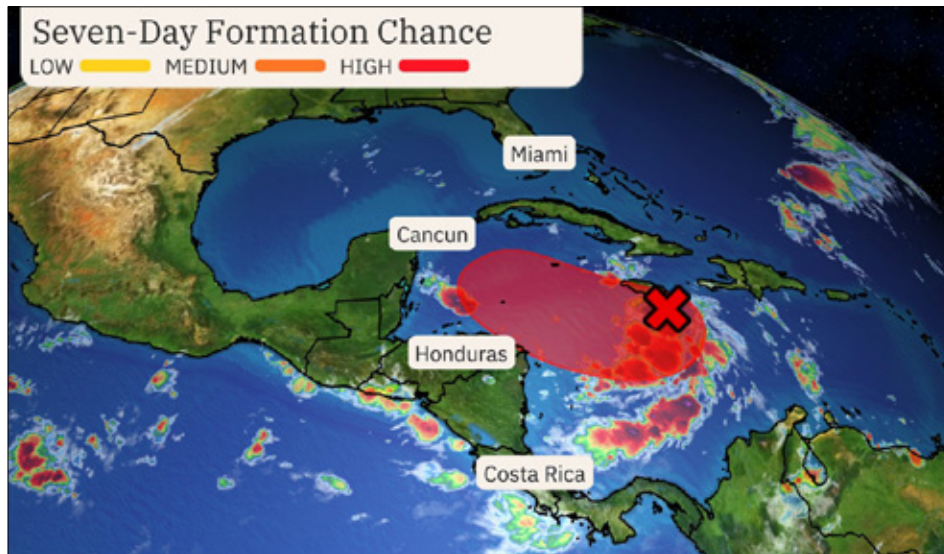
Effective 12 November 2024, CIBC Caribbean will adjust its KYD and USD Prime Rates from 8.00% to 7.75%.

Late-Season Caribbean Tropical Storm likely to form



A tropical depression is likely to form in the western Caribbean by the end of the week and will then intensify into the season's 18th named storm, Sara.

According to the Weather Channel, the broad area of low pressure that will spur this tropical development is located in the Caribbean Sea. It is now being referred to as Invest 99L, a naming convention used by the National Hurricane Center to identify features they are monitoring for potential future development.

The NHC has scheduled the first Hurricane Hunter flight mission into Invest 99L for Wednesday afternoon.

At any rate, this low will likely form into a tropical depression somewhere in the red-shaded area in the map below once it becomes better defined in the next few days, according to the NHC.

The Cayman Islands National Weather Service (CINWS) continues to monitor this low-pressure system. Associated rain showers are expected to impact the Cayman Islands and may persist into early next week as the system remains in the western Caribbean.

Rainfall estimates for the upcoming days are as follows:

- Grand Cayman: Up to 10 inches throughout the week, with the heaviest rainfall anticipated on Friday, 15th November.
- Sister Islands: Up to 8 inches throughout the week, with the heaviest rain expected on Friday, 15th November.

With ground already saturated from recent rainfall, residents are advised to prepare for an elevated risk of flooding. A Flood Warning will be in effect from 15 to 16 November.

Wind and Marine Conditions:

This system is forecast to bring increased winds and rough seas around the Cayman Islands:

- Wind Speeds: Sustained winds of 15-20 knots (17-23 mph) over the next two days increasing to 20-25 knots (23-29 mph) with higher gusts expected over the weekend.

- Wave Heights: 5-7 feet from Thursday to Friday, increasing to 6-8 feet from Saturday through Monday.

A Small Craft Advisory will be in effect from 14 to 15 November, escalating to a Small Craft Warning from 16 to 18 November. Mariners are advised to exercise caution in anticipation of strong winds and high seas.

The public is encouraged to stay informed by following updates from the CINWS and Hazard Management Cayman Islands (HMCI) for further developments.

Stay safe and vigilant as we continue to monitor this situation closely.

Possible future track, strength:

Computer model forecast guidance indicates this system could become Tropical Storm Sara soon after first becoming a depression. And with relatively low wind shear and record warm Caribbean water for mid-November, Sara could ramp up to a hurricane late this week in the western Caribbean Sea.

Its future track is complicated and uncertain, and likely to change in the coming days, so check back with us at weather.com and The Weather Channel app for updates.

Sara could approach the Caribbean coast of Honduras or Nicaragua late this week, bringing heavy rain and wind. It could even stall or drift east for a few days while near Central America. It could even move inland over Central America and spin down a bit, but still produce potentially prolific rainfall, with potentially life-threatening flash flooding and mudslides.

Beyond that, an increasing number of forecast models suggest Sara could then begin moving northwest in the western Caribbean Sea early next week.

That could bring Sara near the Yucatan Peninsula or western Cuba, then into the Gulf of Mexico by next Tuesday. It then is expected to speed up and make a sharp turn to the east, which could bring it across parts of Florida or Cuba around next Wednesday.

On Cardinal Avenue there were stalls with mouthwatering samples of local cuisine – conch fritters, conch stew, Cayman Style beef – Fish & Fritters. There were arts

on display – such as Charlotte’s Designs – featuring beautiful, stylized art using embroidery, each one completely original. There were stalls selling locally-made hot sauces, and stalls selling Henna tattoos. Deal Ebanks was there with his daughter. He was showing a mom-and-daughter pirate the exquisite spinning tops, carved from hardwood, which he has made from the time he was a young boy growing up in West Bay, while his daughter was show-

ing people how the conch shell could be blown to make a loud horn that used to be sounded as a warning, or when a big fishing boat came home.

Then there was Wray Banker, showing visitors important cultural artifacts- he had a beautiful Warri board- a game with a big wooden board and depressions, in which you move a wooden counter. It’s a

came through and devastated the Island. We worked together for months, shipping machine parts ...giving everything we had to Flowers as they offered free blocks and water to the Island.

"About 5 years ago Mr. Flowers was talking about his dream of a new state-of-the-art block manufacturing plant, and I'm so proud to see it here today. So this plant, the CPM + 40 is our flagship - the best machine in the world."

Director, Dara Flowers Burke appeared on-stage with her two children, Alexandra and Lucas. "The future is bright," she said, "And Flowers is proud of our many new ventures, including our gold Leed Certified Phase Seven of Cricket Square, the development in total boasts over 300,000 square feet, and is the largest locally owned commercial real estate park in the Cayman Islands.

"There's an emphasis throughout the group on sustainability, and Flowers is proud to announce the launch of our new recycled glass plant, which will be in operation by the second quarter of next year. Cayman National donates fifty trees at Malportas Pond Bird Sanctuary

Cayman National has donated fifty trees to the National Trust for the Cayman Islands to restore dry forest habitat along Malportas Pond Bird Sanctuary in North Side. At an event held on Friday 1 November, Cayman National's senior leadership team joined National Trust staff and representatives from the Ministry of Sustainability and Climate Resiliency to plant a selection of native trees which produce fruit and flowers that attract birds.

The trees will form the entrance to 5 acres of land the National Trust acquired in 2019 adjacent to Malportas Pond which is a birding hotspot for local and migratory birds including herons, ducks and the famous flamingo visitor from earlier this year. The shores of the pond are an important breeding ground for Least Terns whose numbers are in decline.

Cayman National is donating the fifty trees as part of their 50th anniversary celebrations this year. As a long-term supporter of the National Trust, Cayman National is a corporate member and sponsored a youth delegate to attend the United Nation's COP28 in Dubai last year, Go Green radio tips, their Dive Into Maritime Heritage fundraiser and more.

"Cayman National's commitment to sustainability and ESG principles encompasses products and services, such as our GreenLiving programme, to the way we give back in the community," said Janet Hislop. "The National Trust does invaluable work in conserving our natural environment and preserving our built heritage and we are proud to partner with them on this tree planting initiative."

The trees donated by Cayman National will line both sides of the pathway leading from the entrance on North Side Road to Malportas Pond, providing shade for visitors as well as food for local wildlife. The National Trust also has plans to build two viewing platforms for birdwatchers to enjoy the diversity of wildlife at Malportas Pond.

The mangroves fringing the ponds are home to West Indian Whistling Ducks, while Snowy Egrets use the island in the middle of the pond as an overnight roost. Migratory visitors include Roseate Spoonbills, American Avocets and flocks of White-rumped Sandpipers which stop over each year on their 9,000-mile trip from South America to Canada.

"The National Trust greatly appreciates

the community spirit of Cayman National in support of our efforts to rehabilitate and preserve the coastal areas surrounding Malportas Pond," said Frank Roulstone, Executive Director of the National Trust. "The dry woodland ecosystem around the

pond supports a diverse range of native animals and plants, some of which are unique to these islands."

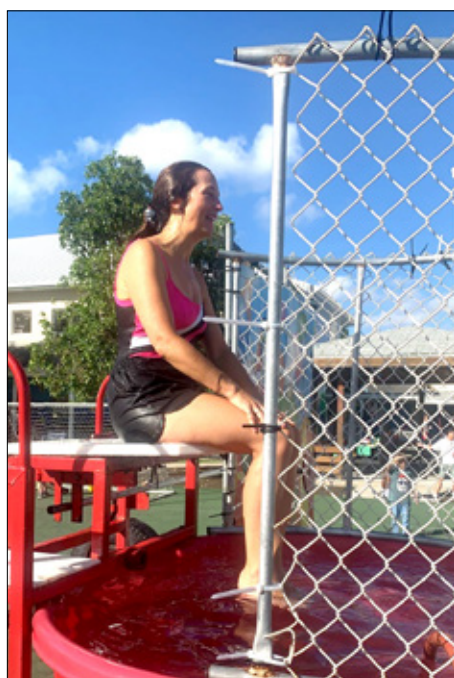
Malportas Pond Bird Sanctuary is admission-free and is open to year-round birdwatchers and visitors in North Side.

CI Government Q3 2024 Financial Report Gazetted

The Cayman Islands Government's Quarterly Financial Report for the Nine-Month Period Ended 30 September 2024 was published in the Cayman Islands Gazette on Friday, 8 November as required by law.

The unaudited financial results for the Third Quarter 2024 show a \$135.7 million surplus for the Core Government and a \$148.6 million surplus for the Entire Public Sector (EPS).

Net Assets of the Government were \$2.3 billion, with overall bank account balances of \$485.0 million in cash and deposits.

Surplus

The overall EPS Surplus of \$148.6 million was \$52.1 million greater than the projected year-to-date operating surplus of \$96.5 million.

This favourable position was due to actual revenues being higher than budgeted revenues by \$27.0 million for the period.

Additionally, Statutory Authorities & Government Companies (SAGCs) contributed \$12.9 million to the overall surplus for the EPS; exceeding their estimated results for the first three quarters of 2024 by \$14.2 million, when compared to an expected deficit of \$1.3 million.

Comparing year-on-year numbers, the EPS Surplus was \$32.0 million higher than that achieved for the same period in 2023 with SAGC third quarter results being \$7.5 million higher than the prior year.

Revenues

Compared to the same period in the prior year, total revenues of Core Government have increased by \$27.0 million, mainly due to fa-

vourable variances of \$7.3 million and \$15.3 million in Coercive Revenue and Investment Revenue, respectively.

The first nine months of 2024 generated coercive revenues of \$848.4 million, which was \$7.3 million more than budgeted expectations and \$57.2 million higher than the 2023 year-to-date actual results.

The positive variance in 2024 coercive revenues compared to budget can be primarily attributed to:

- A \$7.4 million positive variance in Other Company Fees – Exempt Companies, which were higher than the \$105.2 million expected budgeted amount for the Third Quarter due to increased registration. When compared to prior year-to-date performance, the 2024 results were \$19.4 million greater.

- A \$5.4 million positive variance in Other/Miscellaneous Stamp Duty, which was higher due to the continued high demand in the real estate market. Current year results are \$2.3 million higher when compared to actual results for the same period in 2023.

- A \$6.4 million positive variance in Partnership fees, which exceeded budget owing to higher than anticipated registration in this category. Compared to the prior year actual there is a \$7.2 million positive variance.

- A \$4.0 million positive variance in Private Fund Fees, which performed better than the \$61.5 million anticipated due to an increase in the volume of funds registered.

- A \$17.9 million positive variance in Stamp Duty – Land Transfers, which was higher due to higher volumes of property transactions coupled with increasing property values. The 2024 stamp duties of \$68.5

million are \$10.8 million more than the comparable quarter in 2023

Notwithstanding the overall favourable results in coercive revenues collected, when compared to the 2024 Budget, there were certain areas that fell short of projected expectations including:

- Other Import Duty with a \$16.1 million negative variance. However, when compared to the results for prior year-to-date Other Import Duties are on par with the 2023 results.

- Department of International Tax Cooperation (DITC) Filing Fees with a \$9.5 million negative variance compared to budget. This is a new coercive revenue stream that was slated to be introduced in 2024, however the commencement date has been deferred to 2025

Investment Revenues produced \$23.6 million, which was \$15.3 million more than the 2024 budgeted revenue for the nine-month period.

Investment Revenue derives primarily from Interest earned on Marketable Securities (Fixed Deposits, Other Securities and Cash).

Interest on Marketable Securities, reflecting interest earned on bank account balances held in the form of fixed deposits, has exceeded the initial full year budgeted revenue of \$11.2 million, by \$12.4 million.

Higher cash balances have afforded higher values to be placed on fixed deposit and this has driven higher income earned on investments.

Expenses

Expenses for the first nine months of 2024 amounted to \$778.3 million. This amount was \$10.9 million less than the year-to-date budget of \$789.2 million. Compared to the prior year-to-date actuals, total expenses for 2023 are \$43.3 million higher.

Costs relating to personnel for the first nine months of 2024 amounted to \$341.0 million, which were \$34.4 million less than the budgeted \$375.4 million mainly due to delayed recruitment. These costs are \$17.4 million more than for the same period in 2023.

Supplies and Consumables costs were \$110.6 million for the period and were \$11.5 million less than the year-to-date budget. Compared to the prior year-to-date costs of \$102.0 million, the 2024 expenses are \$8.6 million more. It is anticipated that as more projects come online during the remaining quarter of 2024, costs will align closer to the amounts anticipated in the full-year budget.

The savings against budget in staff costs were offset by higher-than-budgeted levels of expenditure in Outputs from SAGCs by \$14.4 million, Outputs from Non-Governmental Suppliers by \$22.1 million, and Transfer Payments by \$11.2 million.

Payments to the Health Services Authority (HSA) exceeded the original year-to-date budget by \$16.6 million. This adverse variance with respect to the HSA is due to actual costs for the Care of Indigents exceeding the budget for this category.

Outputs from Non-Governmental Suppliers of \$54.9 million were \$22.1 million more than the year-to-date original budget, mainly due to "NGS 55 Tertiary Care at Local and Overseas Institutions" being \$24.5 million more than the year-to-date budget.

However, the total costs incurred with respect to Outputs from Non-Governmental Suppliers, for the first nine months of the year are \$5.1 million less than for the same period in 2023.

Thus far in the 2024 financial year, Parliament has approved, via section 11(5) and section 12 of the Public Management and Finance Act, an additional \$34.4 million for NGS 55.

Transfer Payments of \$61.1 million were \$11.2 million more than budgeted for the nine-month period. This variance is mainly due to overages in spending on Scholarships and Bursaries by \$4.1 million and Financial Assistance by \$7.7 million.

Thus far in 2024, Cabinet has approved, via section 11(5) and section 12 of the Public Management and Finance Act, additional funding of \$10.6 million for Financial Assistance.

When compared to the prior year-to-date amount of \$50.0 million, the 30 September 2024 total year-to-date expenditure of \$61.1 million represents an increase of \$11.1 million.

Cash Position

Total cash and fixed deposits as at 30 September 2024, were \$485.0 million. This amount includes Operating Cash and Deposits of \$287.9 million and Reserves and Restricted Deposits of \$197.1 million.

Conclusion

In conclusion, the report noted that the Third Quarter's performance has positioned the Government to be optimistic about its overall financial performance for 2024.

However, the report acknowledged that during the final quarter of the year there will be a push to meet stated 2024 deliverables and advised that should all planned operational and capital spending materialise, the end of year surplus will be significantly reduced.

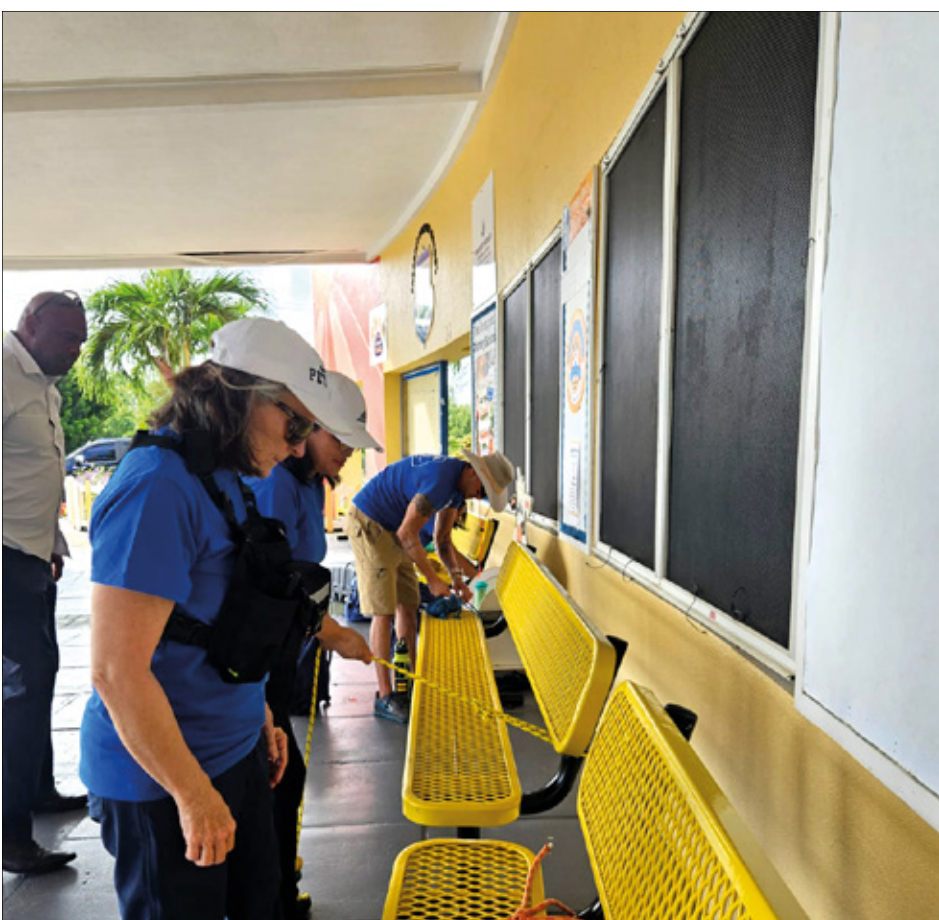

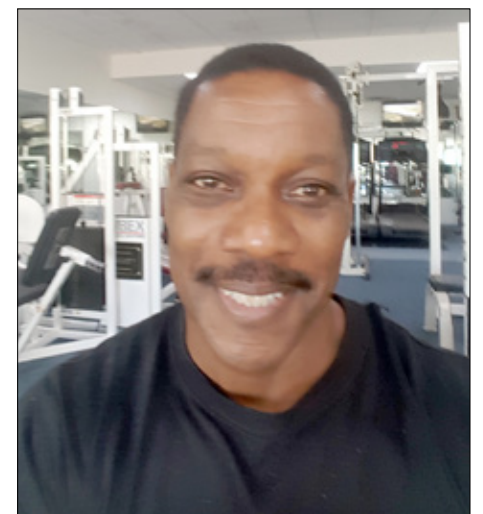

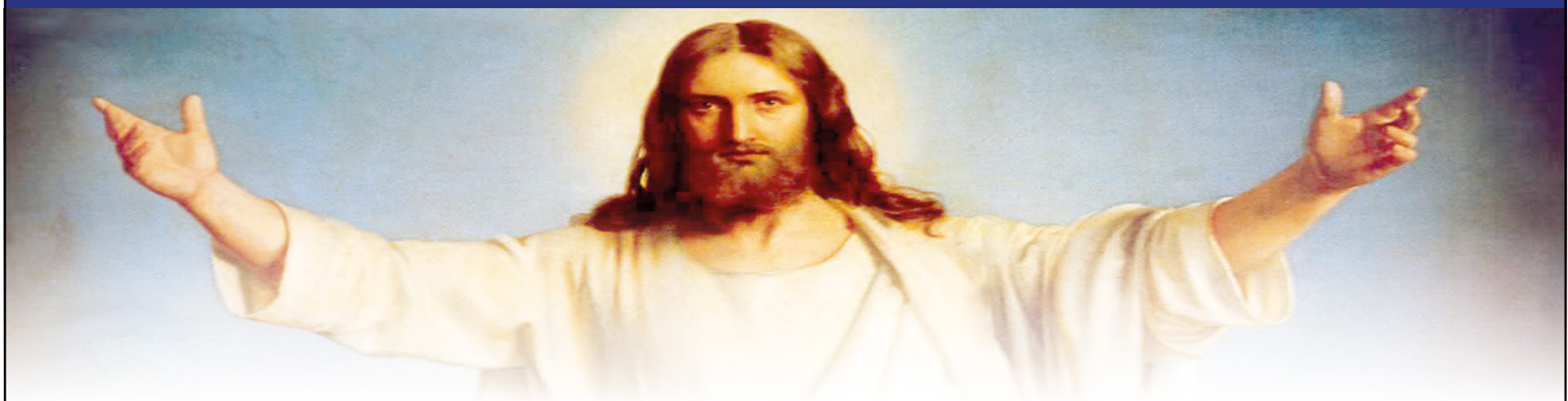
