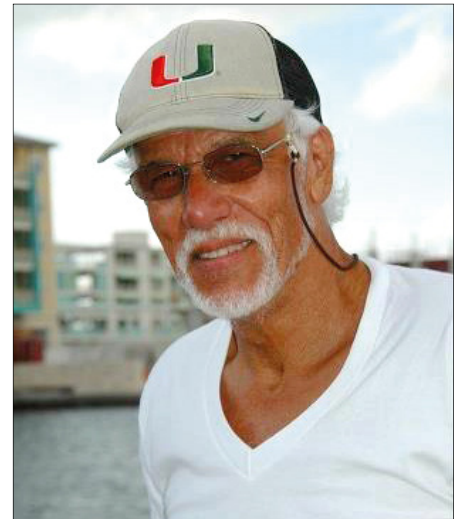

In the case of the United States though, its largely expected to be status quo even with that country's next president, Donald Trump stepping back into the White House for another term. In other words, being so intricately tied to the US econ-

omy, anywhere America goes Cayman is dragged along in its wake - local mitigating measures notwithstanding.

One thing that's certain amidst the coming changes is that the good ship Cayman will continue to sail on in its true maritime tradition of navigating the 'storms' that it will no doubt encounter; both metaphorical and literal.

Cayman to Host Multinational Disaster Response Exercise

ter response and search and rescue.

The humanitarian aid and disaster response will simulate an earthquake south of George Town, triggering the activation of the National Emergency Operations Centre and regional support from the Caribbean Disaster Emergency Management Agency. Local entities such as the Cayman Islands Regiment, Fire Service and Hazard Management Cayman Islands will work with regional partners during the simulation.

As part of the search and rescue, there will be simulation of an aircraft emergency between Grand Cayman and Little Cayman with assets including the Royal Cayman Islands Police Service, Cayman Islands Coast Guard and regional partners coordinating rescue operations.

Reflecting on the significance of the exercise, Governor Jane Owen stated, "Event Horizon 2025 demonstrates our shared commitment to resilience and security in the Cayman Islands and the wider Caribbean. By working together, we enhance our ability to respond to crises, safeguard lives, and strengthen our maritime capabilities."

The Cayman Islands Government has said that the weeklong event involving regional and international partners underscores the value of coordinated, effective approaches to enhance safety and resilience across the region.

Residents are advised that Event Horizon 2025 is a training exercise, not an actual emergency.

The Cayman Islands will host a multi-agency training exercise involving nine countries dubbed, Event Horizon 2025 in Grand Cayman from 10 to 19 January. The exercise, which is organised by the Jamaica Defence Force and its Maritime Air and Cyber Command in collaboration with the United Nations Office on Drugs and Crime, will bring together disaster response and

maritime law enforcement personnel from countries including the Cayman Islands, Jamaica, Dominica Republic, Bahamas, Haiti and Turks and Caicos.

The aim of Event Horizon 2025 is to strengthen readiness and regional coordination in addressing complex emergencies and maritime challenges. Key objectives will be to enhance multilateral maritime law enforcement, safety coordination, strengthen regional readiness and

Police Respond to Fatal Collision in Bodden Town

Shortly after 2:20AM on Thursday, 26 December, police and other emergency services responded to a report of a serious single-vehicle collision on Shamrock Road in the vicinity of Midway Close, involving a Subaru sedan. It was reported that the Subaru was travelling eastbound along Shamrock Road when it left the roadway and collided with a tree.

Emergency services attended the location and three occupants of the vehicle were transported to the Cayman Islands Hospital for treatment by ambulance, while one was transported via private vehicle. One man was subsequently pronounced dead. The RCIPS expresses condolences to the family and friends of the deceased.

The other three persons remain in hospital being treated for what appear to be serious injuries.

Meanwhile the persons, including one child, who were injured in a three-vehicle collision on Shamrock Road, in the vicinity of Beach Bay Road, shortly before 5:50PM yesterday, 25 December, have since been discharged from hospital.

“This morning we have woken up to the news of yet another life lost on our roads,” says Commissioner of Police Kurt Walton. “Instead of enjoying the rest of the fes-



tive season, a family is now dealing with the grief of this tragic loss. And this fatal collision follows another serious collision only hours before. In fact, over the past 48 hours our officers have observed and ticketed a number of drivers travelling at excessive speeds. We again implore all drivers: slow down, drive safely, and avoid turning the holiday season into a season of grief.

“Increased vehicle checkpoints and traffic enforcement continue through the new year, and if you are speeding, driving under the influence, or otherwise driving unsafely, you will be caught and prosecuted, or you may face an even worse outcome”

The RCIPS is also reminding motorists of the National Drug Council’s Arrive Alive 345 Campaign, which includes the Designated Driver Programme, and the Purple Ribbon Bus service, a free bus service on New Year’s Eve for all districts.

UPDATE: Two More Persons Arrested on Seven Mile Beach

Shortly after 2:00PM on Tuesday, 26 December, officers conducting foot patrols along the beach north of Seven Mile Public Beach detected a strong scent of ganja coming from a group of individuals.

Officers conducted searches under the Misuse of Drugs Act, and recovered a quantity of illegal substances, suspect-

ed to be ganja. A 19-year-old man from East End and a 20-year-old woman from Bodden Town were arrested on suspicion of possession and consumption of ganja. Additionally, the man was arrested on suspicion of possession of an offensive weapon after officers found a knife on his person.

Another Fatal Collision during Christmas Holidays

At about 4:30PM on Thursday, 26 December, police and other emergency services responded to a report of a serious single-vehicle collision on the Esterley Tibbetts Highway, in the vicinity of Canal Point Drive, involving a Honda Fit. It was reported that the Honda was travelling northbound along Esterley Tibbetts when it left the roadway and collided with a tree, and subsequently caught fire.

EMS and the Cayman Islands Fire Service attended the location. The fire was extinguished and the five occupants of the vehicle were transported to the Cayman Islands Hospital by ambulance, with two persons being in critical condition. The driver of the

vehicle was subsequently pronounced dead. The RCIPS expresses condolences to the family and friends of the deceased.

The other four persons remain in hospital, with one in critical condition, and the others being treated for what appear to be serious injuries.

In light of the series of serious collisions over the past two days, the RCIPS has diverted additional resources to road safety and traffic operations, and motorists should expect to see a further increased police presence on the roads throughout the coming days. Police continue to appeal to road users to practice safe driving habits, and avoid speeding, drunk, or distracted driving.

Police Respond to Sudden Death in West Bay

Shortly after 11:50AM on Saturday, 28 December, officers responded to a report of a man found unresponsive at an address in the Yacht Drive area of West Bay. Police and emergency services attended the location

and the man was taken to the Cayman Islands Hospital where he was subsequently pronounced dead by the attending doctor.

The mater is currently under investigation.

TAKE NOTICE that –

- (a) Every person who is entitled to be registered as an elector in the **Cayman Brac East and Cayman Brac West & Little Cayman** electoral district(s) and who wishes to have his/her name placed on the Register of Electors for the three month period commencing on the **1st day of April, 2025** shall, unless already registered in the current Register of Electors, apply in writing in Form 4 for registration as an elector, which duly completed form must be received by the registering officer for the said electoral district(s) on or before the registration date, namely the **15th day of January, 2025**.
- (b) Every person not disqualified on any of the grounds set out in the next paragraph of this notice is qualified to be registered as an elector in the said electoral district if he or she –

Qualifications of Electors

90(1) Subject to section 91, a person shall be entitled to be registered as an elector in one electoral district only, but he or she shall not be entitled to be registered as an elector for elections to the Legislative Assembly unless—

- (a) he or she was, on the day immediately preceding the date of commencement of this Constitution, entitled to be registered as an elector; or
- (b) he or she –
- is a Caymanian; and
 - has attained the age of eighteen years; and
 - is resident in the Cayman Islands at the date of registration; and
 - has been resident in the Cayman Islands for a period or periods amounting to not less than two years out of the four years immediately preceding the date of registration;
- or
- (c) on the day of the issue of a writ ordering an election, he or she is otherwise qualified under paragraph (b) but has not attained the age of eighteen, but he or she will attain that age on or before the polling day at the election.

Disqualifications of Electors

91(1) A person shall not be entitled to be registered as an elector in any electoral district who—

- (a) subject to subsection (2) is serving a sentence of imprisonment (by whatever name called) exceeding twelve months imposed on him or her by a court in any country or substituted by competent authority for some other sentence imposed on him or her by such a court, or is under such a sentence of imprisonment the execution of which has been suspended;
- (b) is a person certified to be insane or otherwise adjudged to be of unsound mind under any law in force in the Cayman Islands; or
- (c) is disqualified for registration as an elector by any law in force in the Cayman Islands relating to offences connected with elections.
- (2) For the purposes of subsection (1)(a)—
- (a) where a person is serving two or more sentences of imprisonment that are required to be served consecutively he or she shall, throughout the whole time during which he or she so serves, be regarded as serving a sentence exceeding twelve months if (but not unless) any one of those sentences exceeds that term;
- (b) no account shall be taken of a sentence of imprisonment imposed as an alternative to or in default of the payment of a fine; and
- (c) no account shall be taken of a sentence of imprisonment imposed by a court outside the Cayman Islands other than a sentence on conviction of an offence constituted by conduct which, if it occurred within the Cayman Islands, would constitute an offence punishable under the law of the Cayman Islands by imprisonment of twelve months or any greater punishment.
- (d) A revised list containing the names, street address and occupation of all persons qualified to vote in the said district—
- whose names appear in the current Register of Electors; or
 - who have submitted to the registration officer a duly completed and signed application for registration in Form 4 will be available at the Elections Office in George Town, the District Administration Office in Cayman Brac and the Post Office in Little Cayman for a period of twenty-one days beginning on the **29th day of January, 2025**.

 - the registering office for any electoral district; or

Island Energy Ltd. base rate adjustment – Effective 1 January 2025

Island Energy Ltd. has informed its customers in Cayman Brac and Little Cayman that it has been granted approval from the Utility Regulation and Competition Office (OfReg) to implement a 5.6% increase of its base rate, effective 1 January 2025.

The OfReg decision was made at a meeting on 10 December 2024. Post-paid customers will see the increase reflected on their January 2025 invoices, which are issued in late January and due in February). Prepaid customers will have the new rate applied to transactions beginning on 2 January 2025.

Since acquiring the assets of the Cayman Brac Power and Light Company in 2022, Island Energy Ltd., a Dart subsidiary, has invested over \$4.5 million to improve the safety and reliability of electricity services across the Sister Islands. These investments include new-generation equipment, upgraded transmission networks, new service vehicles, facility renovations, and enhanced training and safety equipment.



"These upgrades enhance the resilience of our network and equip our crews with the necessary tools required

to ensure the highest levels of service delivery to our valued customers, which should also result in fewer and shorter

unplanned outages," said Jonathan Tibbetts, Island Energy general manager.

He noted that while those improvements were essential to maintaining the safety and reliability of the electricity supply in the Sister Islands, they require appropriate funding. Base rates in Cayman Brac and Little Cayman have remained unchanged for over 20 years. Fluctuations in consumer bills over that time have been solely the result of the fuel surcharge component. Tibbetts explained.

"We know that a notice of this nature is not one that you look forward to receiving, nor is there any perfect time to make such an announcement but we are committed to transparent and open communication with our valued customers," Tibbetts stated in a letter to customers.

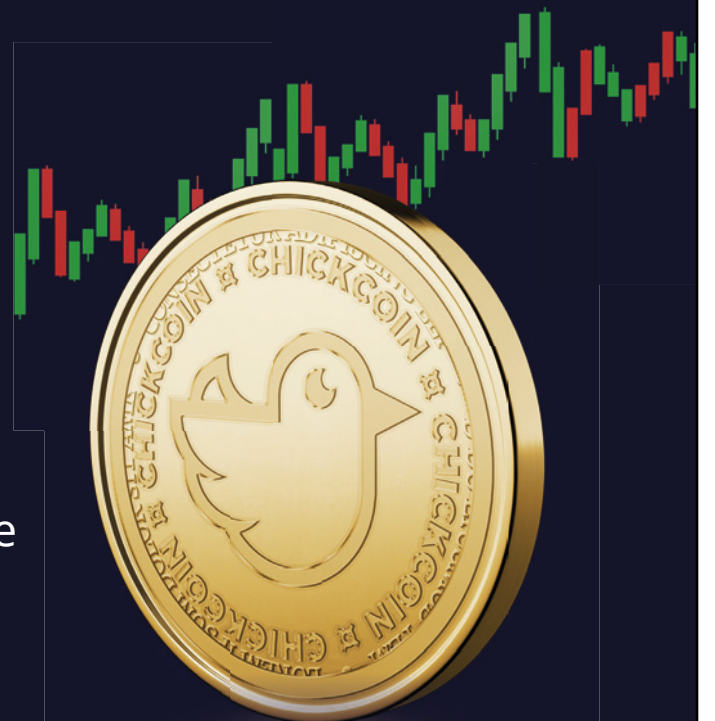

George Town Revitalization Initiative: Phase Two Updates



The Ministry of Planning, Agriculture, Housing, Infrastructure, Transport & Development (PAHITD) is excited to share the latest updates on the progress of Phase Two of the George Town Revitalization Initiative. This important project continues to move forward, with many key developments now underway and more improvements planned in the near future. Amidst the busy tourist season, Edward Street and Mary Street remain closed to facilitate surface works happening in the area.

Progress from Robson Construction (RC):

- Filling and compaction of final lift have been completed and tested.

- Approximately 85% of the concrete bands along the western side of the area have been installed.

- Excavations for bollards have been completed, and the installation of steel cages to the foundation has commenced. The pouring of bollard foundations is scheduled to begin on the night of December 17, 2024.

- The foundation for the new monument seating wall is being built and is making great progress. Final touches on the monument garden, including seating and landscaping, are expected to be completed in the first part of next year.
- 70% of the new mature trees have been

planted, with more trees to follow shortly.

Updates from Caribbean Utilities Company (CUC):

- Conduit installation up poles has been 100% completed. CUC is currently awaiting electrical connectors to proceed with the next phase of works, which includes the installation of wires and energizing the system. Temporary streetlights are planned to be erected without power for the holiday season while awaiting the energization of the system.

- Excavation for lighting in the monument area has been completed.

- Light bases at the corner of the Bodmer Building are currently being poured.

Updates from the National Roads Authority (NRA):

- Additional signage to direct pedestrians is currently in production and will be installed soon.

Phase Two of the George Town Revitalization Initiative is on track to bring significant improvements to the area, including better pedestrian safety, smoother traffic



flow, more parking, and upgraded utilities. These changes will make George Town a more vibrant and sustainable place for everyone to enjoy. day, painting, cleaning, and clearing, making the home brand new! It was hard work, but by working as a team they got it done, and felt really good about themselves.

"This project wasn't just about beautification; it was about fostering a spirit of community and giving back," said Murray, "By dedicating their time, the boys earned 10 valuable community service hours, all while delivering an early Christmas spirit to this deserving family."

Since the programme began in 2009, it has steadily grown, year-by-year. Other boys would see a change in their friends who were on the programme, and would want to join too. Teachers and parents soon saw a real change in the boys' behavior, too.

This year, the new cohort included more than 160 boys. The programme aims to empower the boys, many of whom are considered 'at risk.' It provides positive role models for them, and gives them a sense of pride in all that they do. Boys aged between 14 and 16 joining the programme are provided with a smart black tie – which has become one of the programme's emblems of self-esteem and self-respect. Part of the induction ceremony involves the boys giving an oath to adhere to the programme's core values, which include supporting each other, setting personal goals, and engaging in service projects.

In previous years the boys have worked hard tidying up parks and public places and homes for the elderly or those with challenges.

Recently, one of the partners, RBC, stepped in with a special class to help the boys with their maths. and embracing challenges.

"Practice," is the theme for this year's programme. The boys will hbe working with mentors in presentations, workshops, life-skills initiatives, and even etiquette in fine-dining.

Murray originally had the idea for the programme around 2009 after working as a counsellor at HMP Northward Prison, and seeing teenage boys who had already got into trouble with the authorities, and were asking for a second chance. He realised that, by going into Cayman's high schools, he could do something to help them before they had chosen the wrong path in life.

Murray's desire to help has flourished into today's fantastic and well-respected programme, Boyz 2 Men.

BoyZ2Men – the high school based mentoring programme started by School Counsellor Christopher Murray – went out into the community to beautify and fix up a local home.

"Each year, the boys in the Boyz2Men program take the initiative to identify individuals in need within their communities," Murray explained. "This year, one of our members recognized a home with two physically challenged residents and reached out to the program leaders.

Inspired by their empathy, the Boyz-2Men team rallied over 20 boys to lend a helping hand. Together, they tackled yard work, painted the entire house – dog house included! – and brought smiles to the faces of the grateful residents.

CIFA Futsal League – The Launch



What is Futsal?

Futsal is an exciting, fast-paced small-sided football game. It is widely played across the world and is the small-sided football format that is officially recognized by FIFA. The nature of the game places a large emphasis on technical skill and ability in situations of high pressure. It is an excellent breeding ground for football competencies that can be translated into the 11-a-side format of the game.

Futsal began in Uruguay and Brazil a shortage of playing pitches forced players to play smallsided football.

Futsal is a five-a-side game, normally played on a flat indoor pitch with hockey sized goals and a size 4 ball with a reduced bounce. It is played to touchline, and all players are free to enter the penalty area and play the ball over head-height. Games are 20 minutes per half. The laws of the game encourage and foster skillful, creative play above the physical contact that tends to be a feature in traditional football.

What are the Benefits of Playing Futsal?

There are several benefits for encouraging young people to play Futsal, as part of a balanced training program, to improve their overall technical development. Futsal is an extremely important way for kids to develop their skills and their understanding of the game. The nature of Futsal, with the smaller confines of the pitch, makes it harder to find space. In addition, the line markings prevent easy escape from tight situations, the smaller heavier ball supports closer ball control, and the unique format supports the technical development of young players.

Research indicates that individuals playing Futsal receive the ball six times more often than they would do when they are playing 11-a-side football. This allows players to perform more individual techniques such as passes, controls, fakes, feints, dribbles and runs with the ball. As well as touching the ball more often, players will often receive the ball under pressure from opponents

developing their confidence on the ball particularly in pressurized environments.

Futsal as a game naturally brings players into regular one-on-one situations with their opponent, encouraging players into quick decision making. One of the core attributes Futsal teaches young players is the importance of ball retention due to the threat of an immediate counterattack. Confidence on the ball, receiving a pass under pressure, decision-making in 1v1 situations, and ball retention are all important fundamental skills that we look to develop in young football players.

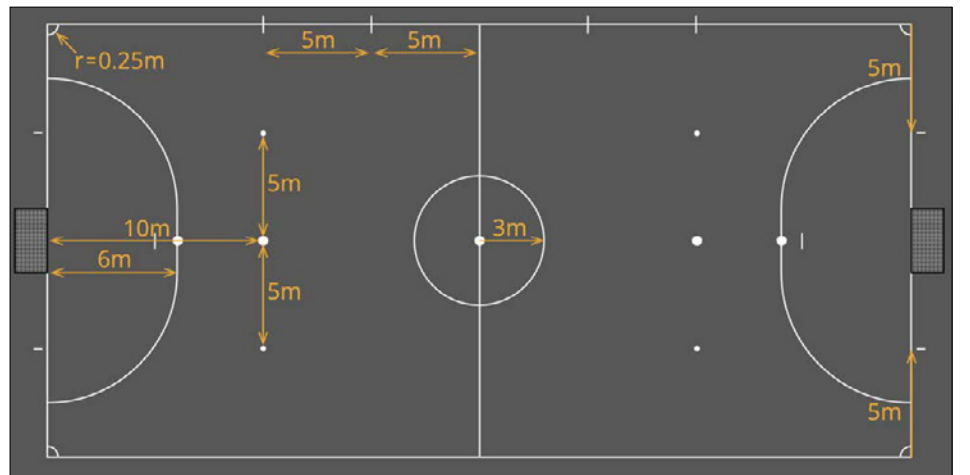
CIFA is excited to launch its Futsal program in 2025 with the start of the CIFA Women Futsal Super League.

The 2025 CIFA Women Futsal Super League competition will:

- Be conducted in accordance with the FIFA Futsal Laws of the Game under the direction of the CIFA Competitions Department.
- Be held from January 2025 to July 2025.
- Be open to all senior female clubs registered with CIFA.
- Consist of 12 teams playing in a home and away league format and a FA Cup knockout.
- Consist of a minimum of 8 players per team and a maximum of 11 players per team.
- Be played on Tuesdays, Wednesdays and Thursdays (Saturdays and Sundays, were convenient) from 6:00 p.m. to 9:00 p.m.
- The matches are 20 minutes halves and the entire game from start to the end usually does not go over one hour.
- Be played at various indoor and outdoor venues in George Town.
- Award trophies and medals to the winners and runners up of the League and of the FA Cup.

CIFA Women Futsal Super League and FA Cup Competitions Format

- 12 teams will play in one league.



- Teams will play each other twice in the league (home and away).
- A total number of 132 leagues matches.
- The CIFA Women Futsal Super League Competition will also feature a FA Cup, which will comprise of all teams playing in a knockout format.
 - o In the first round of the knockout format (preliminary round), 4 teams will receive a bye, 8 teams will play the knockout

Five-time Power and two-time Groovy International Soca Monarch Winner, Machel Montano believes that the time for competition has passed and that more collaborations are needed to take Soca music to greater heights. Montano was asked about the recent announcement of a new Soca competition coming on stream for Trinidad Carnival 2025, while at the official launch of the Pineapple Riddim held at the Queen's Park Oval in Port of Spain, Trinidad on Wednesday morning. The veteran entertainer took his time to respond, starting with the quip:

"What gets you here wouldn't get you there! Ahm, there is a desire by some people to go back to the glory days of the Soca Monarch competition, but in life, we doh get to go back. We only go forward. I must commend Mr William Munro

for his contribution, so give him a round of applause.

"In my humble opinion, Soca Monarch has done a lot for us as artistes who were rising, but in this time of MONK - The Movement of Now Knowing, we need to know what we need to do now and in my humble opinion instead of competing against each other, we need to collaborate more."

The Pineapple Riddim marks the first-ever partnership between Dwayne "DJ" Bravo's 47 Productions and Machel Montano's Monk Music and features powerhouse artistes: Machel Montano ("Wah We Doin"), Patrice Roberts ("Tun Up"), Lyrikal ("Carnival Meeting"), Rupee ("My Kinda Gyal") and rising star, Ronicia "47Ronzy" Joseph ("Come Here"). A release from Crystal Clear Solutions given to media at the event stated that "the riddim delivers a fresh yet nostalgic sound, blending groovy Soca with irresistible Carnival energy".

Montano referenced the rise of Afrobeats

and Reggaeton music, which are both comparable to the sound and speed of Soca and advised "in his humble opinion" that our focus needs to be on making Soca a global product. He said:

Soca Queen, Patrice Roberts is also featured on the riddim, but was out of the country and sent a short video recording which was played at the event. The launch attracted a number of industry professionals, stakeholders and media personnel and featured pineapple cocktails by Verve Creations for Angostura White Oak, as well as tasty edibles by Shafek's Catering and an open bar courtesy Armando Bar Services, LED and graphic printed promotional tees, luminous signs, digital screens and trendy decor by Strictly FX. Montano and Bravo engaged in a friendly arm wrestling contest refereed by acclaimed producer, Kevin "Stadic" Charles to close the event and the elder singer defeated the younger cricket star and was knighted as the new "Champion" by attendees in reference to Bravo's hit single of the same name.

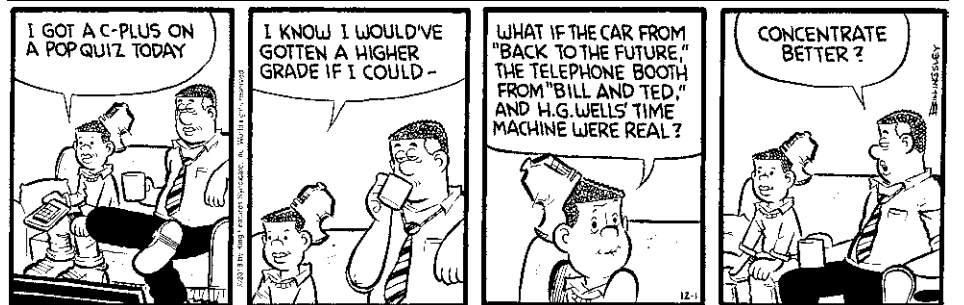

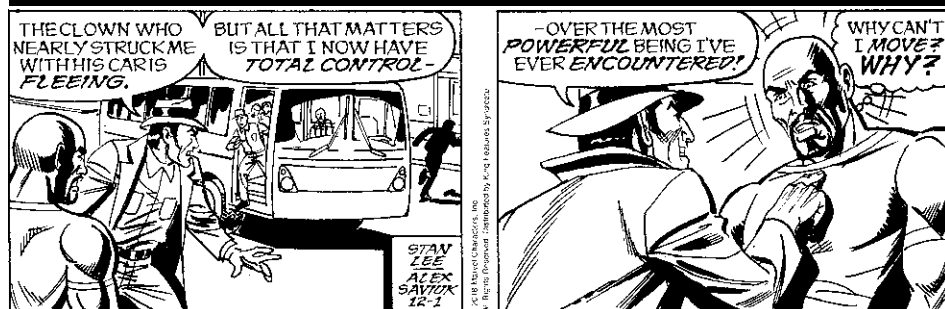
