Never crave naughty foods again (here's how)

You wake up each morning with every intention of eating "good" today.

You'll skip the drive thru line on your way to work. You'll refuse to get fast food with co-workers at lunch. You'll boycott the vending machine in the mid-afternoon. And you won't even think about having dessert after dinner.

But then tomorrow comes with its own special circumstances, and cravings get the best of you once again.

Why Do Food Cravings Always Win?

Let's face it, we live in a world where food temptations are everywhere...which leads to cravings, which leads to eating things that you shouldn't, which leads to pounds gained. Again. And again. And again. Until you're so fed up with your body that you don't even know where to begin to get yourself back on track.

Stores display the most tantalizing junk food items right where you could easily reach them. TV commercials for greasy, fattening foods portray them so scrumptiously that you literally salivate. Sugary snack items have full-page, glossy pictures in your favorite magazines. And as if all of these weren't enough,

the people in your daily life are another (constant) source of food temptation.

To make matters worse, you've been conditioned since childhood to have a positive association with the act of indulging in your cravings. You use food as a reward. You use food as a source of emotional comfort. You use food as a way to relieve stress. And quickly these associations and uses of food become habit. A habit that's not easily broken.

New Technique to End Food Cravings

Food cravings don't need to have the upper hand on you anymore. Here's how you can fight back using your most powerful asset: your brain.

Remember that your mind is an amazing thing. Once your mind is made up about something it's nearly impossible to change it.

Try This Powerful Mind Exercise: Imagine that you are peacefully floating down a river on a raft. The sun is shining, birds are chirping, and you are having a fun, relaxing time. You feel wonderful about the river because it's making you feel happy.

You may not have realized it, but up until this point you've placed unhealthy, fattening foods on a pedestal in your mind. As long as the wrong foods are on that pedestal you'll continue to give into your cravings and will continue to gain fat.

Take the wrong food off that pedestal by listing off everything negative about them...

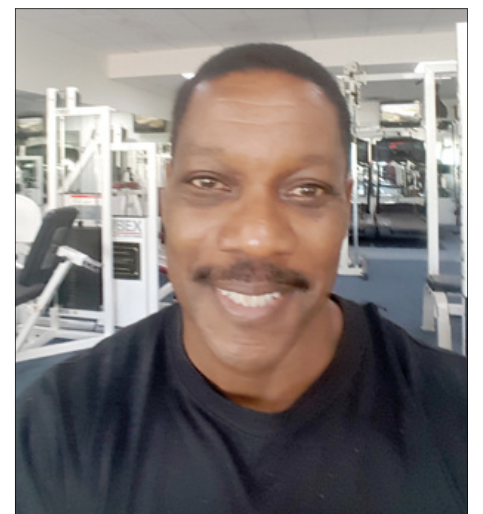
- These foods make you unhealthy.
- These foods cause weight gain.
- These foods drain your energy.
- These foods kill your confidence.
- These foods lessen your quality of life.
- These foods damage your love life.

Every time that you feel tempted to eat an unhealthy food, focus on your list of negatives. Kick the junk off the pedestal and put something healthy in its place.

Step Two: Create a STRONG Positive Association with Wholesome Foods

Now that your mental food pedestal has been cleared, put truly wholesome food items on it. Juicy fresh fruit, crispy vegetables and savory lean meats are the place to start.

Cayman First Expands Management Team with Three Senior Appointments

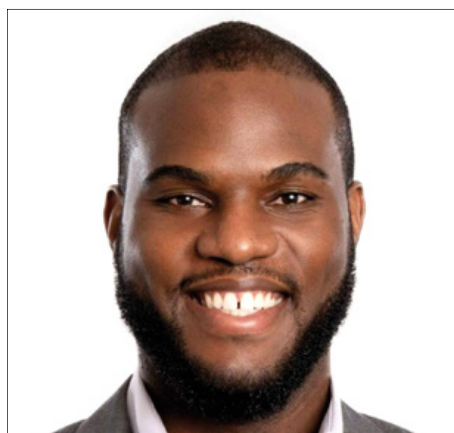

Cayman Islands 2024 Visitation Strong Despite Storm Setbacks

The Cayman Islands ended 2024 on a high note welcoming 437,842 stayover visitors between January and December 2024 representing a 2% increase over 2023's numbers.

March 2024 saw the second highest number of arrivals ever for the destination with 57,040 stayover visitors. December was also a standout month with 52,046 stayover visitors – the second highest number of visitors for December in recorded history and an increase of 4.3% year over year.

Revenue generated by tourism accommodation taxes and fees for January to November 2024 was approximately KYD\$ 38.5 million, which was an 8% increase over the same period in 2023. These revenues were bolstered by a 9% rise in the average daily rate (ADR) of hotel rooms from January to November 2024 over the same period in 2023 according to STR Inc., the major hotel industry intelligence database.

Demand for travel to the destination remained buoyant despite the challenges of an unusually active hurricane season which saw the Cayman Islands impacted by significant rainfall and other adverse weather from a tropical disturbance in June and four named storms between July and November.

“It was gratifying to see such positive growth in our stayover visitation numbers for 2024. Despite our strong results, globally the tourism sector faces economic, geopolitical and climate challenges. As an industry, locally we are not immune to these global shocks. We weathered a challenging hurricane season which saw the closure of Owen

Roberts International Airport due to hurricane Beryl during one of our busiest travel periods in July,” said Kenneth Bryan, Deputy Premier and Ministry of Tourism and Ports.

“These challenges provided an opportunity to demonstrate the effectiveness of the Cayman Islands’ emergency response capabilities as we were able to rapidly restore our accommodation and product post-storm. It also highlighted our strong relationships with airline partners who worked with us to include additional evacuation flights pre-storm and immediately resumed their regular flight schedule post-storm. We look forward to working together with both on island and international partners to

make 2025 as successful a year for tourism as 2024.”

Source Markets

United States

In 2024 the number of visitors from the United States (US) grew by 1.4% over 2023. December was a strong month for visitation from the US, with visitation from the US growing by 4.9% and the destination seeing strong performance across all regions of the United States. Standout regions for December included the Northeast which was up 12.9% year over year and the Midwest which was up 10.1% year over year.

Canada

Canada continued to be a growth market for the destination. 2024 saw the destination setting new monthly records for visitors from Canada in June, July, August, October, November and December. Visitor numbers were also up 5.3% year over year with Canada recording its second-best annual performance ever.

This growth can be attributed to continued engagement with the travel trade as well as a robust PR strategy which included features on the Cayman Islands in luxury lifestyle and travel magazines as the result of the Cayman Islands Department of Tourism’s (CIDOT) Visiting Journalist and Influencer Programme (VJIP). Additionally, at the height of winter in November 2023, Canadians were enticed to escape the cold via Cayman Country - a PR activation which saw Breakfast Television, Canada’s number one morning show, broadcast live for a week.

The UK, Ireland & Continental Europe

The UK & Ireland showed steady growth with an increase in visitation of 3.9% over 2023 showing the impact of CIDOT’s investment in the UK & Ireland via attendance at World Travel Market (WTM) London in 2023 and coverage stemming from the VJIP Programme in lifestyle magazines like Wanderlust and mainstream papers like the Sunday Times and Daily Mail.

Meanwhile Continental Europe showed positive momentum with a 12.3% growth in visitation in 2024 over 2023 which can be attributed to CIDOT’s investment in the German travel trade through attendance at major trade shows like ITB Berlin.

LATAM

Latin America remained steady with a 3.3% growth in arrivals year over year a testament to CIDOT’s investment in the LATAM

market through its VJIP programme, travel trade training and presence at travel trade shows like WTM Latin America and FIT Argentina.

Flight Capacity

According to the International Air Transport Association (IATA), the Cayman Islands saw a significant increase in its airlift between January and December 2024 with 884,279 airline seats an increase of 8% over 2023 and 5,342 flights into the destination an increase of 461 flights over 2023.

In the US this increase was driven by United Airlines with expanded service from Newark, Washington DC and Houston. Delta Airlines increased its flights from Atlanta while JetBlue Airways increased its Boston capacity.

In Canada, Air Canada and WestJet enhanced their Toronto Service with 237 flights into the destination in 2024 an increase of 36 flights year over year. Canada also saw a significant increase in seat capacity in December which was up 16.8% over the same period in 2023. In the UK and Europe, British Airways showed a positive growth in its flight capacity with an increase of 8.4%.

Accommodations

In 2024 the destination’s room inventory increased by 578 bedrooms to 8,356 with the addition of VIDA Cayman Islands and Hotel Indigo Grand Cayman to the islands’ hotel portfolio.

Both hotels enhance the destinations accommodations offerings. VIDA Cayman Islands brings a new boutique, luxury experience to the destination attracting an affluent visitor looking for wellness and adventure.


Hotel Indigo Grand Cayman is the third IHG Hotels & Resorts property in the destination - a global brand with 6,000+ properties worldwide whose extensive network will allow new visitors to discover the Cayman Islands.

“2024 was a standout year for the destination not only from a visitation perspective, but also for our business development and marketing efforts,” said Mrs. Rosa Harris, Director of Tourism.

“The first quarter of the year saw CIDOT undertake significant global travel as part of our tourism recovery strategy, and it has paid dividends in our visitation for 2024. In addition to our travel, we deepened our relationships with airline partners like United Airlines by being the first Caribbean destination to market on their Kinective media platform and British Airways by undertaking a multi-channel marketing campaign including in-flight video, digital ads and print advertorials.

On the PR front, articles in US and Canadian lifestyle publications like Elle, Nylon and Hello! Canada and our number one spot on The Sunday Times “Best Islands” list encouraged travellers on both sides of the Atlantic to visit the destination.

We also hosted the CTO State of the Industry Conference for the first time, positioning the Cayman Islands as a premier destination for meetings and incentive travel while our vibrant calendar of entertainment and culinary events gave visitors a reason to put the destination on their bucket list. We are proud of the work that the Department of Tourism has done this year, and we look forward to building on this success in 2025.”

Ministry of Health Launches Nursing Study

The Ministry of Health has launched a new research initiative dedicated to strengthening nursing in the Cayman Islands. The initiative, spearheaded by Chief Nursing Officer (CNO), Mrs. Felicia McLean, in collaboration with the Nursing and Midwifery Council, Health Services Authority, Doctors' Hospital, Poinciana Rehabilitation Centre, Health City Cayman Islands and the Public Health Department, aims at better understanding and addressing the barriers to career development within the nursing profession locally.

"Many will remember, from the time I was appointed to this role, that the professional development of our nurses is a key priority area that I would be focused on," states Mrs. McLean. "I am dedicated to identifying and overcoming the challenges that are holding back nurses' career advancement, both here in Cayman and in our region. With that goal in mind, I have partnered with key nurse leaders across our islands to develop a research tool to help us understand the root causes of the problem and possible solutions."

The focus on career development is intentional. "I have seen that often times people think of career development and

continuing education interchangeably, and they are different. Continuing education is how nursing and other professionals maintain their skills and increase their knowledge by participating in seminars, courses, and workshops. While continuing education is an important component of career development, career development is a more holistic, intentional approach to setting and reaching long-term career goals. For example, career devel-

opment helps staff nurses who aspire to become nurse practitioners to not only understand what is required to reach that goal, but actually plan out how to get there as part of their professional journey."

This research initiative, being undertaken as a Delphi study, is being led by Dr. Sharon Radcliffe, Director of Nursing at HSA, and Ms. Helen Kirk, Quality Improvement Nurse at Doctors' Hospital. Delphi is a research survey technique with four characteristic features: anonymity, iteration with controlled feedback, statistical group response, and expert input.

For this study, there will be three short rounds of surveys, each 5-10 minutes in length. The first round will ask participants for basic demographic information along with two questions about the perceived barriers to career development and solutions to overcome these. The participants' feedback in the first round will inform themes that will be presented back to them in round two, where they will be asked to score each theme. Again, the response from round two will inform the questions of round three where a priority ranking method will help to identify the most important barriers and solutions.

"Anonymity is a key component of this method, and one that we are relying on to ensure that we have the broadest level of participation across our islands," Mrs. McLean explains. "The multiple rounds of surveys, which are informed by participants' previous responses, will also ensure that we obtain consensus from the group on where the priorities lie. This is a great way to ensure that our nurses are not only able to express themselves freely, but that there is buy-in for the actions that will follow, given that they determined the priority areas, both for the problem and for the possible solutions," she adds.

The nursing study is open to all currently practicing registered nurses and registered midwives who are employed and working in the Cayman Islands. "The survey link was sent via email by the Department of Health Regulatory Services, on behalf of the NMC. However, if you meet the criteria and have not received the link, please reach out to Khailan.O'Connor@gov.ky so that your voice can be heard," Mrs. McLean adds.



Participants wishing to engage in this process must complete the Round 1 survey by no later than Monday, 3 February, 2025.

The vital support of the JDF's Air Wing played a crucial role in airlifting BIC team members Peri Smalldon and Joseph Jamieson, along with scientific equipment, into a remote part of Colliers Wilderness Reserve. This operation not only facilitated the transportation of new equipment to collect crucial data for the BIC Programme but also enabled the retrieval of outdated tools from the protected area. This opportunity allowed the CI Regiment to offer practical training for their members, while the Jamaica Defence Force benefited from their Air Wing crew gaining valuable experience flying overseas and engage in conservation work. Collectively, all organizations gained valuable experience while supporting one another in successfully achieving their objectives.

The National Trust for the Cayman Islands currently protects just over 3,500

acres of critical habitat. Colliers Wilderness Reserve is one of the primary habitats where our Blue Iguanas are released into the wild. This protected area is of ecological importance and is over 190 acres. An abundance of local flora and fauna can be found in Colliers Wilderness Reserve as this protected area maintains the biodiversity that lives there. After the helicopter dropped off the troops and BIC team members, they were welcomed by a wild, Blue Iguana that had been released into Colliers Wilderness Reserve approximately 5 years ago. The Blue Iguana stayed with the team as they conducted their work and posed for a few photos.

On the 8th May 2022 (International Blue Iguana Day), the Cayman Islands Regiment adopted "Lissy" as their Blue Iguana who is the first Regiment Mascot for the Cayman Islands. Lissy currently resides at the Blue Iguana Conservation Facility. The National Trust for the Cayman Islands and Blue Iguana Conservation is proud of the continued partnership and collaboration with the Cayman Islands Regiment. We are grateful for their ongoing support in helping us with the Blue Iguana Conserva-

tion Programme and maintenance of our Protected Areas.

"We are incredibly grateful for the assistance of both the JDF and the C.I. Regiment. The airlift saved countless hours of hiking through treacherous conditions in the Colliers Reserve where it is difficult

and potentially dangerous to transport even the most basic equipment. Both the JDF and C.I. Regiment acted with admirable professionalism and we welcome the continued partnership with both" says Frank Roulstone, Executive Director of the National Trust for the Cayman Islands.

THE NEW TRUMP ERA GETS UNDERWAY

It amounted to a bonfire of executive orders as second-time president Donald Trump and his predecessor (and previous successor) Joe Biden engaged in a veritable tit-for-tat over a few critical days and hours spanning the ending of the Biden presidency and the starting of the new Trump era.

As fast as ex-President Biden rushed through a raft of executive orders including pardons and relaxing restrictions on Cuba, the new second-time White House incumbent Donald Trump set about revoking them and forcing through a series of his own on his first day back.

INTERNATIONAL

Far-reaching international policy shifts and directives from ending wars to slapping massive trade tariffs on just about the rest of the world are hallmarks of what's to come, including seeking to rename the Gulf of Mexico as the Gulf of America and pulling the United States out of the World Health Organisation.

Drastic changes to previous climate change commitments, energy, and electric vehicles are expected to have repercussions far beyond the shores of the US.

Where President Biden has overturned

a previous Trump decision to pull the US out of the Paris Climate Agreement, Mr Trump has now in turn once more hauled the US out of the global agreement.

He has also declared a national energy emergency in the US to underline another major policy change. In reversing a Biden ban on drilling in parts of the Arctic, Mr Trump said he was repositioning America as a major energy exporter to bolster the economy.

"We will be a rich nation again," he declared, "and it is that liquid gold under our

feet that will help to do it."

Also, all US foreign assistance programmes have been suspended pending review for policy alignment with American values.

DOMESTIC

Domestic policy upheavals include controversial measures to clamp down on immigration and pardoning around 1500 convicted rioters from the January 6th 2021 insurrection to overturn that elec-

tion outcome which Mr Trump still maintains he won despite numerous court rulings against him.

Changing the constitutional birthright mandate, a new federal hiring freeze, and changes to the US government's diversity hiring policy, are among the flood of new executive orders rushed through.

How free speech is interpreted fell under the Trump executive pen, including overturning a last-minute Biden ban on the TikTok platform - which has been under consideration for some time over concerns of Chinese control.

ByteDance Ltd, the parent company of TikTok is incorporated in the Cayman Islands.

Mr Trump also has the support of several of the US (and the world's) top tech entrepreneurs including the heads of Amazon, Meta and Tesla/Space X. Elon Musk who heads the latter will also run a new US government advisory body called the Department of Government Efficiency (DOGE) tasked with cutting down the size of the federal government.

And, in what has been seen in some circles as a particularly chilling decision, President Trump directed that "all necessary and lawful action" be taken to ensure that there are enough lethal injection drugs to carry out the death penalty.

TRUMP SCRAPS BIDEN'S CUBA GESTURE

Residents of Cayman hoping to take advantage of ex-US President Joe Biden's lifting of travel restrictions on Cuba now have to rethink their plans.

As the saying goes, the ink had not even dried on the Biden reprieve before it was revoked by his successor (and former predecessor), now second-time President, Donald Trump.

The decision by ex-President Biden to remove Cuba from the list of countries deemed as state sponsors of terrorism (SST) was expected to open the pathway to making it easier for many interactions with Cuba, including travel by non-US citizens also planning to visit the United States.

The Biden order was also conditional on an agreement brokered by the Catholic church for the Cuban government to release over 500 political prisoners.

It would have also meant that residents of the Cayman Islands who visit Cuba would have had less hassle with their US ESTA (Electronic System for Travel Authorization). However, the Trump executive order reinstates the restrictions which means those ESTAs will once again be severely restricted and even suspended if they visit Cuba and subsequently plan to travel to the States.

Overturning the just days-old Biden executive order came in a flurry of new executive orders by President Trump within hours after being formally sworn in as the 47th President of the United States. He was also the 45th but lost the bid for



a second consecutive term after losing the 2020 election.

Responding to the Trump decision, the Cuban government called it "an act of arrogance and contempt for the truth."

"This act of mockery and abuse confirms the discredit of the lists and unilateral mechanisms of coercion of the United States Government," said President Cuba's Miguel Díaz-Canel.

"The legitimate and noble cause of our people will prevail, which will once again win," he asserted.

Cuba has also consistently denied any support for terrorism. During his first term, President Trump had slapped the SST on Cuba citing the government's support for Venezuelan leader Nicolas Maduro

The Biden executive order to remove Cuba from the terrorism list was expect-

ed to relax other crippling US measures which have kept the country in an economic crisis. Cuba has been in the grips of

a US trade embargo since 1958.

With Cuba now back on the US SST list is a clear indication of the new Trump administration's intention to resume its hardline policies on Cuba which prominently featured in his first term as president.

Driving those policies now is new US Secretary of State Marco Rubio, who is Cuban-American.

He has been a strong supporter of sanctions against Cuba both as a Florida legislator and a US Senator. Rubio had also stated before taking up his current post that he was in favour of reimposing the sanctions lifted by ex-President Biden.

In a foreign policy seesaw, the US restrictions now reimposed by Trump after being relaxed by Biden were previously reinstated during the first Trump administration after they were lifted by ex-President Barack Obama.

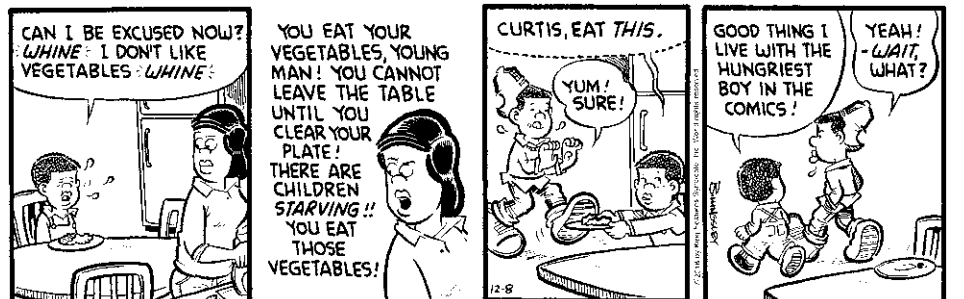

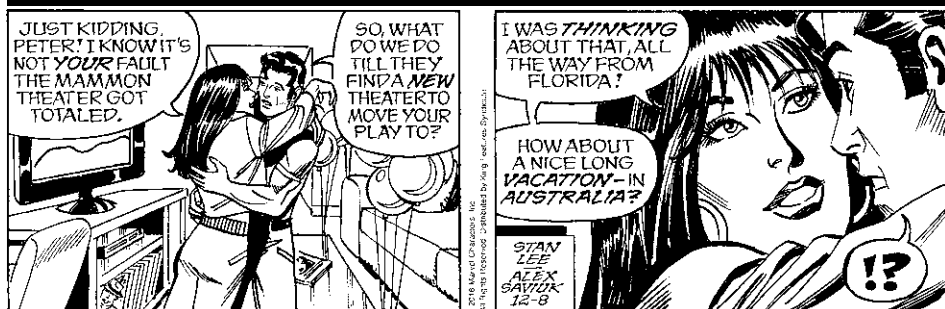

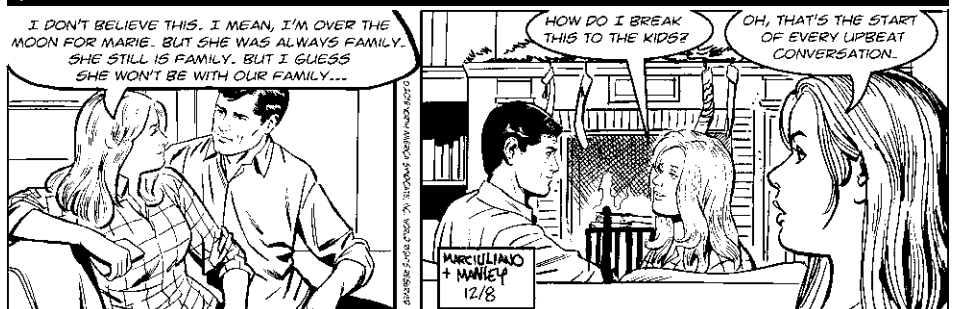
