STRONG EARTHQUAKE AND TSUNAMI THREAT RATTLE NERVES

Cayman went into a state of high alert on Saturday evening following reports of a massive earthquake in the Caribbean Sea in the vicinity of the islands raising fears of the risk of a tsunami.

Official reports measured it at 7.6 on the Richter scale and put the epicentre about 129 miles southwest of George Town. It was described as "one of the strongest earthquakes in the region in recent memory".

To everyone's relief the tsunami didn't materialise and the 'all-clear' was given by Hazard Management Cayman a few hours later.

HMCI had earlier issued the tsunami threat as a precaution and urged the pub-

lic to "stay safe and remain alert".

"This was a large earthquake and we are thankful that no major damage has been reported on our Islands," it said in an update.

The 7.6 earthquake was followed by a smaller 4.3 tremor.

The event also caused other countries in the western and eastern Caribbean to go on tsunami alert including Cuba, Jamaica, and parts of Central America, along with Antigua and Barbuda, Dominica and other islands in the eastern Caribbean chain.

Low-lying, densely-populated Cayman with its extensive tourism infrastructure was seen as particularly at risk. This was reflected in the numerous international and regional news reports after the news broke about the strong undersea earthquake so close to the islands.

The U.S. Geological Survey reported that the earthquake occurred at around 6:23 p.m. Eastern Time, with an epicentre about 129 miles southwest of George Town, the capital of the Cayman Islands, and 372 miles west of Kingston, Jamaica.

A short time later, the U.S. National Tsunami Warning Center issued a tsunami advisory for Puerto Rico, the U.S. Virgin Islands and the British Virgin Islands. The advisory for those islands was later cancelled.

The US National Weather Service said in a social media advisory that "a one to three-foot tsunami is still an impressive force of nature capable of strong and un-

ment's National Oceanic and Atmospheric Administration(NOAA) said, "tsunami waves reaching 1 to 3 meters above the tide level are possible along some coasts of Cuba." It added waves between 0.3 and 1 meter above the tide level are possible for some coasts of Honduras and Cayman Islands.

It also issued a tsunami threat for Cuba, Honduras and the Cayman Islands.

However, that was later withdrawn and updated as, "according to the latest modelling and information, the tsunami threat has passed for the entire region."

Each year, Department of Education Services (DES) releases a data report to support education authorities and policymakers in making well-informed decisions. This report offers valuable insights into the present condition of education in public schools. It also highlights enrolment trends, compares private and public enrollment provisions, and evaluates performance trends within the public education system.

Upward Trend in Enrolment



Early Childhood Care & Education (ECCE) enrolment increased by 2.5 percentage points compared to 2021-22



There is a near-even split between genders 48% female & 52% male



More than half of students attend government schools (55%), with the remaining students split between private schools (44%) and homeschooling (1%)

- Enrolment for compulsory education saw a modest increase of 0.13%, with near parity between girls (49.8%) and boys (50.2%) compared to 2022-23.
- Government school enrolment increased by 4.7% since 2022.

Of the students who sat 5 or more subjects, 62.6% achieved the national benchmark, 33,7% of cohort achieved Honours status after achieving passes in 7 or more subjects.

Year 11 Prior Attainment

- CAT4 test scores predicted that at least 46% of students would perform satisfactorily in the core areas of Mathematics, English and Science
- Value-added analysis revealed that Year 11 students with the lowest CAT4 scores significantly improved by 1.14 grade points in English and 1.2 points in Science, allowing them to obtain satisfactory grades.

Year 11 SEND

Approximately 7% (27) of the Year 11 cohort required Special Educational Needs and Disabilities (SEND) provisions. Among these students: 74% achieved acceptable grades in English; 33% in Mathematics; and 67% in Science.

Year 12

Continued positive trajectory in core subjects, with 86% of students who sat the English examination achieving Level 2 qualifications in the subject.

This year also saw:

- 80.6% and 60.6% of students who sat Science and Mathematics examinations attaining Level 2 passes in the respective subject areas.
- 59.4% of students who sat 5 or more subjects achieved the national benchmark (5+ passes including English & Mathematics).

The Elections Office's comprehensive training programme for polling staff is in high gear in Grand Cayman and Cayman Brac, ensuring that all personnel are well-prepared for the upcoming General Election on 30 April. Training for the Returning and Deputy Returning Officers began in November 2024.

Training sessions focus on critical aspects of the electoral process, including

opening the polls, voter polling procedures, handling election materials, assisting voters with disabilities, and the proper protocols for closing the polls. The training aims to equip staff with the knowledge and skills required to ensure a smooth and efficient voting experience for all electors.

On General Election Day, the Elections Office will operate 65 polling stations across the Cayman Islands. Each station will be staffed by a presiding officer and two poll clerks, supported by field officers and logistical staff.

To ensure a professional and legally compliant election process, a dedicated team of officials has been appointed. Returning Officers, appointed by Her Excellency the Governor, Mrs Jane Owen, oversee the organisation and conduct of elections in their respective electoral districts, ensuring that all procedures adhere to the required regulations. Presiding Officers will lead the operations at polling stations, managing the voting process, issuing ballot papers, and ensuring that election laws are upheld. They will work closely with poll clerks, who are responsible for verifying voters, and facilitating a seamless voting experience.

Supporting the polling operations externally, field officers will be stationed at polling divisions to guide voters to their correct polling stations and help maintain order throughout the day. Logistical officers will play a crucial role in the efficient functioning of the election by setting up polling stations and ensuring they remain well-stocked with necessary materials.

The Elections Office remains committed to conducting a fair, transparent, and efficient electoral process. Through these training sessions, election staff are given the necessary skills and knowledge to uphold the integrity of the democratic process.

The Elections Office strongly encourages all members of the public to check the official Register of Electors to ensure their name and address appear correctly. The list is available for review on the Elections Office website at elections.ky. If corrections are needed to any information that may be missing or inaccurate, individuals are encouraged to submit a claim or objection by 19 February 2025. Form 9 should be used for objections, and Form 7 should be used for claims. These forms can be downloaded from the Elections Office website and submitted in person or via email to office@elections.ky.

The Elections Office looks forward to seeing strong participation in the General Election on 30 April 2025.

REFERENDUM LAW PASSES. NOW IT'S OVER TO THE VOTERS

In what is certain to be a prominent (and possibly dominant) topic in the campaign for the April 30th election, the Cayman Islands Parliament on Thursday, February 6th passed legislation for a referendum to be held as part of the upcoming poll.

The three-question non-binding referendum seeks voters' responses on whether a cruise pier should be built, holding a national lottery, and whether possession of small quantities of cannabis should be decriminalised.

The depth of interest and passion surrounding the timing of the referendum and the selected issues was evident during the Parliamentary debate - with even premature reports that the legislation had passed.

The referendum bill had only in fact cleared the second hurdle of the Parliamentary process on Wednesday night by a vote of 13 in favour and five against in the Second Reading of the bill. It was only finally passed in the Third Reading on Thursday night with a changed vote of 11 in favour, four against, and three members absent.

Despite the difference in the vote count between the two voting stages, the bill nevertheless passed with a resounding majority.

Its passage was guaranteed by the main opposition People's Progressive Party(PPM/ Progressives) assuring the minority UPM (United People's Movement) government of



its support on the issue.

The four defected UPM members opposed the referendum bill amidst criticism that they were part of the Cabinet collective responsibility that had previously decided to hold it.

But speaking during the debate, MLA Andre Ebanks formerly UPM Deputy Premier who now leads the new Cayman Islands Community Party (TCCP) largely formed of the disaffected UPM members, sought to explain the internal divisions, including rifts over the referendum and cruise pier issue which led to their split from the government.

Echoing comments made by his TCCP colleagues, he stated: "It does not require a referendum. It requires leadership", and chided MPs supporting the referendum of "dodging their responsibilities".

According to the TCCP leader, the issues in the referendum should have been brought to Parliament to be debated "because that's what the people elected us to do." He also stated that the time for an adequate awareness campaign between now and the April 30th election date was insufficient.

Particularly on the contentious cruise pier issue, Mr Ebanks called the referendum "a smokescreen" to divert attention from addressing matters affecting the cruise and wider tourism industry.

"The TCCP will not participate in a smokescreen," he insisted.

Of the three issues included in the referendum - building a cruise pier, decriminalising small amounts of cannabis(marijuana/ganja) and holding a national lottery - it is the cruise pier topic which has attracted the most attention and controversy...again.

The long-running contentious issue already seems set to dominate the campaign platforms, public conversations and organised debates during the election campaign.

The rifts over the referendum, particularly the cruise pier, have been further highlighted in statements from two local organisations championing the issue from opposing sides.

The Association for Cruise Tourism (ACT) in the Cayman Islands said it is "celebrating a hard-fought victory" following the Parliamentary vote.

"This is exactly the outcome ACT has worked tirelessly to achieve," ACT's Executive Program Manager Ellio Solomon said in a statement.

He called it "a major step toward aligning Cayman's cruise berthing infrastructure with modern standards, and we are proud that our efforts have ensured the voices of Caymanians will be heard on this critical issue."

Solomon, a former parliamentarian, also said ACT will continue to push for transparency, education and dialogue "to ensure the best possible outcome for all Caymanians."

On the other side of the argument, CPR Cayman (Cruise Port Referendum) remains opposed to the idea citing a lack of transparency, lack of referendum regulations, foreign interference and inadequate information among its concerns.

"To date, the Government has provided no transparency regarding the proposed cruise berthing facility which it is asking the public to vote on. There has been no disclosure of a detailed plan, cost projections, location analvsis, or environmental impact assessmentscritical data that should be available before Caymanians are asked to make a decision of this magnitude," it said in response to the vote to hold the referendum.

CPR Cayman said it believes that local cruise operators are essential contributors to the tourism economy and that their longterm success must be protected.

"However the push for mass cruise tourism at the proposed magnitude will not benefit local businesses, but large international cruise lines seeking to reshape Cayman's tourism landscape in ways that may not align with our island's long-term best interests," it cautioned.

2024 Deputy Governor's 5K Challenge a huge success



The 2024 Deputy Governor's 5K Challenge has set a new benchmark in community engagement and philanthropy, raising a remarkable \$90,000 for its three beneficiaries: Boyz2Men, the National Council of Voluntary Organisations (NCVO), and the Addison Kelly Memorial Scholarship Fund.

Marking the event's 10th anniversary, the DG's 5K challenge attracted more than 2,100 participants while celebrating a decade of promoting fitness and giving back to the community under the unifying theme of "Supporting our future generations".

Deputy Governor Hon. Franz Manderson expressed his heartfelt gratitude for the overwhelming support the fundraising event received. In his statement, Mr. Manderson said, "As a result of the unwavering support from the business community, the civil service, the statutory authorities, government companies, and the wider community our three charities will each receive \$30,000 to further their efforts within our community."

The funds will be used by Boyz2Men to support their academic assistance and mentoring program, the Addison Kelly Memorial Scholarship Fund to implement a Mental Health First Aid training program for community workers, and the NCVO to support their preschool program, foster care services, and continued family assistance

The charity road race commenced on April 14 in Cayman Brac with 197 participants, followed by the Little Cayman leg on 21 April, with 56 participants before concluding in Grand Cayman on 28 April with 1915 participants.

Expressing her gratitude for the success of the 2024 installation, Jennifer Ahearn, Co-chairperson of the DG's 5K Challenge, said, "The event is not just about raising funds to support these amazing charitiesit's also about creating the opportunity for everyone to come together, public and private sector, of all ages and from all walks of life, to enjoy some fellowship, fresh air, and get some exercise while having a lot of fun."

Among the major sponsors that played a crucial role in this year's challenge were the Platinum Sponsor, Appleby Law firm, and Gold Level Sponsors including EY, Butterfield, Davenport Development, The Cayman Islands Civil Service Association Cooperative Credit Union, and Dart. West Bay Disruption Patrols Result in an Arrest, and **Recovery of a Stolen Motorbike**

As it continues to grow, the Programme sets a powerful precedent for others, showing how collective action and local engagement can create a sustainable and resilient future for all.

RULING PARTY RETAINS POWER IN TURKS AND CAICOS ELECTION

The ruling Progressive National Party (PNP) has retained power in the Turks and Caicos Islands with another resounding win in consecutive elections.

Seventy-five-year-old Premier Charles Washington Misick led his party to victory on Friday, February 7th 2025 again trouncing the main opposition People's Democratic Movement(PDM).

The PNP won 16 of the 19 seats at stake. It also won seven of the 10 local constituencies and all of the nine At-Large seats.

Of the other three seats, two were won by the PDM which had last formed the government from 2016 to 2021. The other seat went to the PDA The Progressive Democratic Alliance (PDA).

In the last election in 2021 for the then 15-seat House of Assembly the PNP had won all but one seat. Premier Washington is a former chief minister of the Turks and Caicos Islands and was Leader of the Opposition when he navigated his party back to office in 2021.

In a victory address, he said: "On this journey, we will have great successes to-

gether, and we will continue the economic and social transformation of these islands. No journey is without bumps and setbacks. You won't always agree with the decisions we make but I will always be honest with you about why we make certain decisions and the challenges we face."

Ensuring a Healthier Environment

A series of comprehensive training sessions to strengthen the capacity of environmental and technical officers in water quality monitoring, data analysis, and storage were recently concluded in the British Virgin Islands (BVI).

The Ministry of Environment, Natural Resources, and Climate Change, in partnership with H. Lavity Stoutt Community College (HLSCC), CERMES, and Spatial Innovision Ltd, collaborated to train over 21 officers from various departments, including the Environmental Health Division, Water and Sewerage Department, Agriculture and Fisheries, National Parks Trust, and Town and Country Planning.

Ms. Atoya George, Project Coordinator, emphasised that the RESEMBID project -Strengthening BVI's Water Quality Monitoring Programme to Inform Effective Environmental Management and Spatial Planning - focuses on capacity development to equip officers with essential skills for managing water quality data. "Through these sessions, participants gained expertise in spatial analysis and comprehensive water quality monitoring techniques," she noted.

Participants also completed a five-day workshop in September 2024, strengthening their capabilities in data collection, testing, analysis, and laboratory maintenance. Final geodatabase training, completed in December 2024, prepared officers to utilise the newly developed water quality geodatabase.

Andrea Floudiotis, RESEMBID's Senior Programme Manager, commended the collaborative effort, highlighting that improved water quality monitoring is vital for human and environmental health. "We applaud the Government of the Virgin Islands for increasing its capacity to collect and utilise water quality data to inform pollution control strategies and evidence-based decision-making." Effective water quality monitoring preserves biodiversity, safeguards public health, and helps countries better respond to the increasing challenges posed by climate change."

This initiative underscores the Ministry's

commitment to sustainable marine environment management. By equipping officers with the necessary tools and knowledge, the Ministry aims to better manage the human impacts on marine ecosystems, promote effective pollution monitoring, and support sustainable spatial planning.

The latest phase of the BVI SMART Schools Project expands its mission to maximise safety and sustainability with upgraded infrastructure, improved safety standards, and the adoption of green practices.

Michel Ambrose, SMART Schools Project Manager, highlighted the project's dual focus: "This project, supported by our partners, not only safeguards our students but also empowers them with the knowledge and tools to thrive in an ever-changing world. These upgrades are a critical step toward achieving that vision."

The 14 participating schools have undergone extensive assessments and improvements to meet stringent international safety standards under DDM's guidance. Enhancements include structural upgrades, energy and water conservation measures, and the implementation of sustainable practices such as school gardens, recycling, and waste reduction.

Schools that meet these safety benchmarks are certified as "Safe," while those incorporating advanced green practices achieve the "SMART" designation. With infrastructure upgrades and green initiatives already making an impact, the BVI SMART Schools Project continues to set a new standard for safety and sustainability in education.

The DDM remains dedicated to ensuring that every public school in the Virgin Islands is equipped to face future challenges, creating secure, SMARTer spaces for students to learn and grow.




