# DEH Glass Recycling program is back

The Department of Environmental Health (DEH) and the Flowers Group are excited to announce the resumption of the glass recycling program. Residents are now encouraged to drop their glass waste to any of the nine recycling depots across Grand Cayman.

DEH Director, Mr. Richard Simms explained that the resumption of the glass recycling program aims not only to reduce the environmental impact of glass waste but also to promote sustainable practices among residents. "This public-private partnership fosters a sense of camaraderie and community while highlighting the collective responsibility in preserving the natural beauty of the Cayman Islands. It's also a sustainable step forward to a cleaner and brighter future. We are looking forward to a long standing working relationship with the Flowers Group," he said.

One of the key components of the program is the use of the crushed glass in the manufacture of blocks, incorporating the recycled glass into a new product manufactured by Flowers Group. Mr. Frank Flowers, Managing Director of the Flowers Group, said "Flowers is a generational company. Our goal is to create success for the Cayman Islands for generations to come. This project is a small part of the bigger picture to achieve this objective. We are thrilled to recycle glass products locally and repurpose these materials into our building products ushering a new wave of sustainability for the Cayman Islands building industry."

Glass is a recyclable material that can be processed endlessly without losing its quality, making it an ideal candidate for recycling. The glass recycling program in the Cayman Islands was originally initiated in 2012 and was temporarily suspended in 2022.

Residents are encouraged to dispose of their glass waste into the traditional brown bins located at each the recycling depot across Grand Cayman for the responsible disposal of glass waste. These locations have been carefully chosen to ensure accessibility for all, whether you live in George Town, West Bay, or the North and Eastern districts. They are:

- Foster's at Republic Plaza, West Bay
- Camana Bay Recycling Centre, West Bay
- Kirk Supermarket, George Town
- Foster's at the Airport Centre, George Town



- BarCam Service Station, Red Bay
  - Foster's at Countryside Shopping Village, Bodden Town
  - Haig Bodden Sport Centre, Bodden Town
  - Craddock Ebanks Civic Centre, North Side
  - Captain George Dixon Park, East End
- The DEH is committed to continuing to serve the community while promoting



sustainable practices among residents. Together, the DEH and the Flowers Group are implementing a sustainable model that can inspire future environmental initiatives within the community.

# A Legacy of Service: Cayman Islands Red Cross Celebrates Volunteers Who Keep the Community Safe



Twenty years ago, in the aftermath of **Hurricane Ivan**, a group of extraordinary individuals stepped forward. With homes destroyed, streets flooded, and uncertainty in the air, these volunteers became the backbone of the Cayman Islands Red Cross (CIRC). They assessed damage, provided first aid, managed shelters, and offered comfort to those who had lost everything. Their dedication became the foundation of what would later be known as **"The Henris"** — an award ceremony created in their honor.

That legacy of service continues today. **Recently, the Cayman Islands Red Cross hosted its Annual Volunteer Appreciation Ceremony at the Marriott Hotel, recognizing the incredible contributions of its volunteers throughout 2024.** It was an evening of gratitude, reflection, and celebration, as the CIRC honored the individuals who dedicate their time and energy to keeping the Cayman Islands safe.

## Seven Emergencies, Three Storms, and a Community That Came Together

The **2024 hurricane season** was one of the most active in recent years. **Three named storms — Helene, Beryl, and Rafael — swept across the islands, bringing destructive winds and heavy rains.** On top of that, two severe floods and two house fires forced residents to evacuate their homes. Each time, the Red Cross was there.

CIRC **opened its shelters seven times** this year, providing evacuees with a safe place to stay, warm meals, and emotional support. In addition, volunteers worked alongside **Hazard Management Cayman Islands (HMCI) and the Cayman Islands Regiment** to distribute relief supplies, fill sandbags, and transport seniors to safety.

It was a relentless year — but one that proved, once again, that when disaster strikes, Cayman's Red Cross volunteers are always ready.

The evening's **Guest of Honor, Chief Officer of the Portfolio of the Civil Service Mrs. Gloria McField-Nixon**, commended the volunteers for their dedication, emphasizing the profound impact they have on the lives of those in need.

Whether responding to storms, supporting displaced families, or ensuring the most vulnerable among us are cared for, your commitment strengthens the fabric of our community. The Cayman Islands is a safer, stronger, and more resilient place because of you."*

# Members Approve and Adopt Historic Amendments to Standing Orders to Enhance Parliamentary Procedures

On February 6, in one of its final acts of the 2021-2025 Term, Parliament unanimously approved Government Motion No. 9 and thereby adopted the Parliament Standing Orders 2025, a new and modern set of Standing Orders. This represents the first comprehensive overhaul of the Parliament Standing Orders since Standing Orders were first introduced in 1976. The new Standing Orders will come into force on 28th February 2025, and will govern procedures when the new Term commences following the upcoming General Elections.

The Standing Orders are the legal rules which establish and guide parliamentary procedures.

They were initially permitted under the Cayman Islands Constitution Order (1965) to regulate Meetings of the Legislative Assembly, Committees, and other parliamentary activities, and were formally promulgated by the Legislative Assembly in 1976. Since then, the Standing Orders have received only ad hoc revisions, despite the significant constitutional and parliamentary advances that have occurred since 1976.

“Our Parliament and its Standing Orders are the cornerstone of our democracy, and for many years, I have longed to see them revised to enhance the effectiveness and efficiency of our legislative proceedings,” commented Speaker Hon. Sir Alden McLaughlin. “These reforms represent a significant step forward in strengthening our parliamentary democracy and finally bring the procedures in Parliament into alignment with the constitutional and other parliamentary

changes which have taken place over the last 15 years.”

“They will enhance the ability of Parliament to speak with and scrutinize the work of Government effectively while ensuring that parliamentary proceedings remain accessible to the public and in line with modern needs,” the Speaker noted. “Last night’s unanimous adoption by the Parliament of these modern fit for purpose Standing Orders brings me a great deal of satisfaction and pride.”

As Minister in the 2005-2009 Administration, Sir Alden led the Constitutional Modernisation Initiative on behalf of the Cayman Islands Government. This resulted in the replacement of the Cayman Islands Constitution Order 1972 and the approval of the Cayman Islands Constitution Order (2009) in a historic referendum in May 2009.

As Premier, Sir Alden also led the significant effort to further advance the Cayman Islands Constitution with the amendment of the Cayman Islands Constitution Order 2009 by the Cayman Islands Constitution Order (2020). Among other things, this amendment resulted in the transition of the Legislative Assembly to the Parliament of the Cayman Islands.

Sir Alden also championed the effort to make the Parliament an autonomous entity, independent of control by the Executive and successfully piloted the Parliament Management Act to safe passage, thus creating the Parliament Management Commission and Parliament Management Council (which now manages the administration of The Parliament).

“The Parliament Standing Orders 2025



is the final piece of the structural change necessary to give the Cayman Islands a modern, forward-looking democratic framework, fit for the 21st Century,” said the Speaker. The new Standing Orders is the product of more than three years of work by the Standing Orders Working Group. The Group commenced its review of the Parliament Standing Orders in 2021 under the chairmanship of the Speaker at that time, Hon. Dr. W. McKeever Bush, and continued under former Speaker, Hon. Katherine Ebanks-Wilks.

During the current Speaker’s tenure, the Working Group, which included the Honourable Attorney General, the First Legislative Counsel, the Clerk of Parliament and Assistant Clerks, held more than 25 meetings over the last year to rigorously review the Standing Orders.

#### Key areas of reform include:

**Improved legislative processes:** The amendments introduce clearer procedures for the presentation, reading, and publication of Bills, ensuring greater consistency with the Constitution, namely the 2020 amendment to the Constitution which provided that Bills must be published at least 28 days before being considered unless the Premier certifies urgency.

**More structured parliamentary sittings:** The new Standing Orders formalise the meeting days of Parliament as Wednesdays, Thursdays, and Fridays, and adjust sitting hours from 2 p.m. to 8 p.m., with an optional 30-minute suspension at 5 p.m. Additionally, a fixed recess period is introduced from the first week of July to

the first week of September each year, except for urgent and extraordinary matters.

**Enhanced transparency mechanisms:** The introduction of a Premier’s Question Time every Wednesday for 30 minutes allows Members to pose questions about the Government’s overall performance. A 15-minute Urgent Questions period will also be available at each sitting, allowing Members to raise pressing matters in the public interest.

**Strengthened committee oversight:** The Finance Committee will now have enhanced powers to summon individuals and request necessary documents for its deliberations. Provisions also allow the House to resolve itself into a Finance Committee or for the Chairman to summon a meeting when needed.

**Greater efficiency in parliamentary debates:** The reforms introduce time limits for speeches — personal explanations will now be limited to 10 minutes, while government statements will be capped at 20 minutes with prior Cabinet approval.

**Modernised procedures:** Provisions now allow for virtual attendance in exceptional circumstances with the Speaker’s approval, reflecting the evolving needs of Parliament. It also allows for a Member to use supplementary visual aids during a debate.

**Standing Business Committee:** Specific provisions were added for this Committee which will now be chaired by the Speaker of Parliament and no longer require that the members be elected by the House.

# CPR Cayman Responds to Approval of Referendum Bill



With the Government Initiated Referendum (GIR) now confirmed for 30 April 2025, CPR Cayman remains committed to ensuring that voters have access to the critical data needed to make an informed decision. Every Caymanian deserves full transparency on this project's implications before casting their vote.

CPR Cayman believes that local cruise operators are essential contributors to our tourism economy and that their long-term success must be protected. However the push for mass cruise tourism at the proposed magnitude will not benefit local businesses, but large international cruise lines seeking to reshape Cayman's tourism landscape in ways that may not align with our island's long-term best interests. Instead of reactive expansion, we advocate for a strategic, measured approach that ensures a thriving cruise sector while safeguarding the unique advantages that make Cayman an exceptional destination.

## Seeking Transparency & Public Accountability

To date, the Government has provided no transparency regarding the proposed cruise berthing facility which it is asking the public to vote on. There has been no disclosure of a detailed plan, cost projections, location analysis, or environmental impact assessments — critical data that should be available before Caymanians are asked to make a decision of this magnitude.

CPR Cayman remains committed to engaging in meaningful dialogue on all aspects of this issue and continues to seek greater clarity on how a cruise berthing facility would impact our already strained quality of life in the Cayman Islands. Decisions that affect our islands' future must be based on complete and transparent data, not speculation.

## Lack of Referendum Regulations

In the Cayman Islands, there are no rules governing the financing of referendums.

The implication is that not only can government spend promoting a yes vote without restriction, big local and international companies with deep pockets with a vested interest in one outcome can finance massive campaigns to influence the voters without a fair and equal campaign for the other view.

While the Government Initiated Referendum is set to go ahead on 30 April, in the interest of safeguarding our democracy, we restate our call for the introduction of comprehensive referendum regulations.

The danger of referendum's proceeding in the absence of such regulations include:

- Distorted Democratic Process: Unlimited spending by wealthy entities can drown out grassroots voices and skew public discourse.
- Information Asymmetry: Voters may receive disproportionate exposure to one side of the argument, leading to uninformed decision-making.
- Foreign Interference: Without restrictions, external entities can significantly influence domestic policy decisions through financial backing of campaigns.
- Lack of Transparency: Without reporting requirements, voters cannot know who is funding the campaign messages, or their true motivations.
- Erosion of Merit Based Arguments and Unfair Competi-

# FSI to Host Seminar on New DAML Regime as Industry Adapts to Key Compliance Requirement

The Cayman Islands Financial Services Institute (FSI) is set to host a seminar later this month focusing on the new Defence Against Money Laundering (DAML) regime, a key compliance requirement under the Proceeds of Crime Act. The event, scheduled for Wednesday, 26th February 2025, at the Indigo Hotel, will provide financial services professionals with critical insights into how the regime will impact reporting obligations and risk management procedures.

The DAML regime represents a significant regulatory change for Cayman's financial sector. It establishes a process through which financial service providers, legal professionals, and other reporting entities must seek consent from the Financial Reporting Authority (FRA) before proceeding with transactions that may involve criminal property. Given the legal and operational implications, industry participants are expected to require a greater understanding of the framework to ensure compliance.

Robert J. Berry, Director of the FRA, will deliver a keynote address outlining the DAML's purpose, legal framework, and implications for financial institutions, legal professionals, and other reporting entities. His presentation will be followed by a presentation by Róisín Liddy-Murphy, Partner and Head of Regulatory & Risk Advisory at Conyers, who will examine

# RCIPS and Partners Conclude Successful “Week of Action” in George Town

including drug-related offences and immigration violations.

Five drug search warrants were conducted at addresses in the Windsor Park, Rock Hole and Washington Boulevard areas of George Town, and high visibility patrols were carried out in Rock Hole. Over the course of the week, a total of 21 arrests were made, including nine by RCIPS and 12 by CBC. RCIPS arrests included the following offences:

- 4 x Possession of Ganja and Suspicion of Consumption
- 1 x Possession of Ganja, Possession of Cocaine with Intent to Supply
- 1 x Possession of Ganja with Intent to Supply and Animal Cruelty, with 10 cock fighting chickens seized.

- 1 x Handling Stolen Goods and Suspicion of Burglary
- 1 x DUI
- 1 x Being in Charge of a Vehicle Whilst Intoxicated

CBC engaged and processed 87 individuals that lead to the arrest of 12 persons for overstaying. The most significant being a male who has been overstaying since 2020.

“The George Town Week of Action demonstrated the effectiveness of multi-agency collaboration, and will become a template to build on”, says Inspector Ian Yearwood. “It also demonstrated the importance of sustained stakeholder engagement to inform

Police appeal to those that dump rubbish to be considerate and play your part in keeping our neighborhoods clean and safe, by disposing of rubbish responsibly, through using the landfill facilities provided.

“The Week of Action and the cleanup day have produced some excellent results, and disruption of criminality”, says Assistant Commissioner of Police, Rob Atkin MBE. “The RCIPS will continue to work with our partners and community members to ensure that the minority of persons in our communities that engage in criminality and anti-social behavior across our islands are targeted, as we work with our partners to ensure the Cayman Islands remains one of the safest places to live, work and visit”.

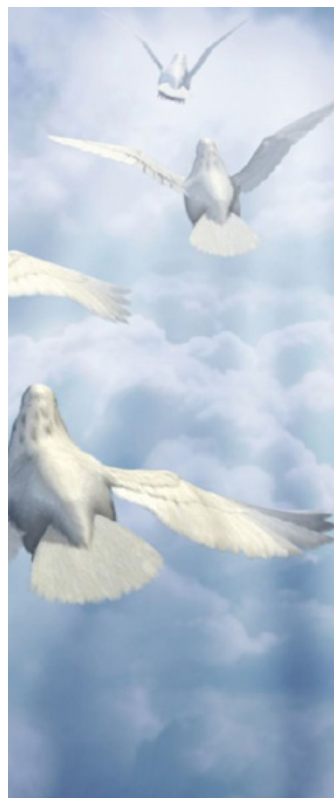
