PHILLIP EBANKS RUNS INDEPENDENTLY FOR RED BAY


Attorney and former police superintendent Phillip Ebanks has thrown his hat in the ring as an independent candidate for the Red Bay seat in the April 30th election.

In an appearance on the Caymanian Times podcast Cayman Conversations with Ralph Lewis, Mr Ebanks said even though he chose to run as an independent candidate, he is nonetheless prepared to work within a team as a parliamentarian or minister.

"It seemed to me that the most straightforward way for me to present myself to the country was as an independent. I present myself an independent on the basis that it seems fairly clear to me, given that we don't have this well-entrenched form of party system in the country, that it looks like we're going to be heading towards another coalition government."

Mr Ebanks who has a combined 40 years experience as a practising attorney and in law enforcement, said he brings a

practical solutions-oriented perspective to politics both at the district and national levels.

He cites Cayman's residency and citizenship system as being in need of urgent overhaul alongside immigration and employment policies.

"We still have the issue of feeling that Caymanians do not get the best opportunities to enter the workforce, but more importantly, to progress within the workforce, to get the better jobs and the opportunity to thrive," he stated. Saying

there's a need to rebalance this situation, Mr Ebanks proposes that the current method where jobs

are advertised only two weeks before a work permit expires be reviewed.

He strongly advocates for a six-month window in order to give Caymanians a better shot at those jobs rather than resort to overseas recruiting as a norm. "There is scope for us to ensure that there's an avenue available to Caymanians to progress. And I think the way to handle that is through the work permit system, to make sure that when permits are issued and they're coming up to renewal, there is a way and an avenue for advertisement...not two weeks in advance, but six months in advance.

Mr Ebanks is worried that under the current system, "careers are being stifled".

He is also campaigning to overhaul inconsistencies in the residency and citizenship system. The Red Bay independent candidate feels however that this issue must be handled with due care and attention.

"We must have real immigration reform and real changing and solidification of policy that allows us to achieve that end. It is a big subject, and it has a variety of elements to it, including, how long people should wait for permanent residency, how many statuses we should be giving out and that type of thing. And I think we really need to have an open conversation about that and find a way forward to do that. And I think the best way to do that is to handle that calmly, competently, once we have a new government in place. It's not the issue that you're going to resolve in four weeks before an election."

Another big concern for Mr Ebanks has is that of access to housing for Caymanians, and he has some ideas how to resolve the shortage.

"We have a major issue there with that. Not enough people are able to get housing. And we need to think bigger in terms of how we're producing housing in the country. There are many good ideas out there...For example, one of the ideas, I think is worth pursuing is to make sure that we try to enter more public-private partnerships in producing houses in the volume that the population can get access to housing."

Phillip Ebanks, the independent candidate for Red Bay is vying for the seat last held by retiring Speaker and former premier Alden McLaughlin.





COUNTDOWN TO VOTING DAY: THE RACE FOR PARLIAMENT IS ON

Cayman's election campaign season in a sense officially kicked off on Nomination Day Monday March 3rd with 59 candidates registered for the April 30th general election.

Three parties and 24 independents will challenge for the 19 seats in the Parliament, seeking to form or be a part of a majority of at least twelve to form the next government.

There are 35 candidates across the three established parties, almost making it the first time so many constituted political parties are contesting the polls - a significant departure from political traditions in Cayman.

This raises the question of whether the long-held resistance to the party system in Cayman politics is now fading.

The People's Progressive Movement (PPM/Progressives) led by Joey Hew is fielding 13 candidates, The Caymanian Community Party(TCCP) helmed by Andre Ebanks - 10, and the Cayman Islands National Party(CINP) of Dan Scott - 12.

West Bay North, Red Bay, East End and Cayman Brac East have the most candidates with five candidates each running in those districts.

An interesting battle is shaping for the Cayman Brac East seat held by current United People's Movement(UPM) Premier Juliana O'Connor-Connolly who is running as a PPM candidate at the same time.

Her last-minute confirmation as a candidate for the Progressives sent shockwaves throughout the political establishment.

While this raises some questions about constitutionality, the political practicalities are that her UPM government label, though not a formal political party, is effectively rendered obsolete.

However, some questions remain in the governing period up to the formation of the next government over whether this means the PPM and UPM are in a de facto coalition until then as two other UPM ministers - Kenneth Bryan and Dwayne Seymour - are also on the PPM slate.

The Cayman Brac East seat is also in the crosshairs of Dan Scott, the leader of the new Cayman Islands National Party(CINP). The other three candidates in that district are independents; Ruth Ann Bodden, James Albert Christian, and Maxine Avon McCov-Moore.

In Cayman Brac West and Little Cayman, the retirement from politics of PPM's Moses Kirkconnell means that either Nickolas DaCosta (CNIP) or independent Lonny Lee Tibbetts will emerge as MP. The PPM is not fielding a candidate.

For West Bay North four of the five candidates are independents competing for the seat vacated by independent (and ex-PACT and UPM Cabinet member) Bernie Bush who is out of the race. Independents Jermaine Ebanks-Hurlston, Shakeina S Bush, Rolston "Rollie" Anglin, and Michael Lemay, along with CINP's Jordon D Rivers are vying to be the district's MP.

Red Bay, the seat held by former PPM Premier and current Speaker of Parliament Sir Alden McLaughlin will also have a new representative in Parliament after Sir Alden announced his retirement from competitive politics. The party hopes to retain that seat with PPM party stalwart Roy Tatum facing off against Melrose Whitelocke (TCCP) and independents Dawn Thomas, Leon Gould, and Phillip Ebanks.

With PPM's Barbara Conolly also quitting politics, the George Town South seat is also wide open. The candidates there are independent Alric Lindsay, Gary "Peanut" Rutty, and, Craig "Festa" Frederick.

Another PPM incumbent departure this one in George Town West will also result

in a new MP for that district. With David Wight quitting politics that seat is now up for grabs between his PPM replacement Pearlina L. McGaw-Lumsden, Craig T Merren of the CINP, and independents Hunter J. Walton and Tyree Malcolm Hernandez.

With campaigning now hitting high gear spending limits are imposed to a maximum of CI\$40,000 per candidate (as opposed to a political party).

"The maximum amount of election expenses to be incurred in respect of a candidate at an election shall be forty thousand dollars" as specified in the Elections Act 2022 (S. 67),

When factored across the three parties with their combined 35 candidates and the 24 independents, even if the individual ceiling of CI\$40,000 is not reached in all cases, the trickle-through effect in the economy is still expected to be considerable.





Visitor numbers on the up

Cayman saw 41,418 stayover visitors in January 2025, an increase of 7.7% year over year and the second-best January in recorded history. This was setting the destination on pace for a strong 2025, government said.

Tourism Minister Kenneth Bryan attributed January's record numbers to the resilience of the Cayman Islands tourism industry and he said they looked forward to seeing an increase in visitation throughout 2025.

The United States continued to show steady growth with visitor numbers increasing by 8.8% compared to January 2024. Visitors from the Northeast, Midwest and South of the United States recorded growth in visitation. This was as a result of seat capacity increases in the key markets of Miami via American Airlines, Boston via JetBlue and Chicago via United Airlines and new service in Orlando via Southwest and Minneapolis/St. Paul via Delta Air Lines.

The DOT said the seat capacity in-



crease and new services from the United States came about because of a dedicated aviation strategy including a Q4 2024 investment in geotargeted advertising campaigns with airline partners to drive visitation from key US gateways.

Canada remained a key market for visitation showing "robust growth" with its visitor numbers increasing by 10.3% compared to January 2024, representing more than 10% of the total stayover arrivals for January 2025.

However, in the UK & Ireland, January arrivals declined by 7.7% and the number of visitors from Europe were 6.6% lower than the same period in 2024. Latin America represented marginal growth at 1.2%

Director of Tourism Rosa Harris stated: "This achievement is a testament to our strategic and steady approach to rebuilding visitor confidence and demand through our marketing and business development efforts."

Public Health Urges Measles Awareness and Vaccination Amid U.S. Outbreak

The Public Health Department is urging the public to remain vigilant following a recent measles outbreak in several U.S. states, including Texas, New York and North Carolina. Given the increased risk of measles exposure due to travel and community interactions, Public Health is emphasising the importance of measles awareness and vaccination for all eligible individuals.

"The measles virus is highly contagious and can lead to severe complications," said Dr. Samuel Williams-Rodriguez, Medical Officer of Health. "Vaccination remains the most effective way to prevent infection and reduce the risk of outbreaks within our community."

Measles is a serious disease that spreads through respiratory droplets and can lead to severe health issues, including pneumonia, encephalitis, and even death. Symptoms that are highly likely to be present in cases of measles are:

Rash that follows onset of fever

• Cough, acute respiratory infection or conjunctivitis (Pink Eye)

Sore throat

The MMR (measles, mumps and rubella) vaccine is a safe and highly effective way to

prevent measles and its complications.

Public Health also confirms that the Cayman Islands Molecular Biology Laboratory at the Health Services Authority has the ability to test for measles in individuals who present symptoms or have been exposed to a suspected case. Dr Williams-Rodriguez added, "Our surveillance

and laboratory testing capabilities allow us to identify and respond to potential measles cases promptly. Testing for measles is available free of cost across the Cayman Islands. We encourage anyone who develops symptoms such as fever, cough, runny nose, and a rash to seek medical attention immediately. While these symptoms are also common during flu season, they may indicate other illnesses requiring specific medical evaluation and care."

Parents and guardians are reminded that children who are unwell should not be taken to school, group activities or playdates. School and other activities can resume once the child is feeling better and has been fever free for a period of 24 hours.

While the entire population is urged to be aware, early education and school-age children (ages 1-17) and young adults (ages 18-23) are a priority group due to their high interaction in group settings, increasing the risk of transmission. "Our aim is to protect our children at home and abroad," explains Chief Medical Officer, Dr. Nick Gent. "That means ensuring that Caymanians and Cayman residents who are studying in the United States are also included in our awareness and immunisation efforts."


Public Health is reminding parents and guardians to check their children's immunisation records and ensure they are up to date with the MMR vaccine. MMR vaccine is usually given to children at 15 & 18 months old.

To facilitate immunisation efforts, the Public Health Department will host special MMR vaccination clinics on Saturday, 1 March, and Saturday, 8 March, at the Public Health Clinic, (2nd Floor) Smith Road Medical Centre, from 9:00 AM to 1:00 PM. These clinics will be open to individuals who need to update their vaccinations, with a focus on ensuring school-age children are adequately protected.


Parents and guardians are advised to bring their children's immunisation records to the clinic for review. If a child is found to be missing a dose of the MMR vaccine, it will be administered on-site at no cost to patients. no matter their insurance provider.


